



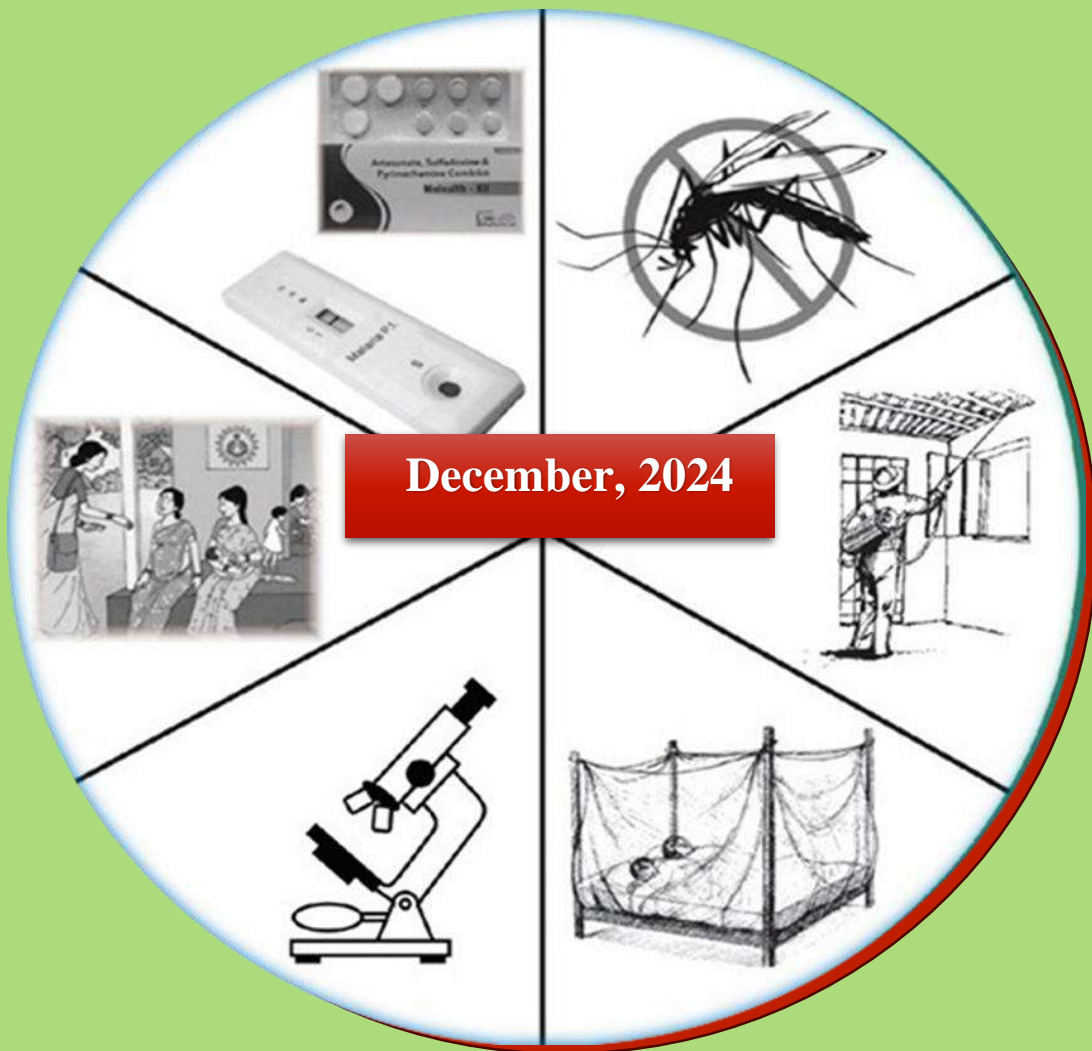

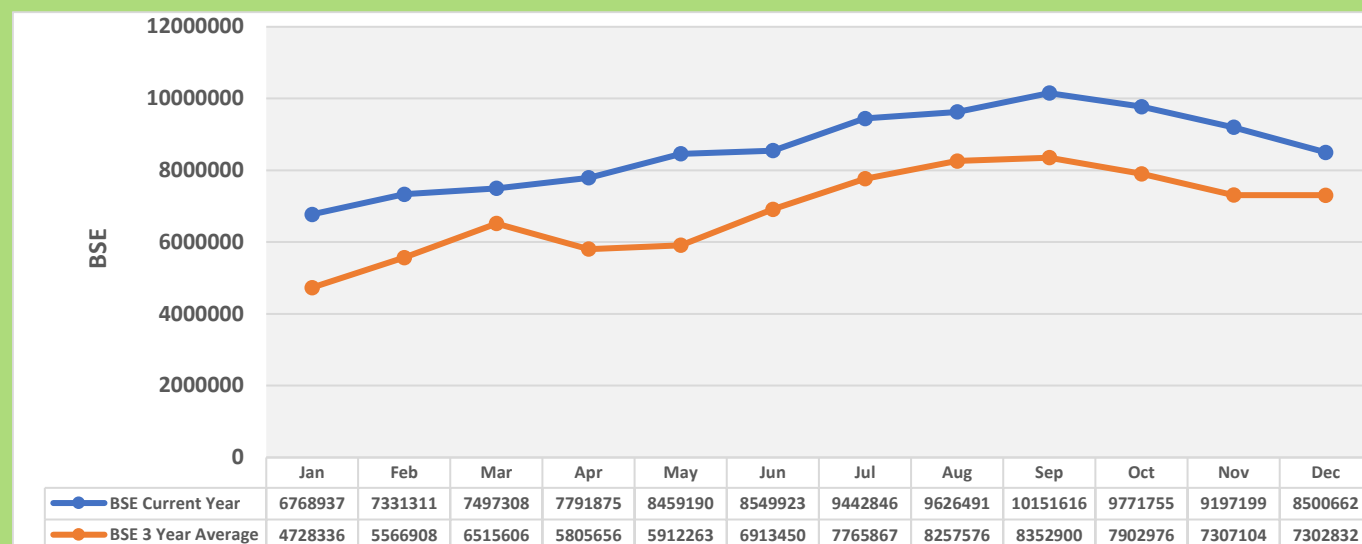

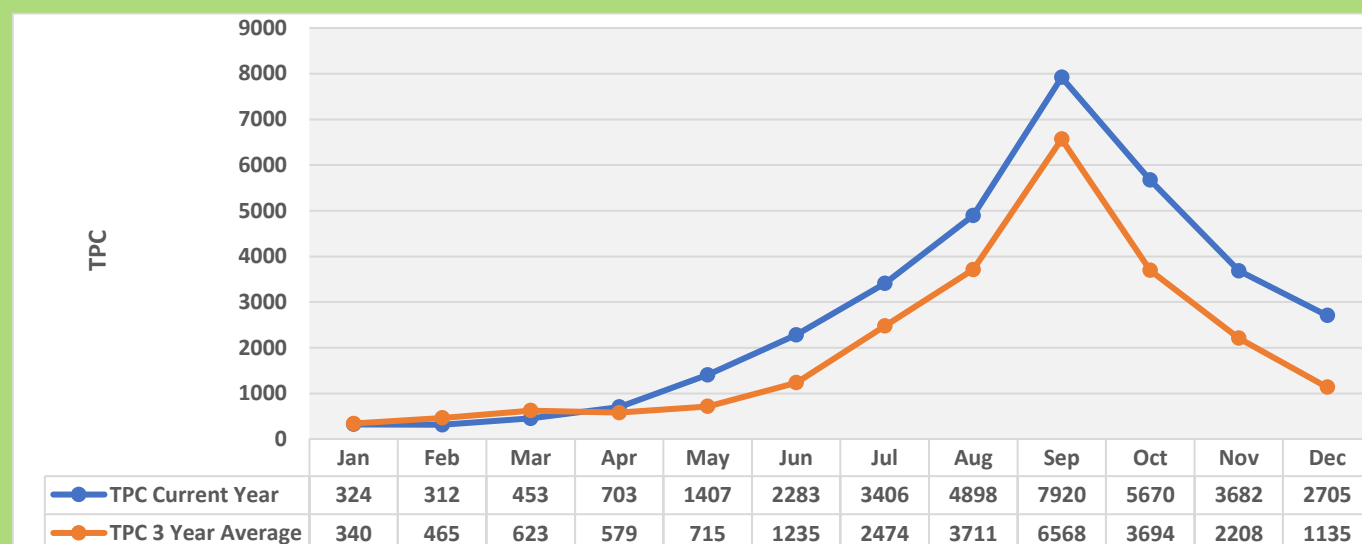
\*BSE (Blood Slide Examination), TPC (Total Positive Cases), PF (Plasmodium falciparum) and TPR (Total Positivity Rate).

**GRAPH 1: MONTH WISE TREND OF BSE IN CATEGORY I STATES/UTs**



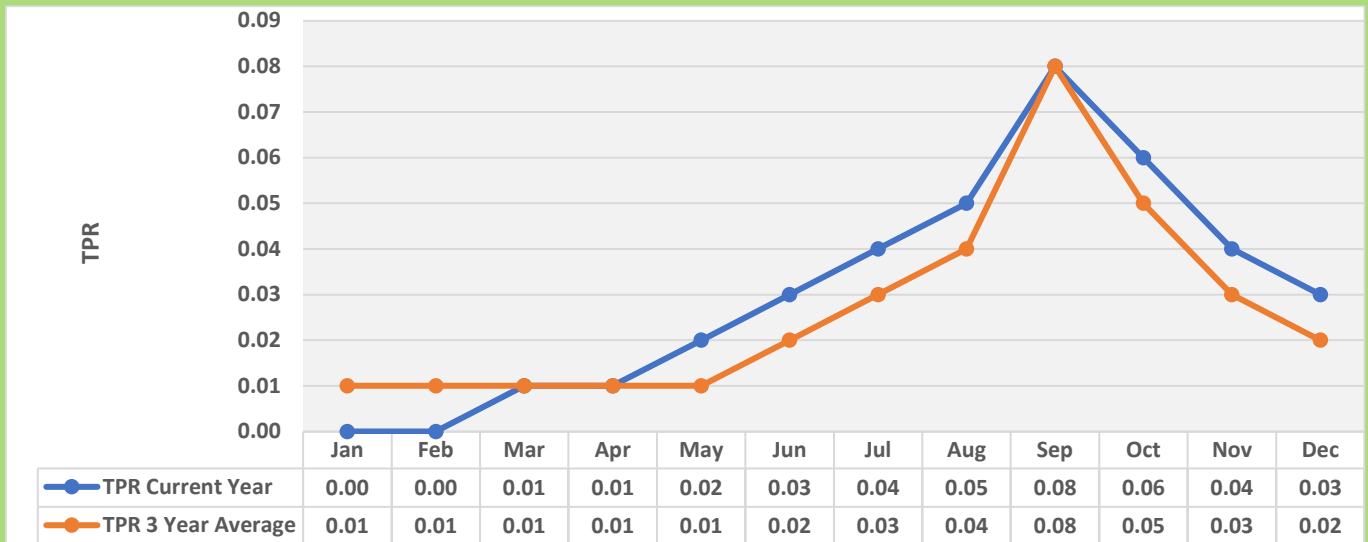

**GRAPH 2: MONTH WISE TREND OF TPC IN CATEGORY I STATES/UTs**



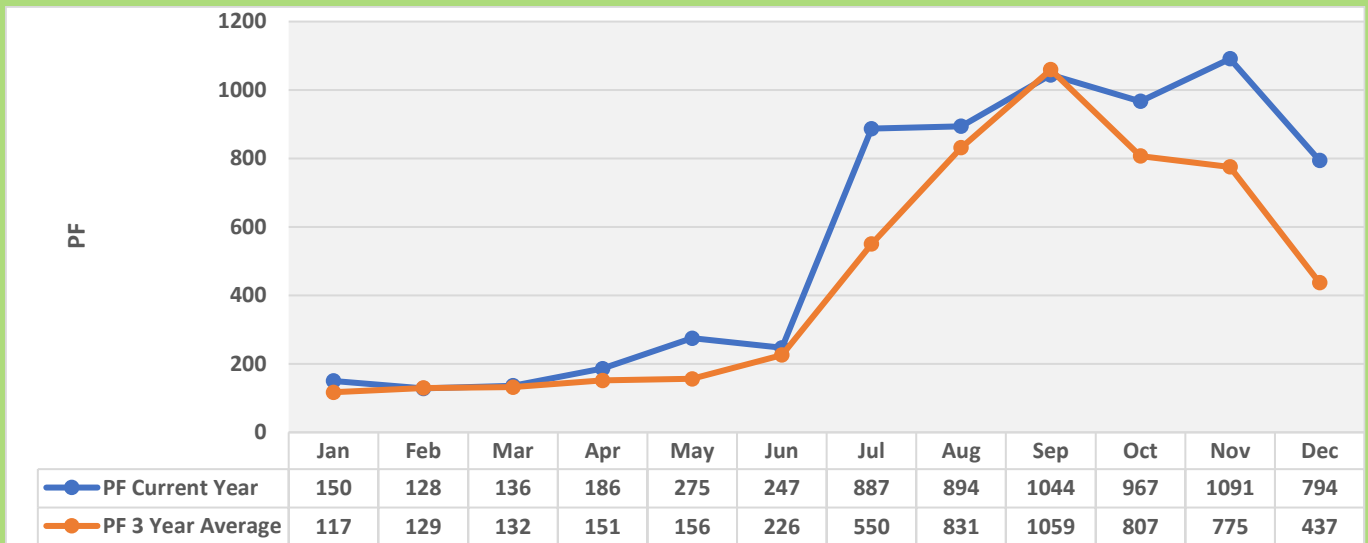

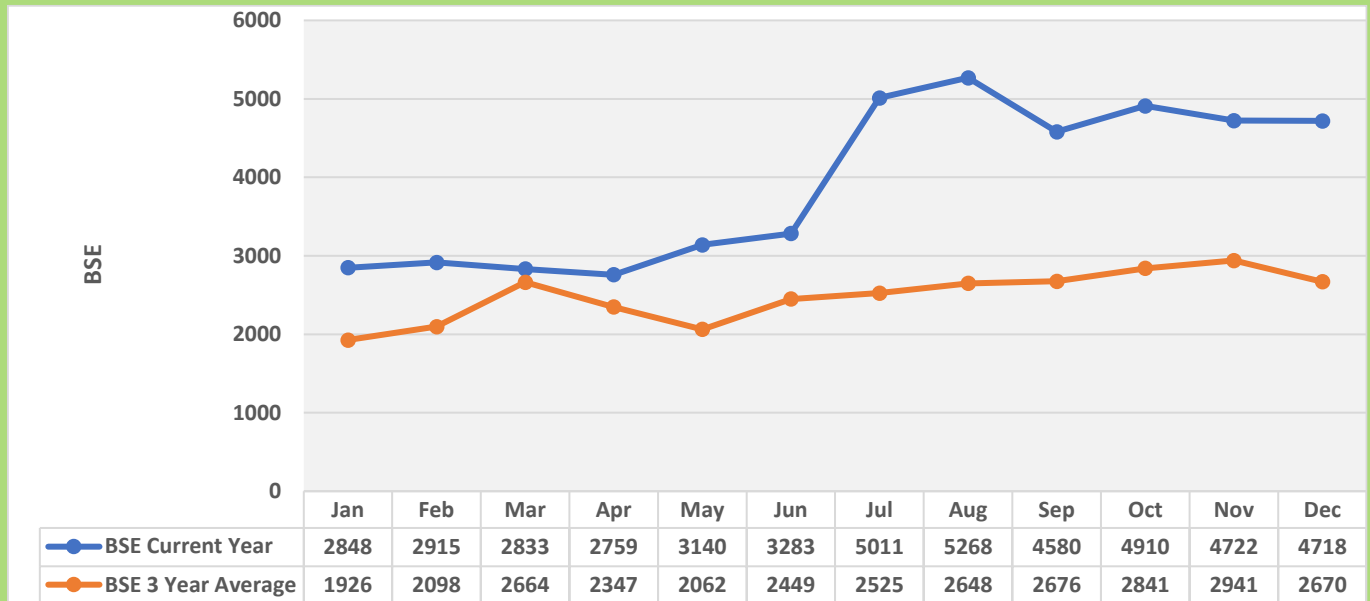

**Action points for all Category I States/UTs:**

- States/UTs need to perform data analysis at sub district level to identify hotspots and implement focal strategies.
- States/UTs need to focus on surveillance of migratory workers.
- States /UTs need to conduct private sector mapping and ensure 100% reporting.
- States/UTs need to conduct regular meetings of district and state task force for Malaria Elimination.
- States/UTs need preparedness and response of outbreak.
  
- States/UTs need to ensure that all malaria cases are investigated by the competent authority.
- Vector control measures by identifying potential vector breeding sites, environmental management, biological control and focus based adult vector intervention.

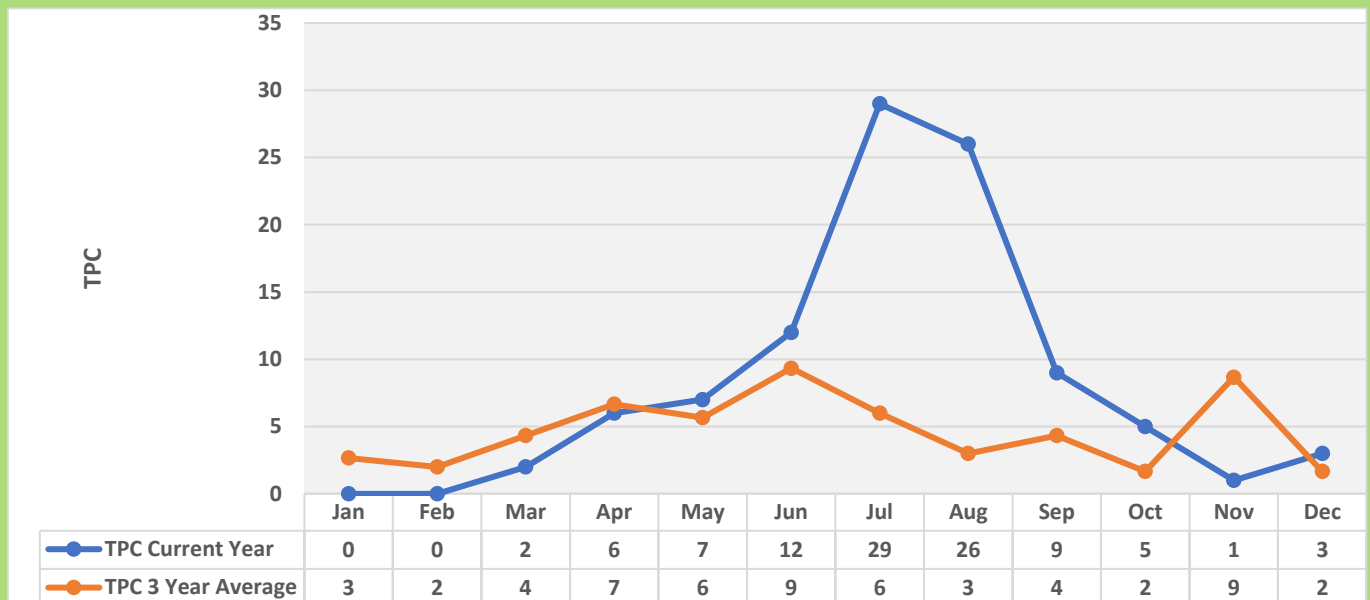

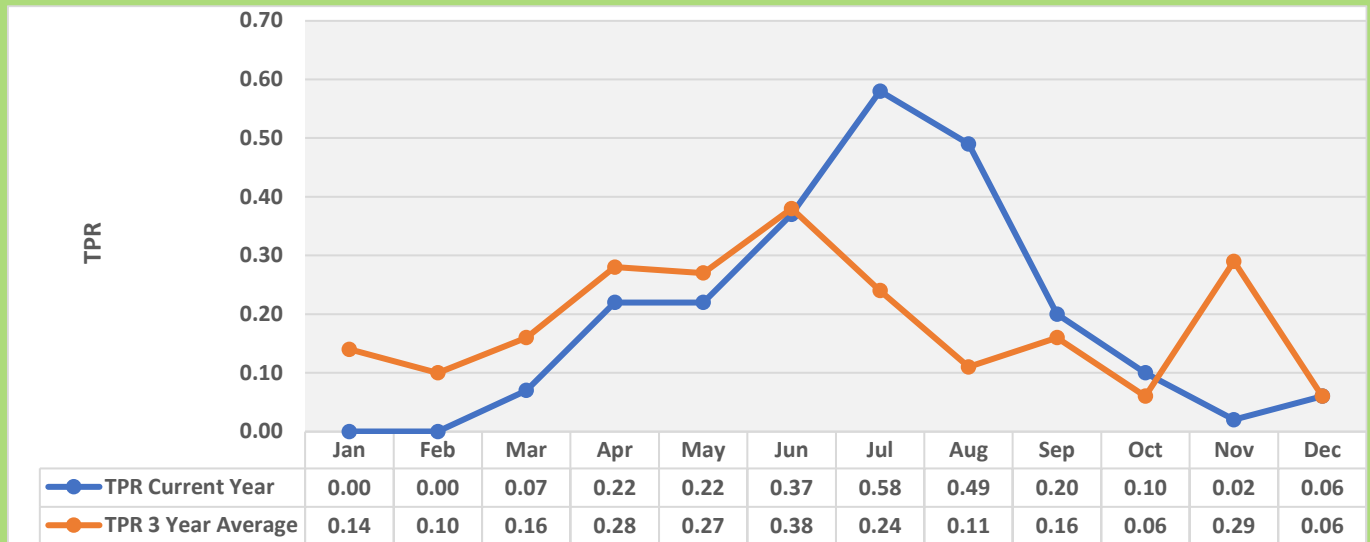
**GRAPH 2: MONTH WISE TREND OF TPC IN ANDAMAN AND NICOBAR ISLANDS**

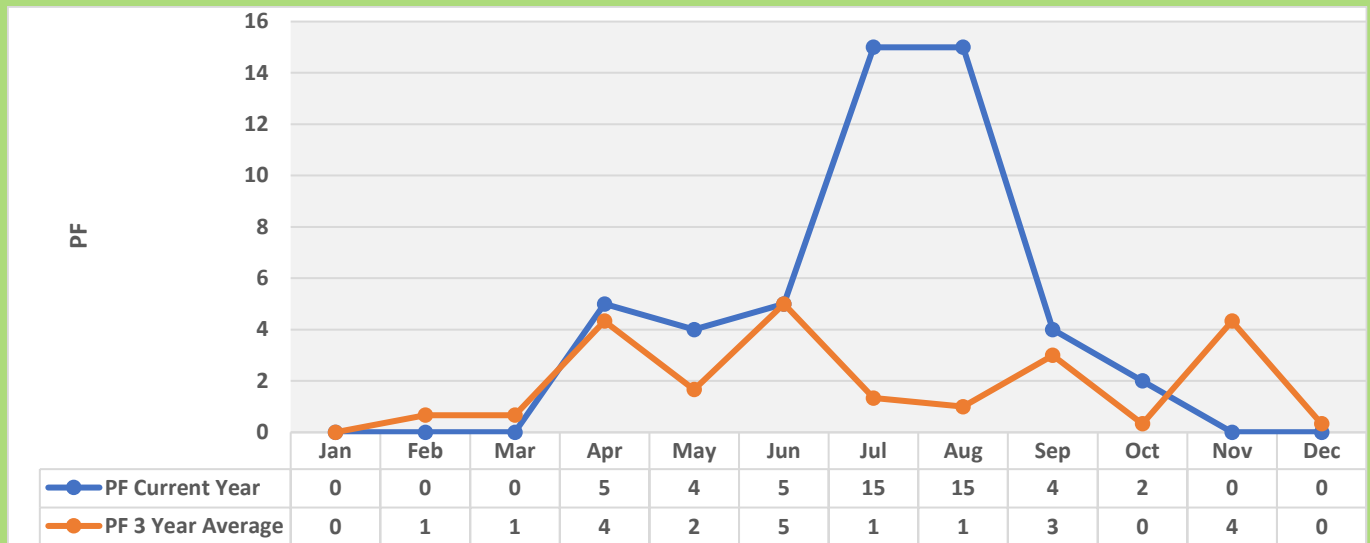


**GRAPH 3: MONTH WISE TREND OF TPR IN ANDAMAN AND NICOBAR ISLANDS**

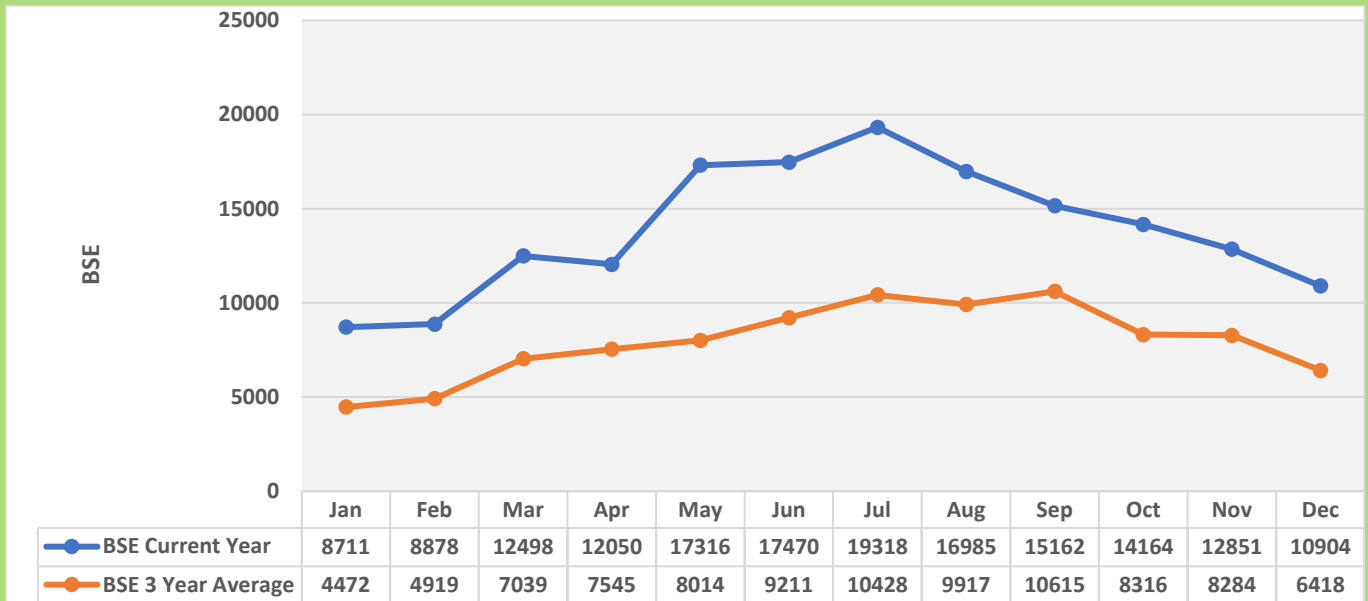
**GRAPH 4: MONTH WISE TREND OF PF IN ANDAMAN AND NICOBAR ISLANDS**

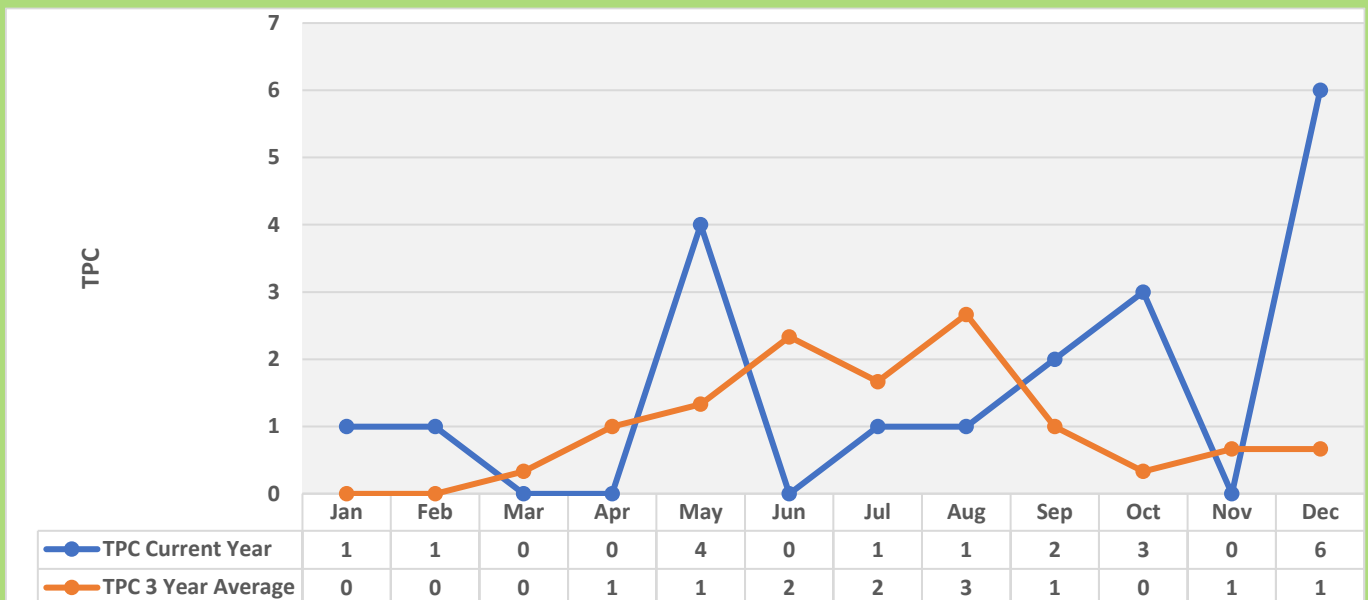

**GRAPH 1: MONTH WISE TREND OF BSE IN ARUNACHAL PRADESH**



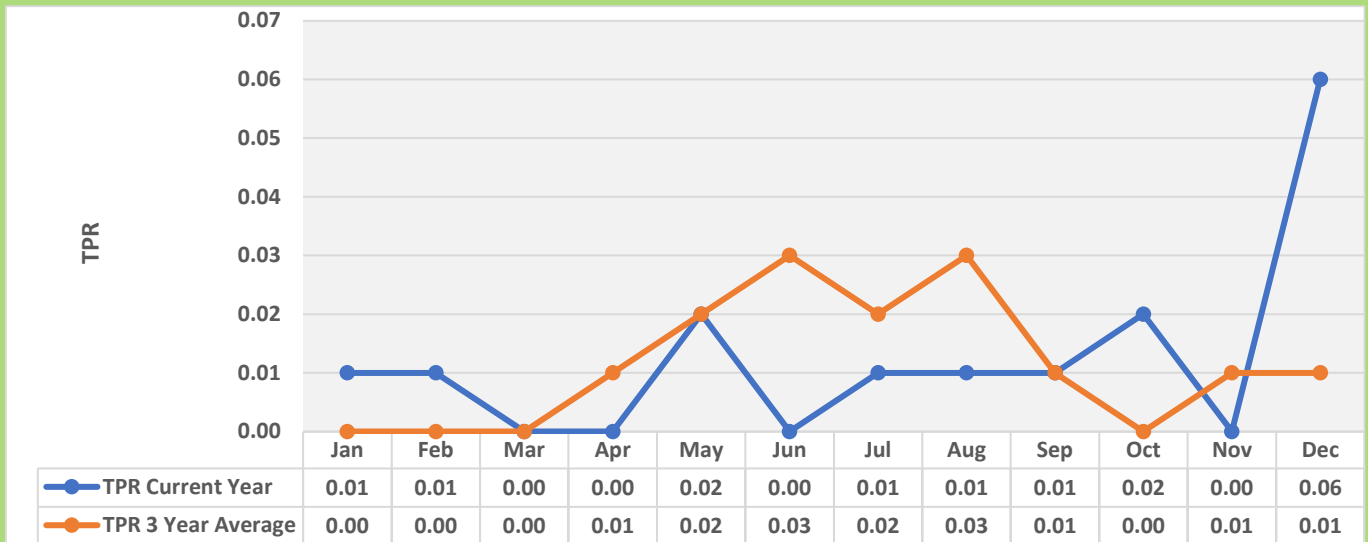

**GRAPH 2: MONTH WISE TREND OF TPC IN ARUNACHAL PRADESH**



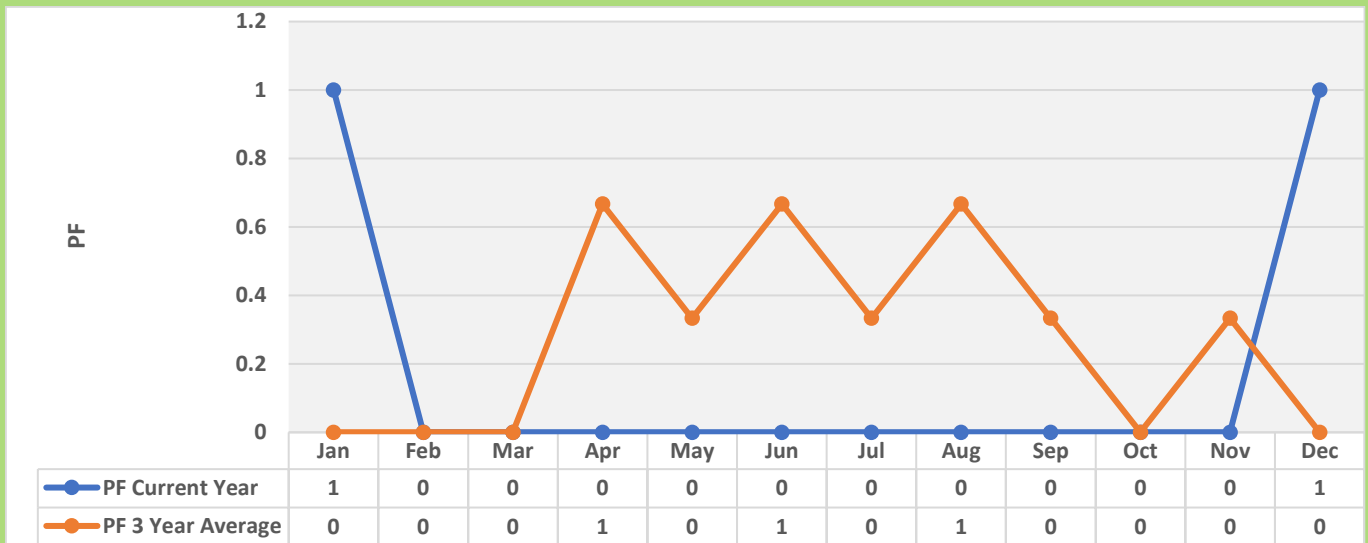

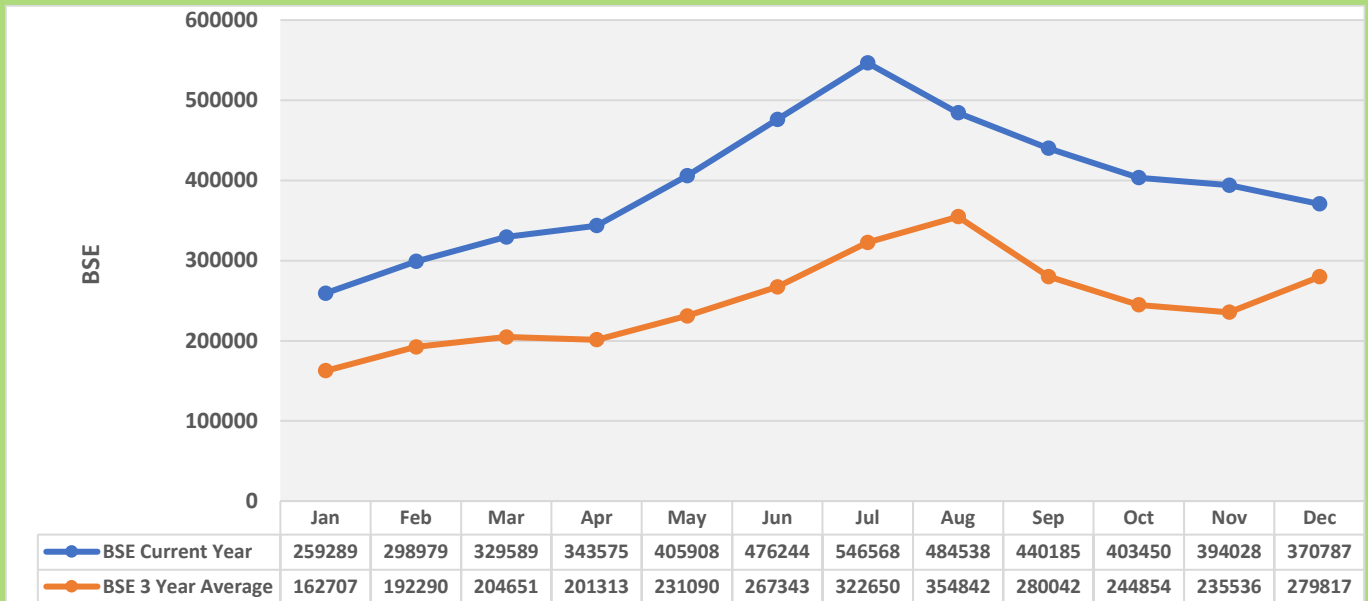
**GRAPH 4: MONTH WISE TREND OF PF IN ARUNACHAL PRADESH**

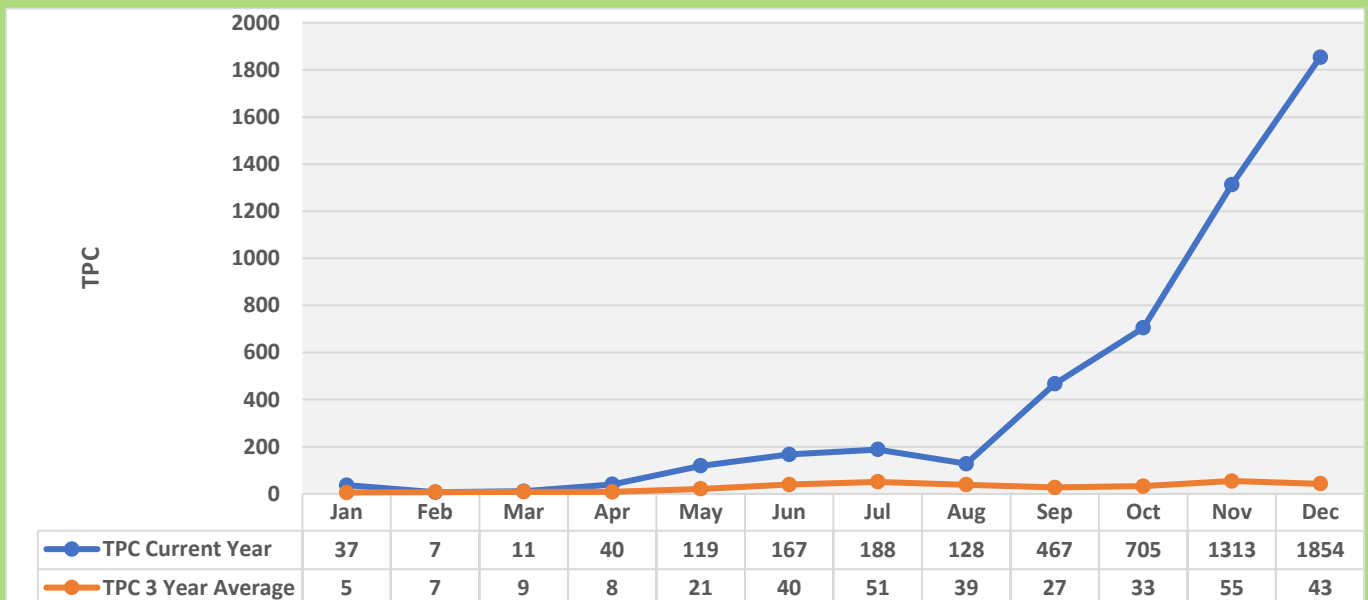

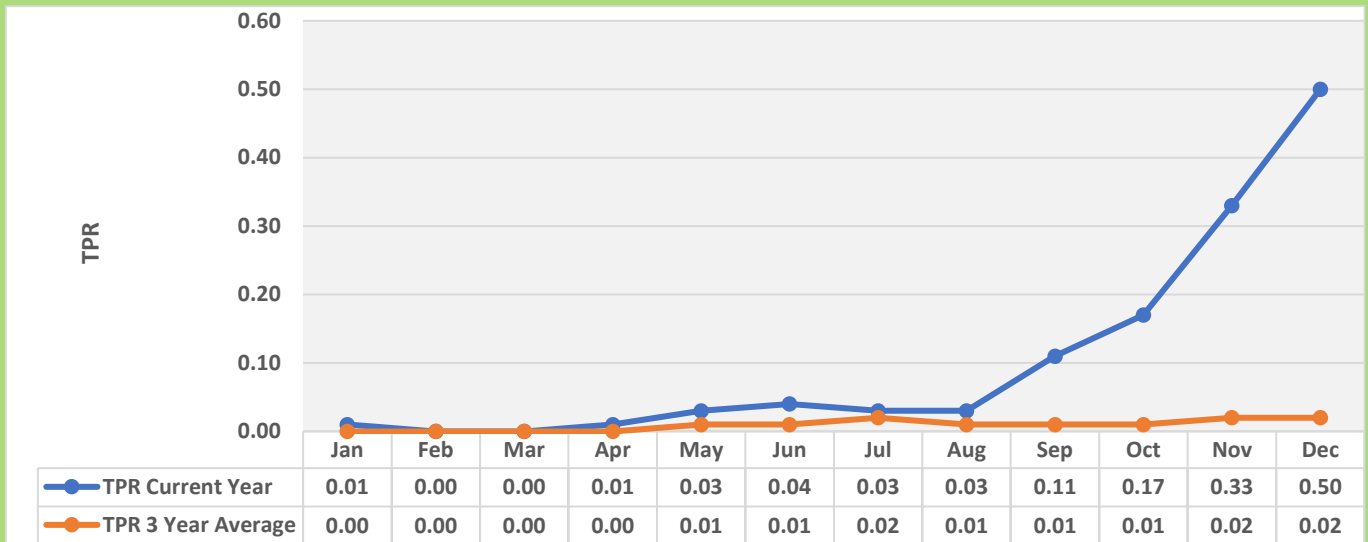

**GRAPH 2: MONTH WISE TREND OF TPC IN ASSAM**



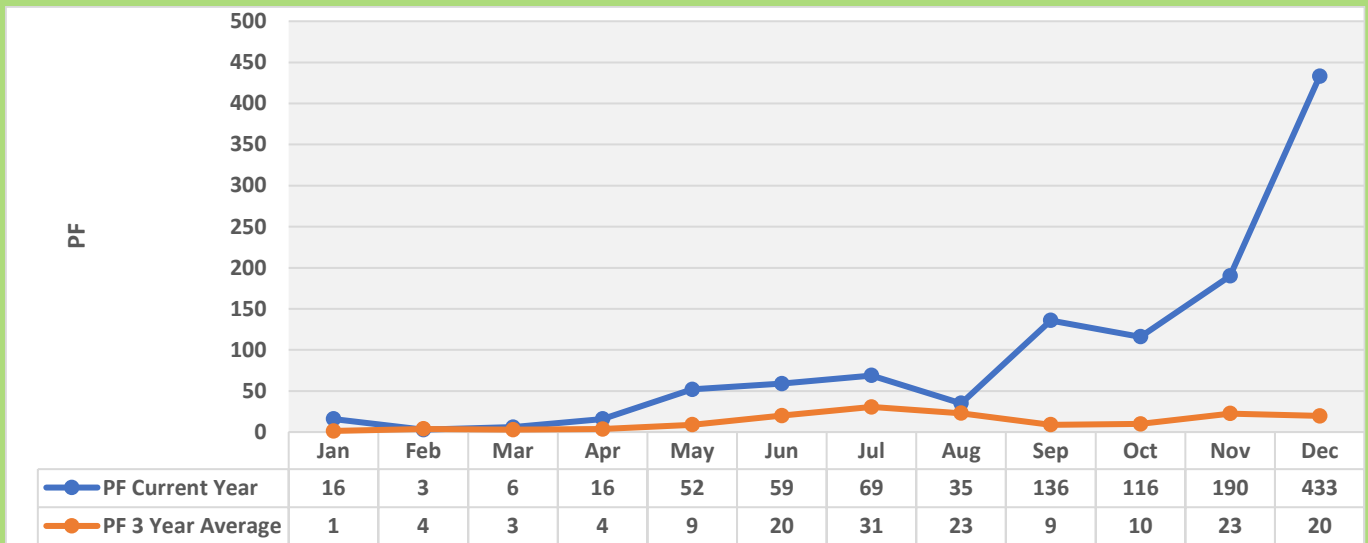

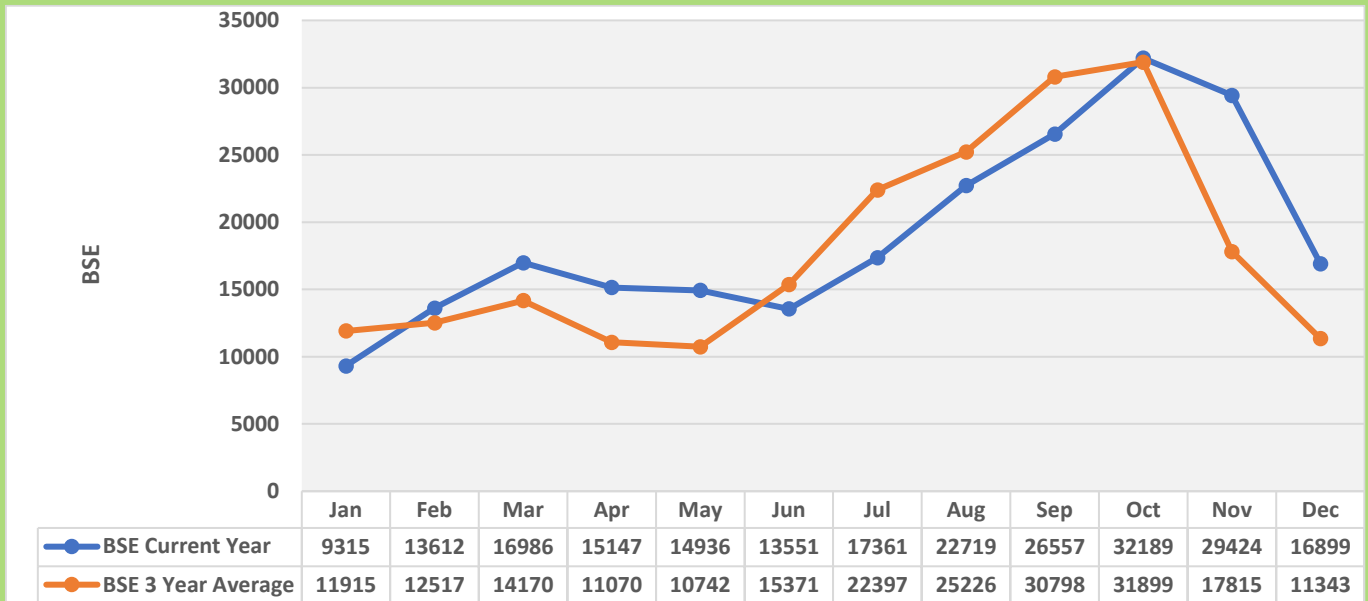
**GRAPH 4: MONTH WISE TREND OF PF IN ASSAM**

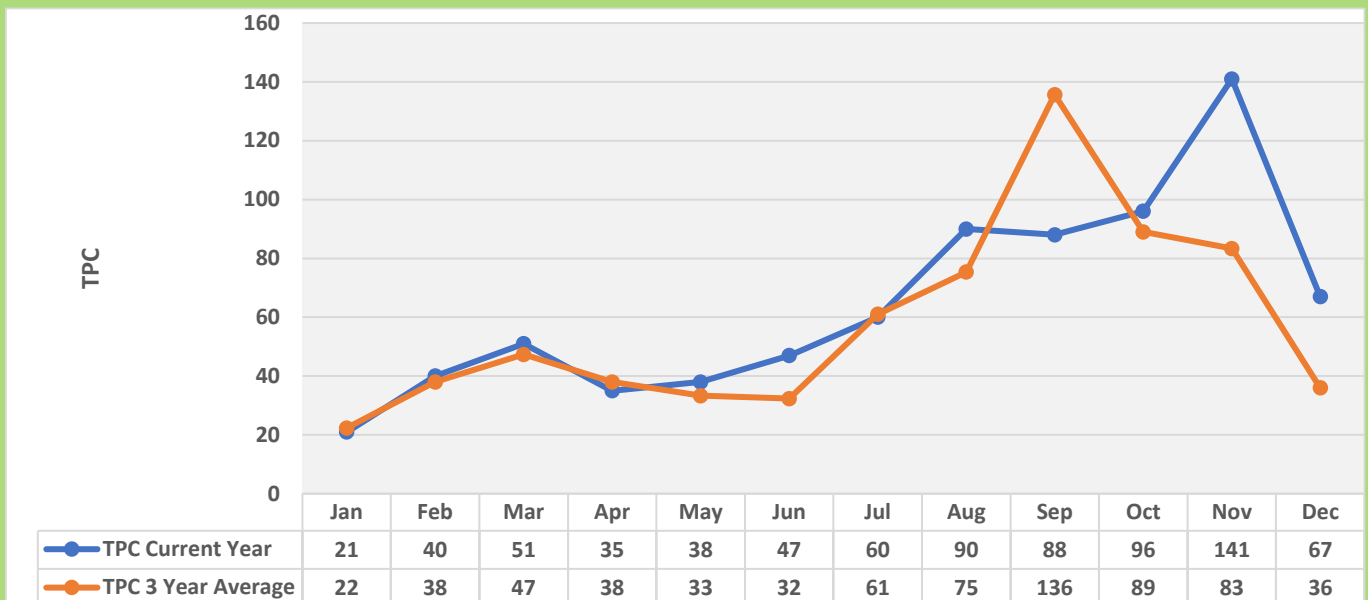

**GRAPH 1: MONTH WISE TREND OF BSE IN BIHAR**



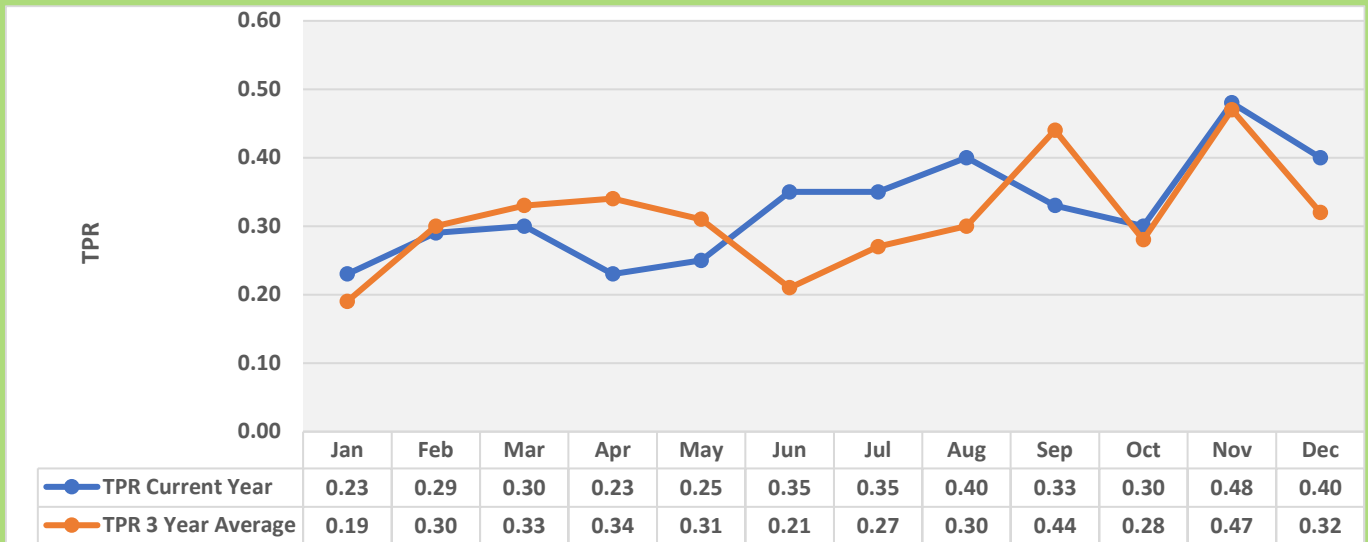

**GRAPH 2: MONTH WISE TREND OF TPC IN BIHAR**



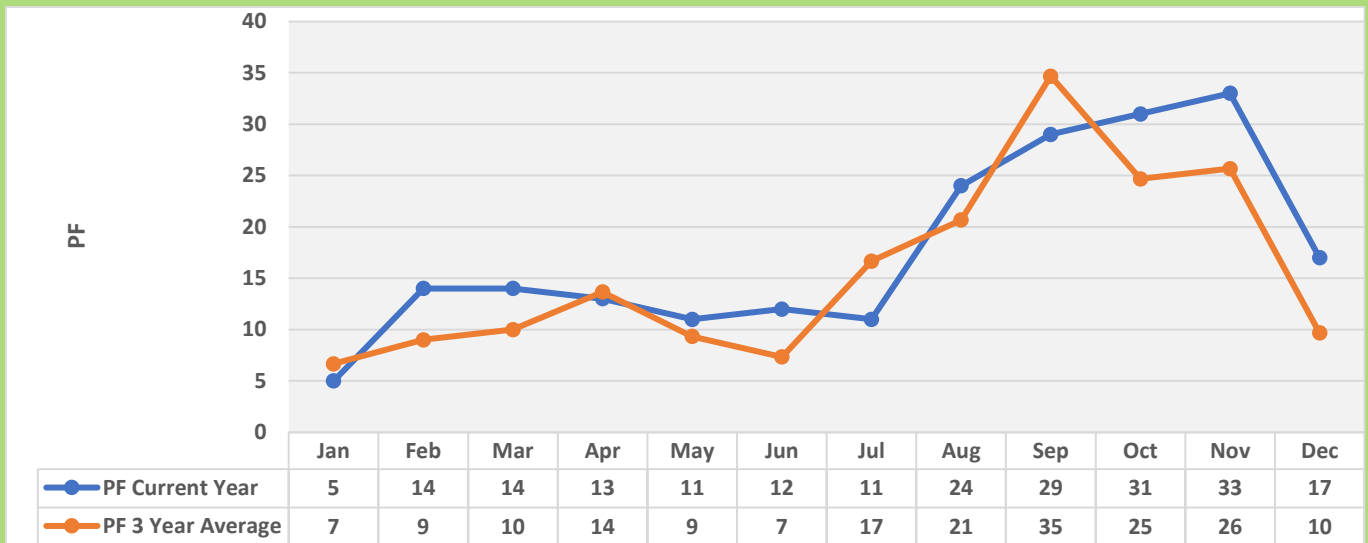

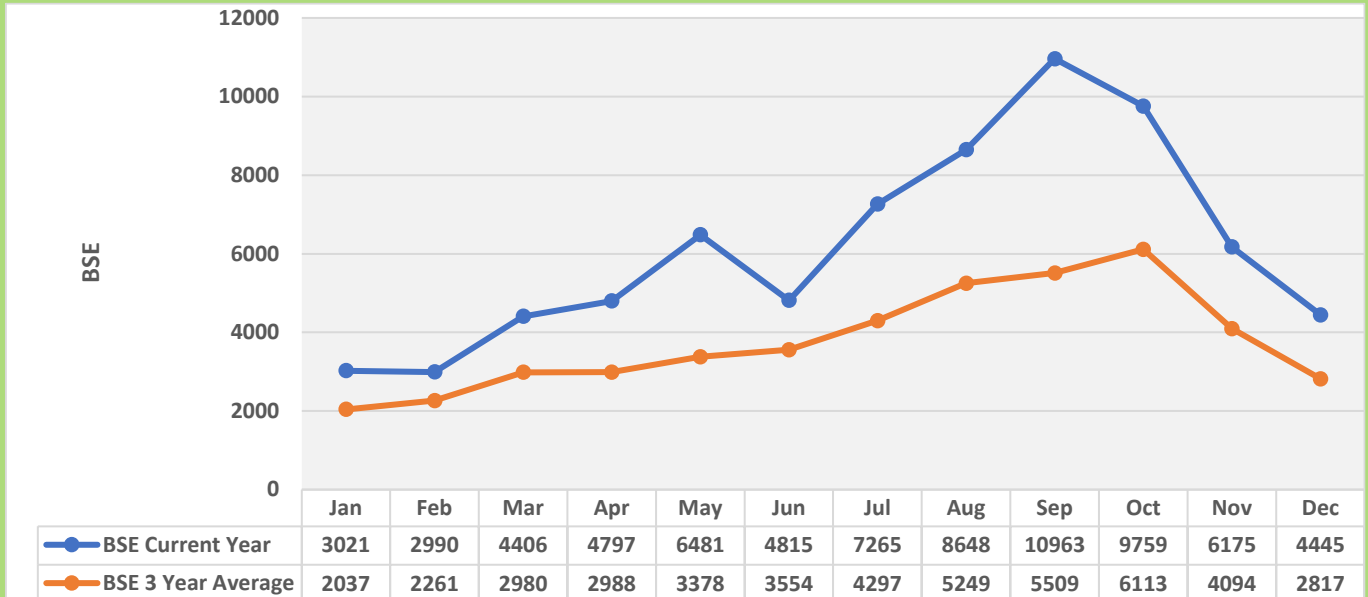

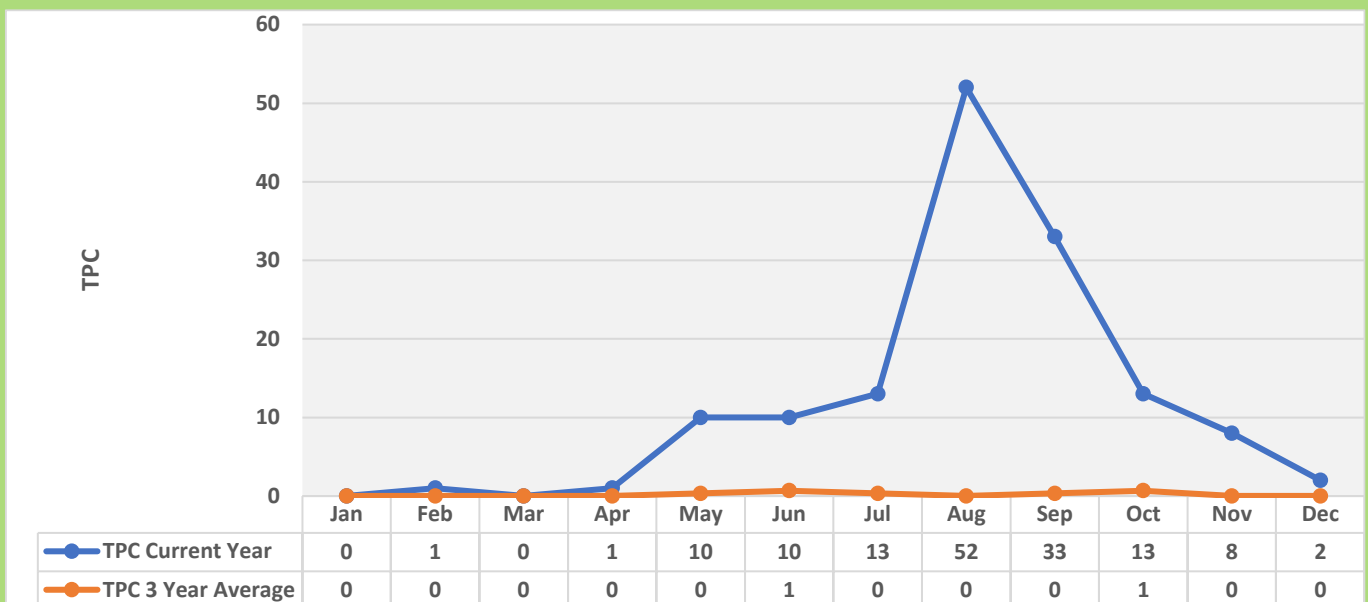

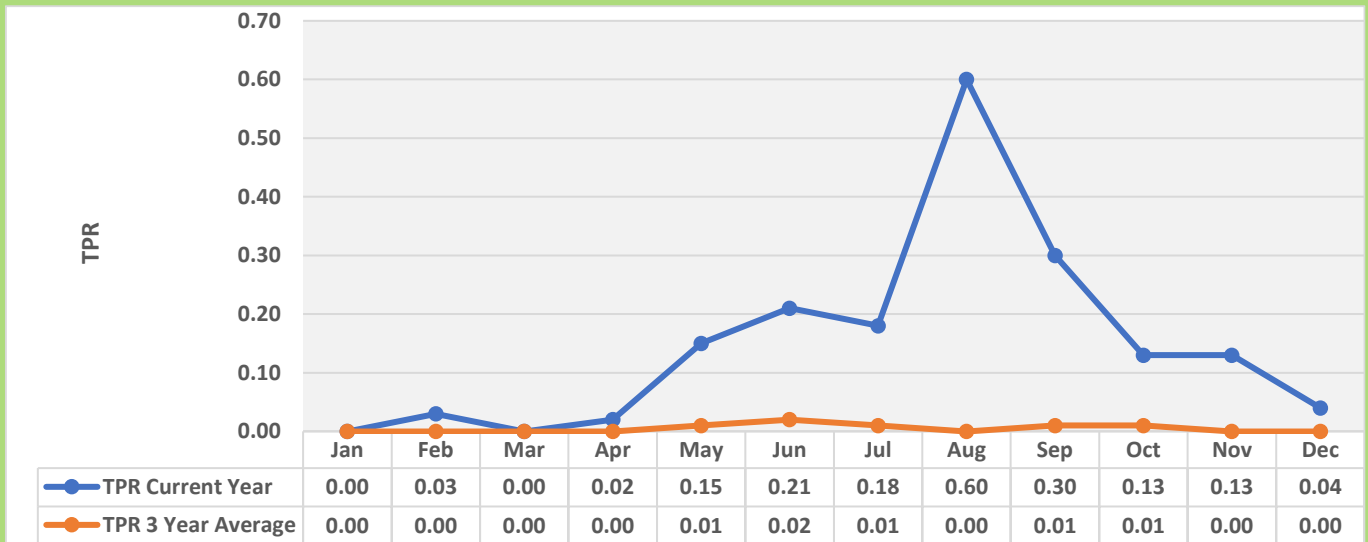
**GRAPH 2: MONTH WISE TREND OF TPC IN CHANDIGARH**

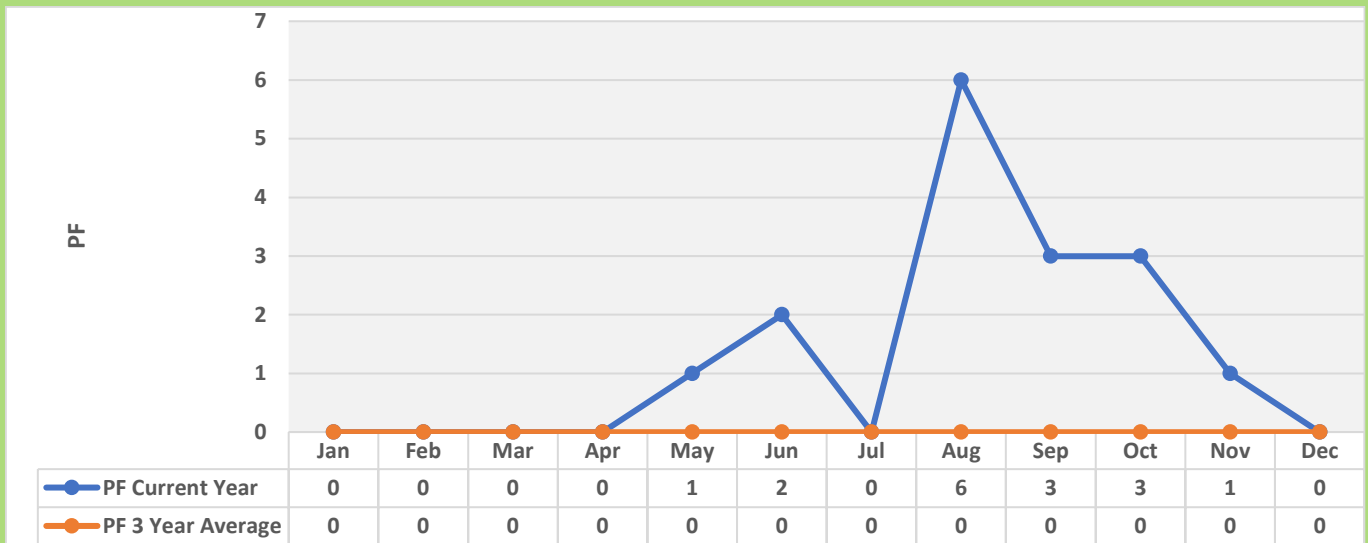


**GRAPH 3: MONTH WISE TREND OF TPR IN CHANDIGARH**

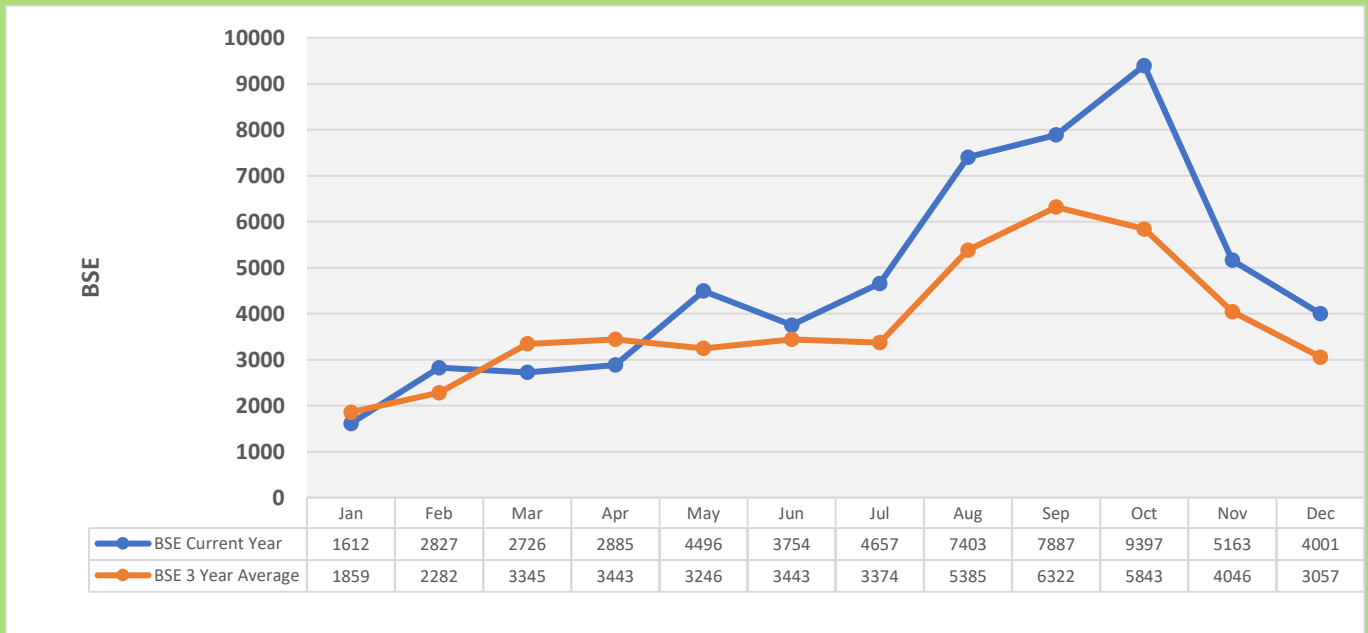
**GRAPH 4: MONTH WISE TREND OF PF IN CHANDIGARH**

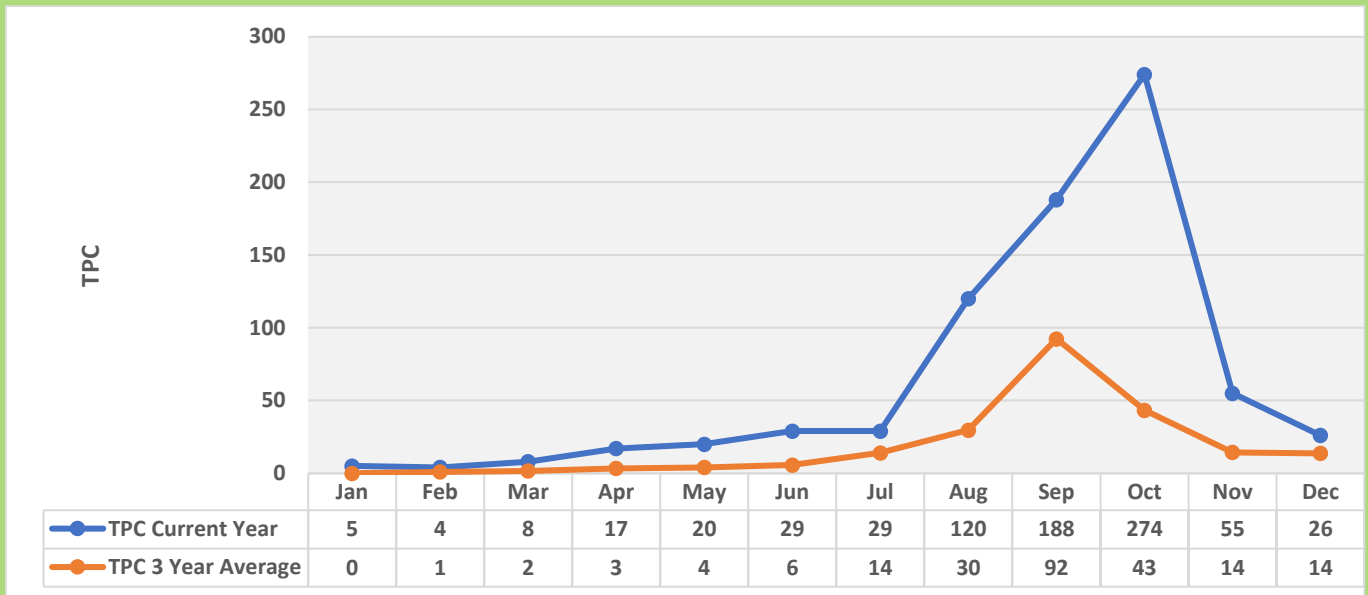

**GRAPH 1: MONTH WISE TREND OF BSE IN DELHI**



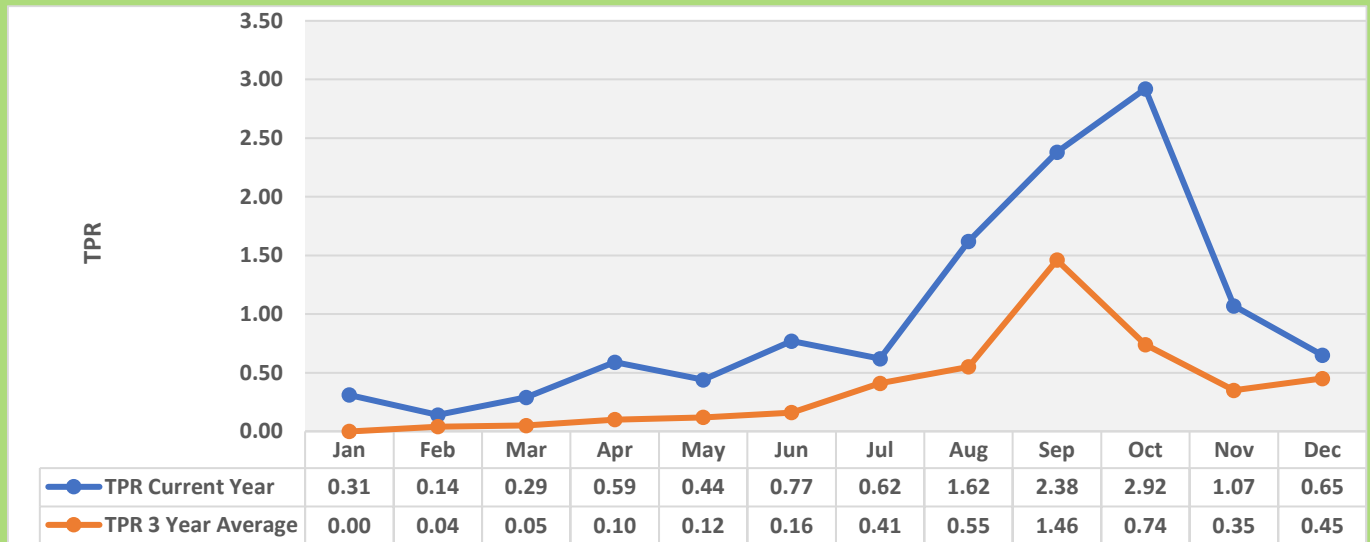

**GRAPH 2: MONTH WISE TREND OF TPC IN DELHI**



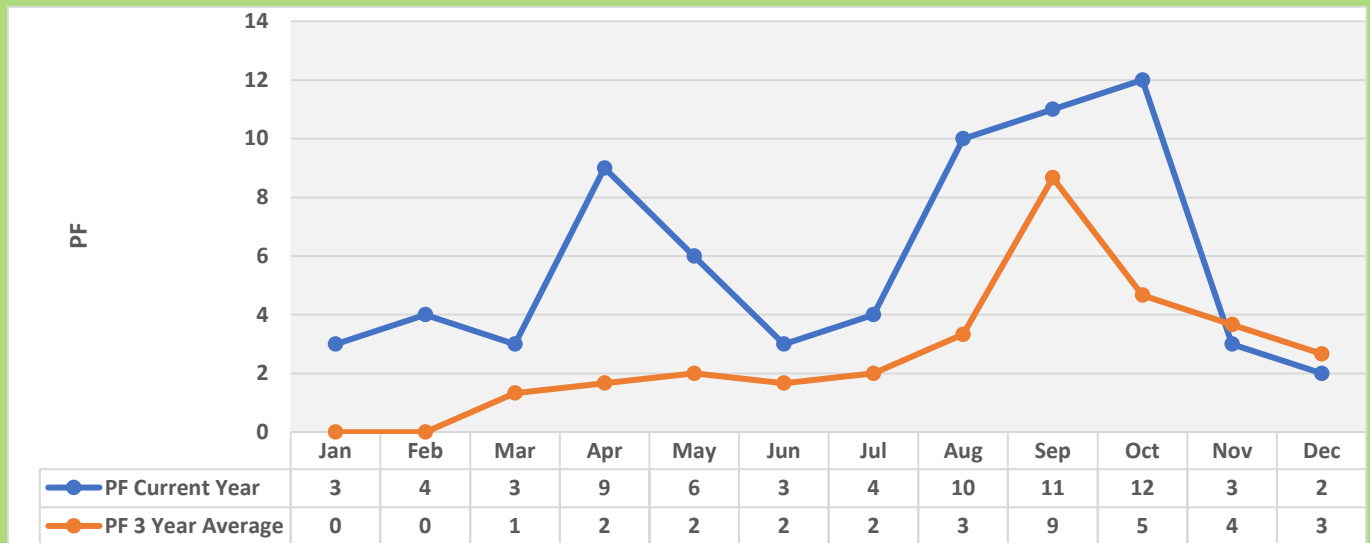

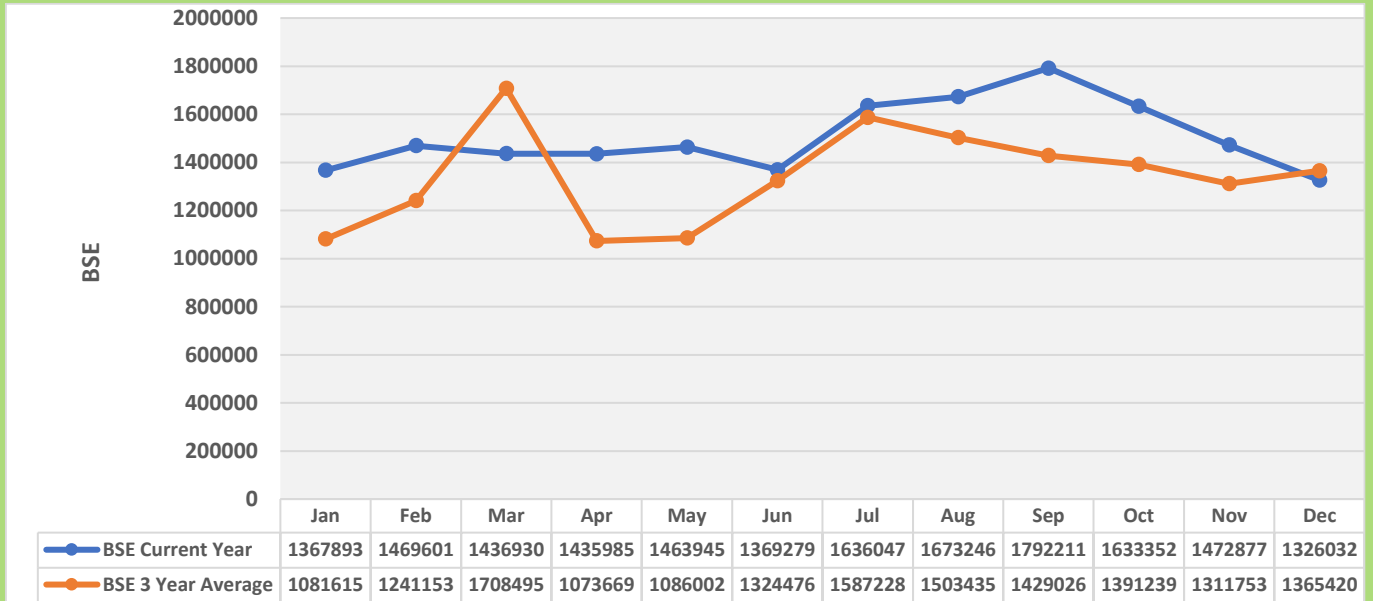

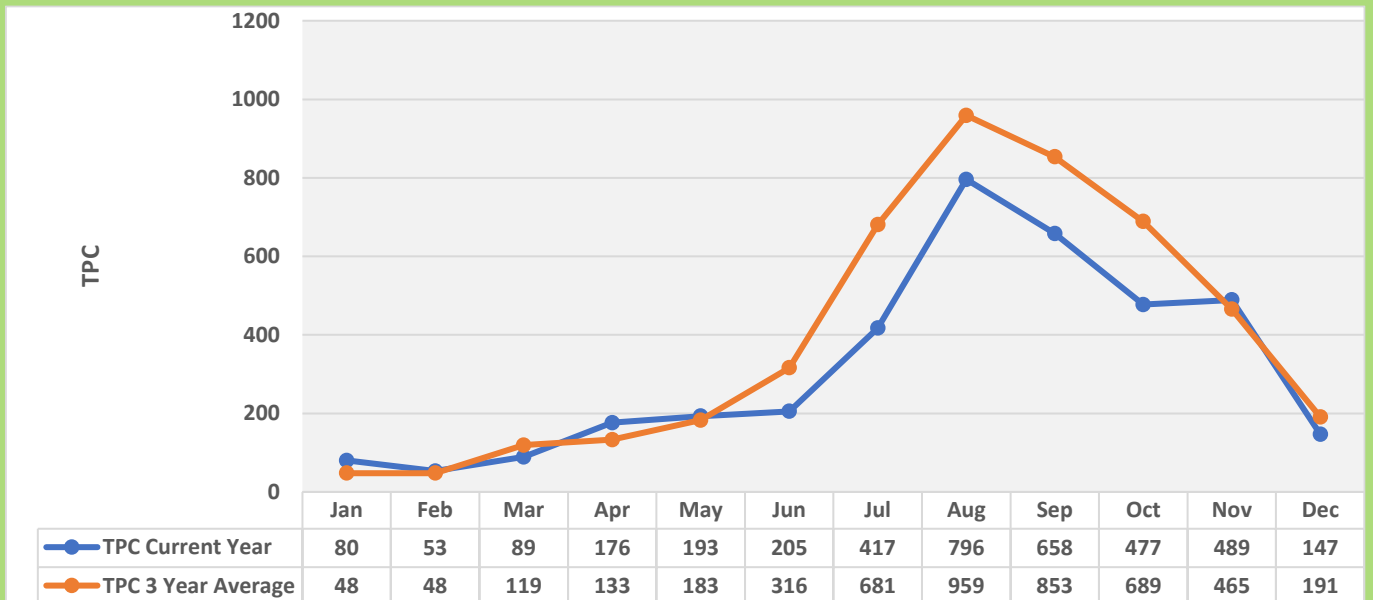

**GRAPH 1: MONTH WISE TREND OF BSE IN GUJARAT**



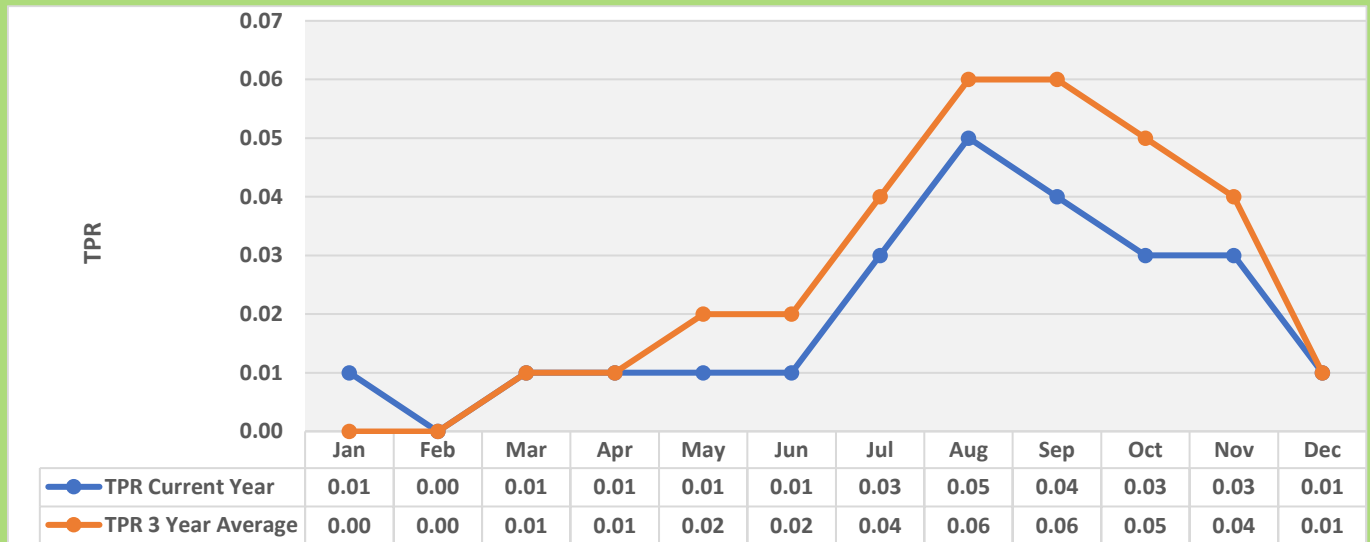

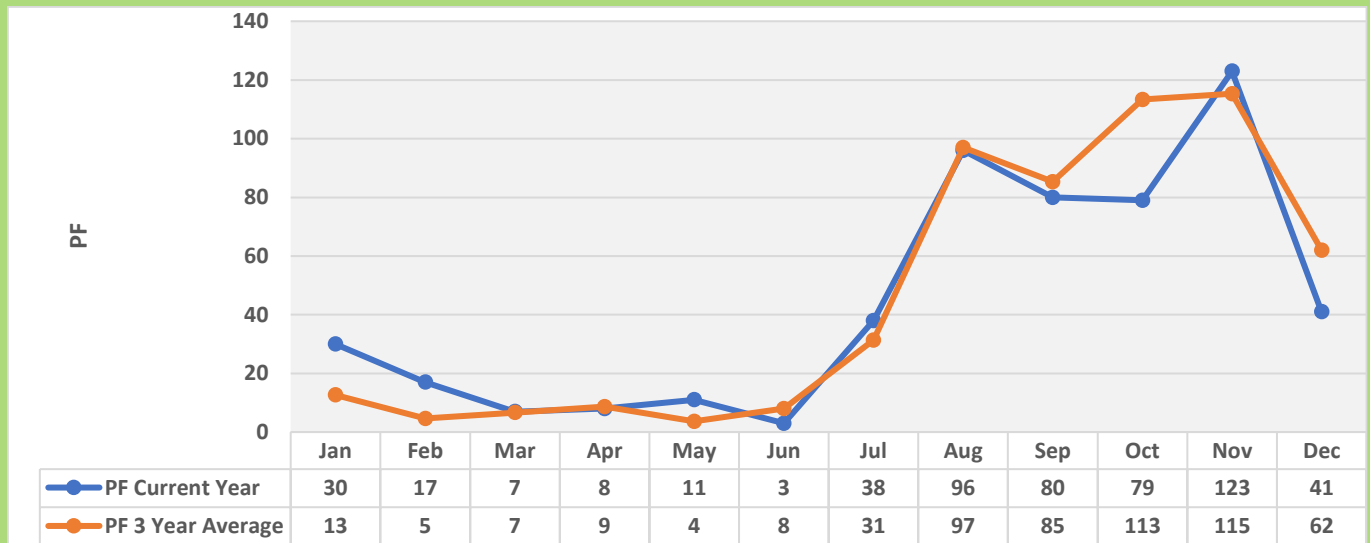

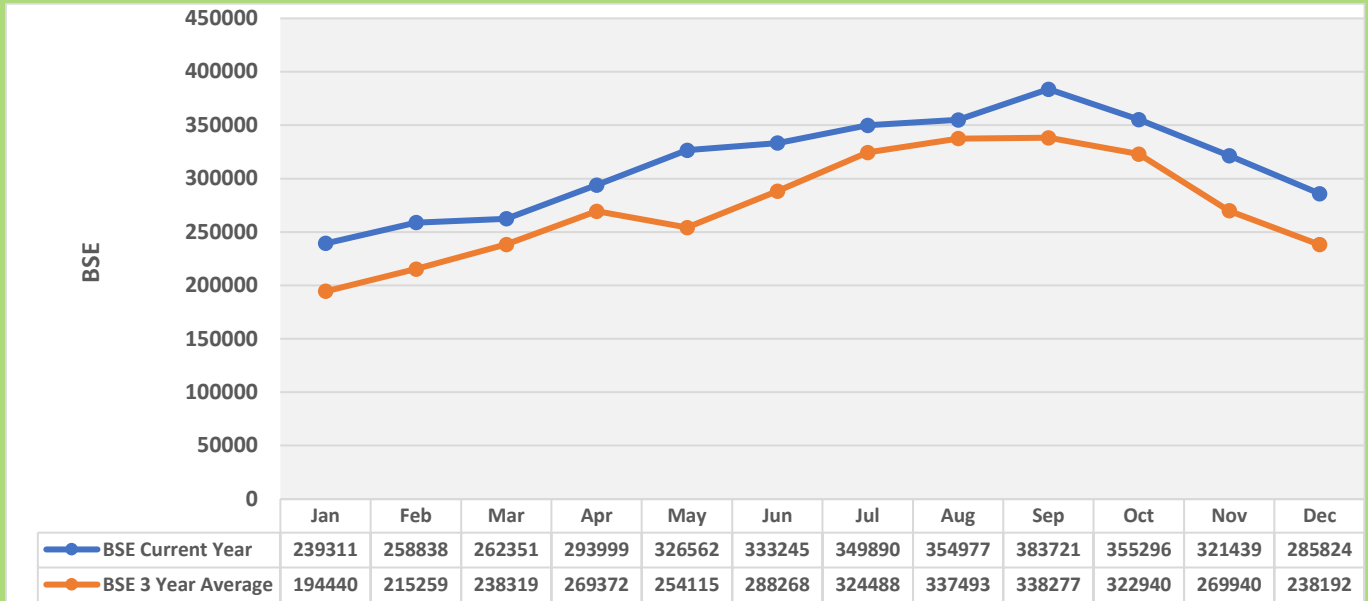
**GRAPH 4: MONTH WISE TREND OF PF IN GUJARAT**

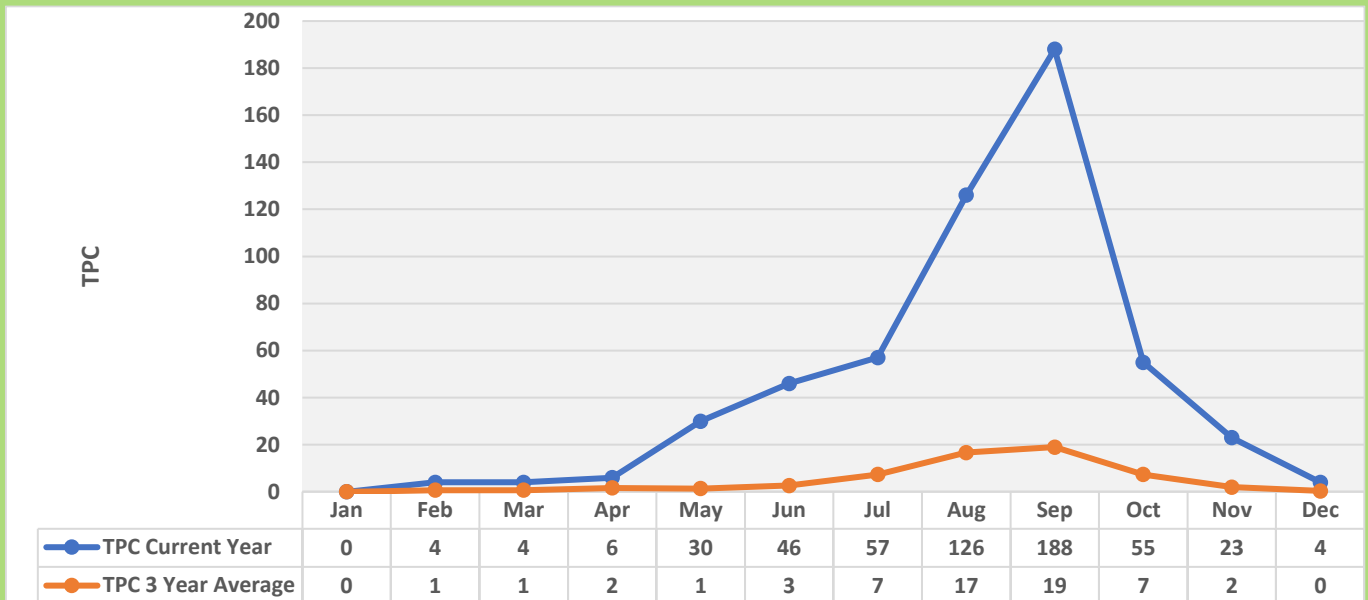

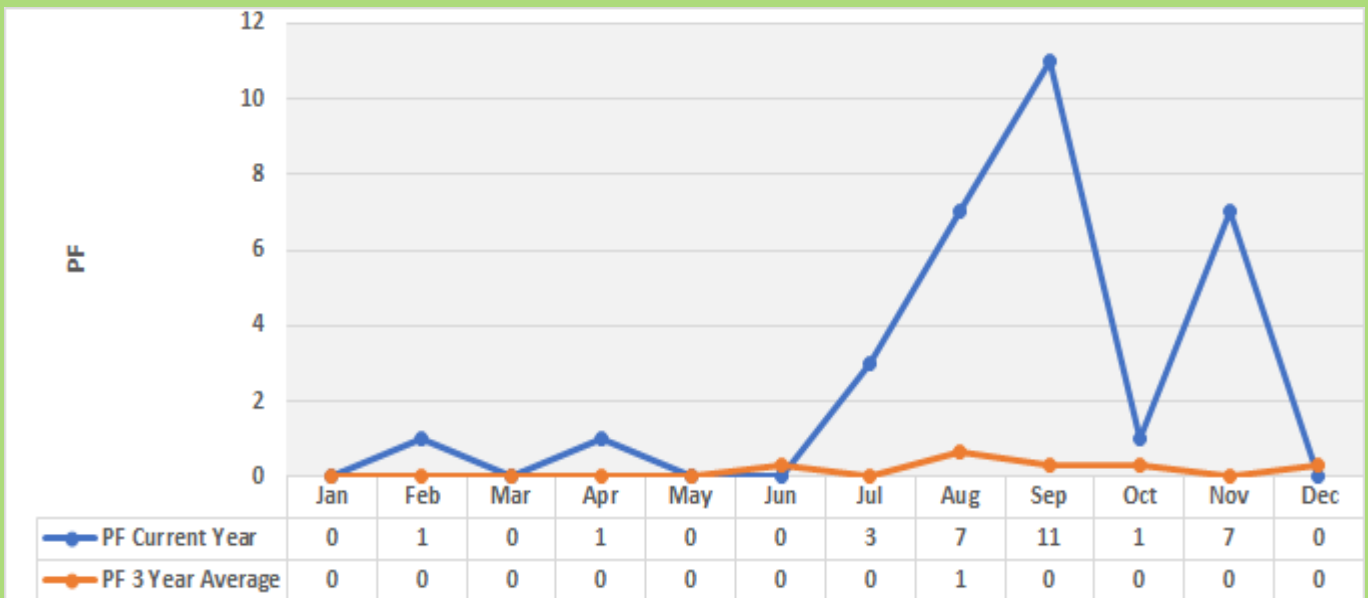

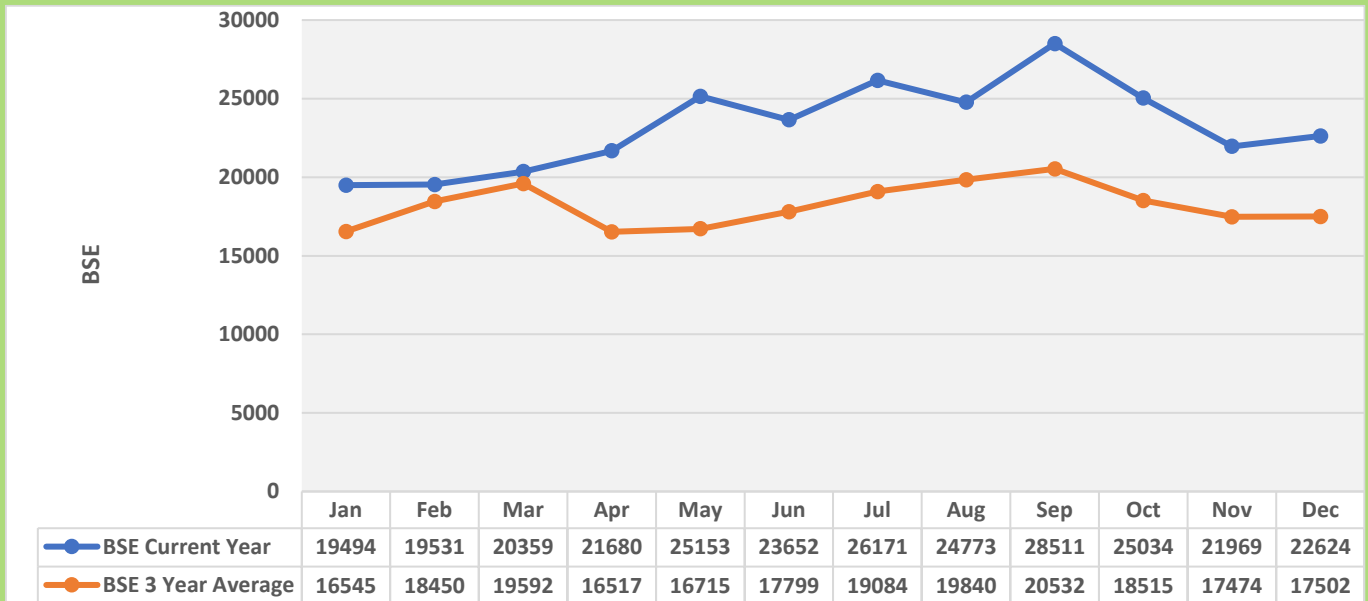
**GRAPH 4: MONTH WISE TREND OF PF IN HARYANA**

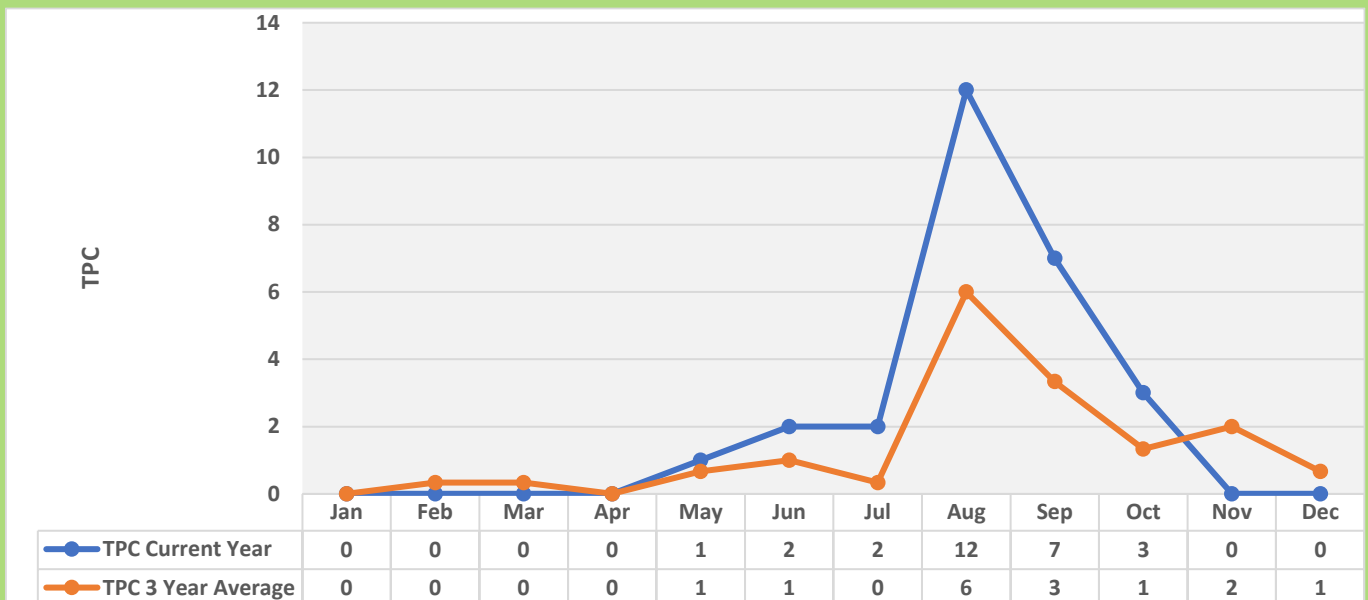

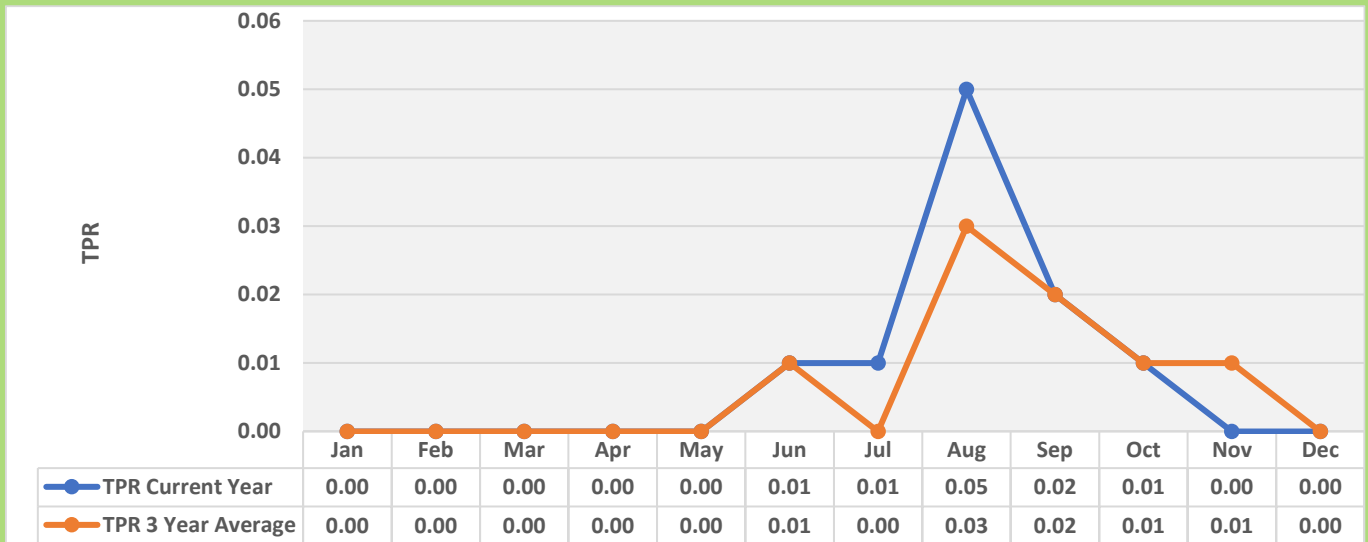
**GRAPH 2: MONTH WISE TREND OF TPC IN HIMACHAL PRADESH**

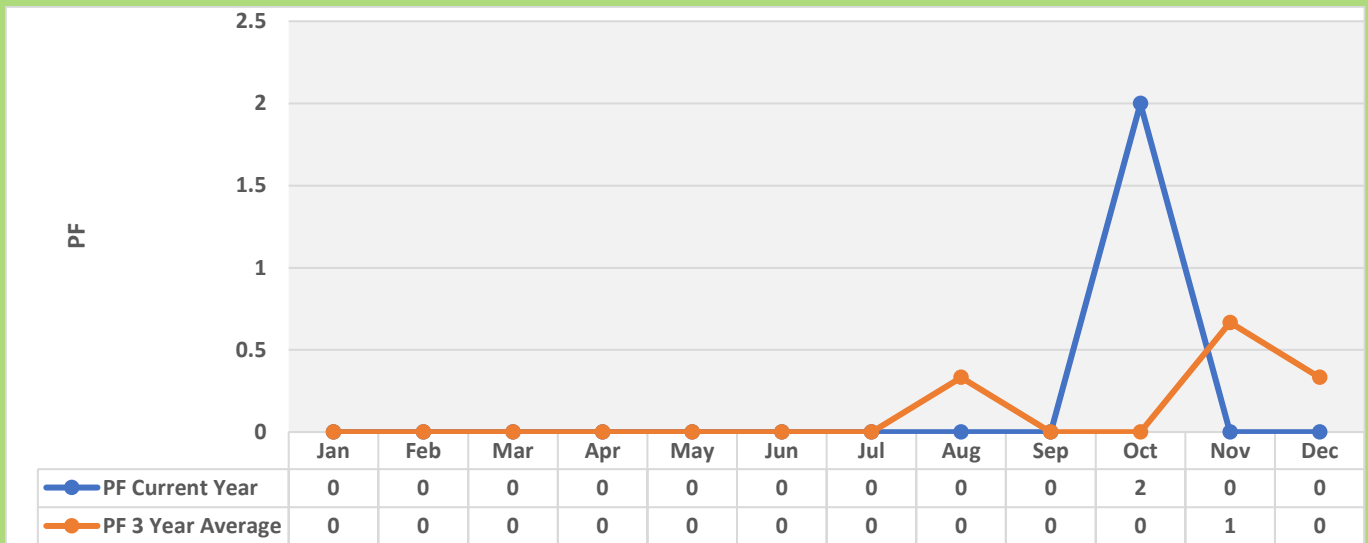


**GRAPH 3: MONTH WISE TREND OF TPR IN HIMACHAL PRADESH**

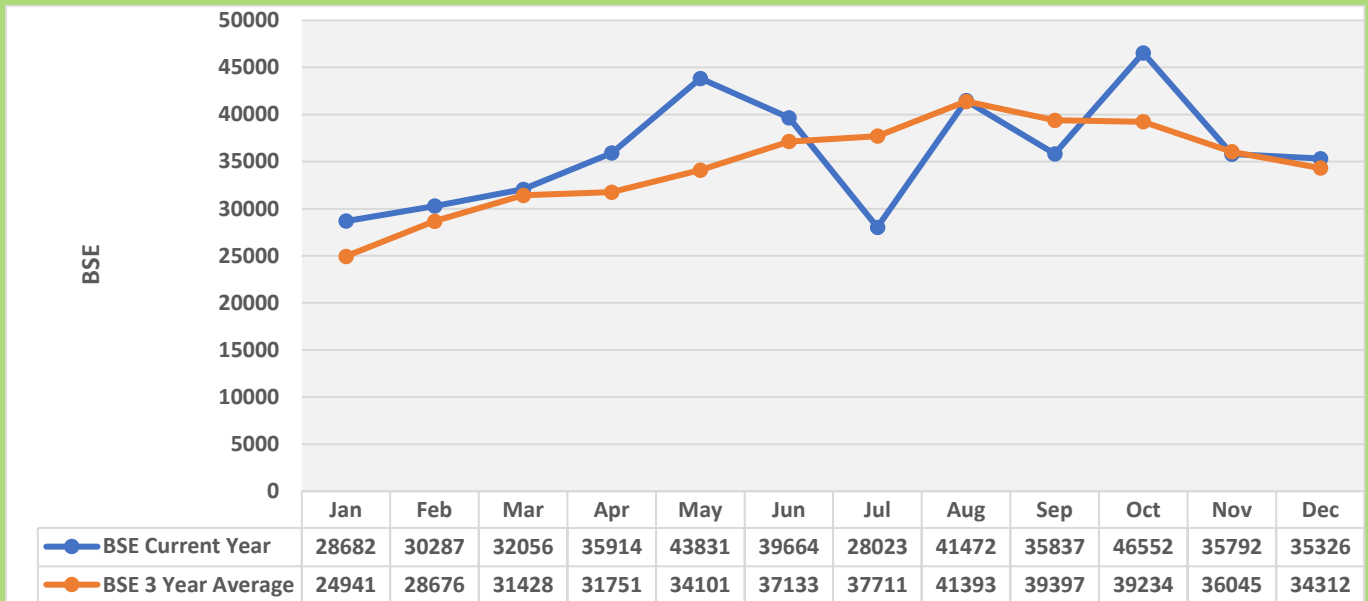
**GRAPH 4: MONTH WISE TREND OF PF IN HIMACHAL PRADESH**

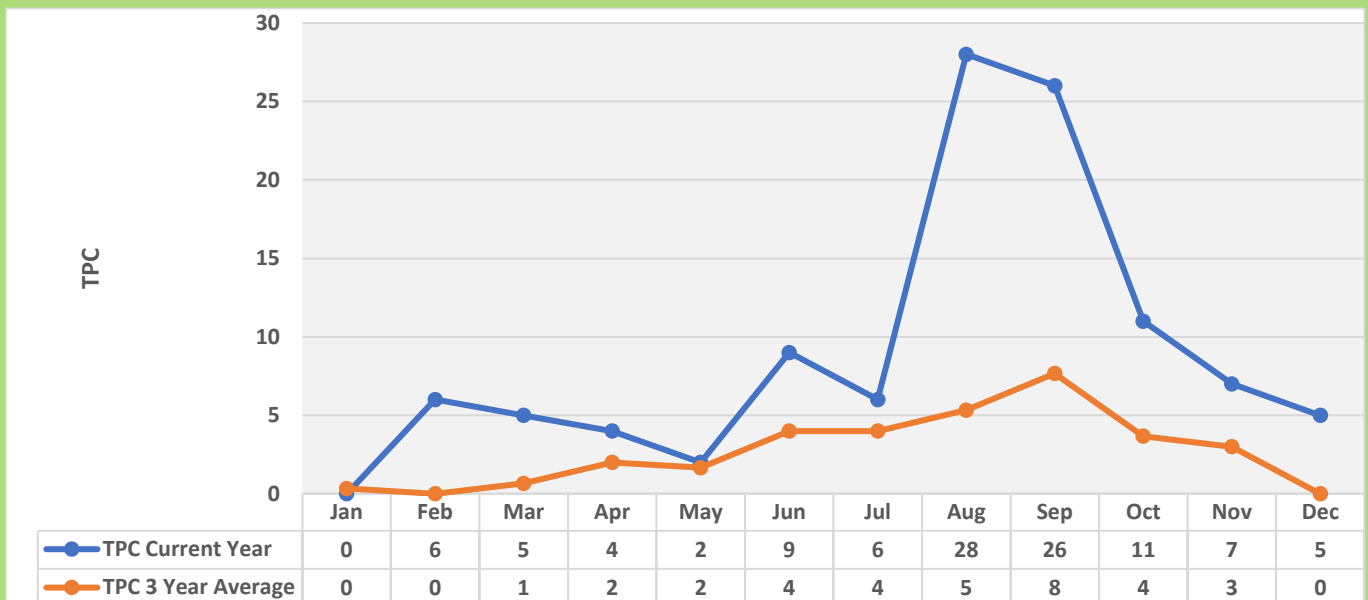

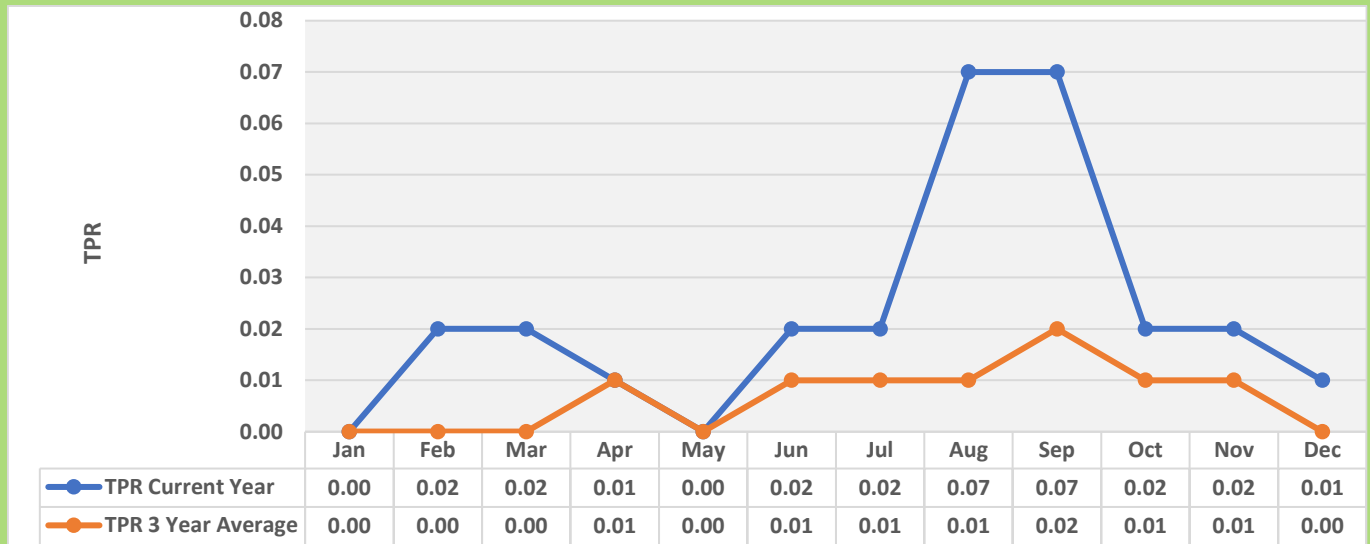

**GRAPH 2: MONTH WISE TREND OF TPC IN JAMMU AND KASHMIR**



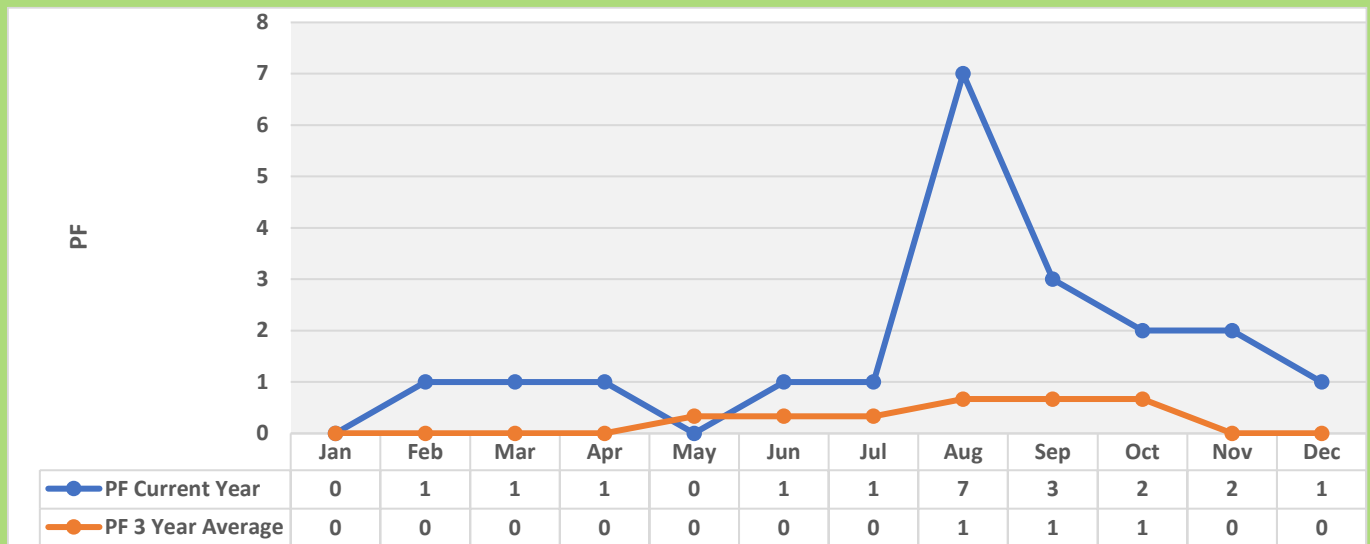

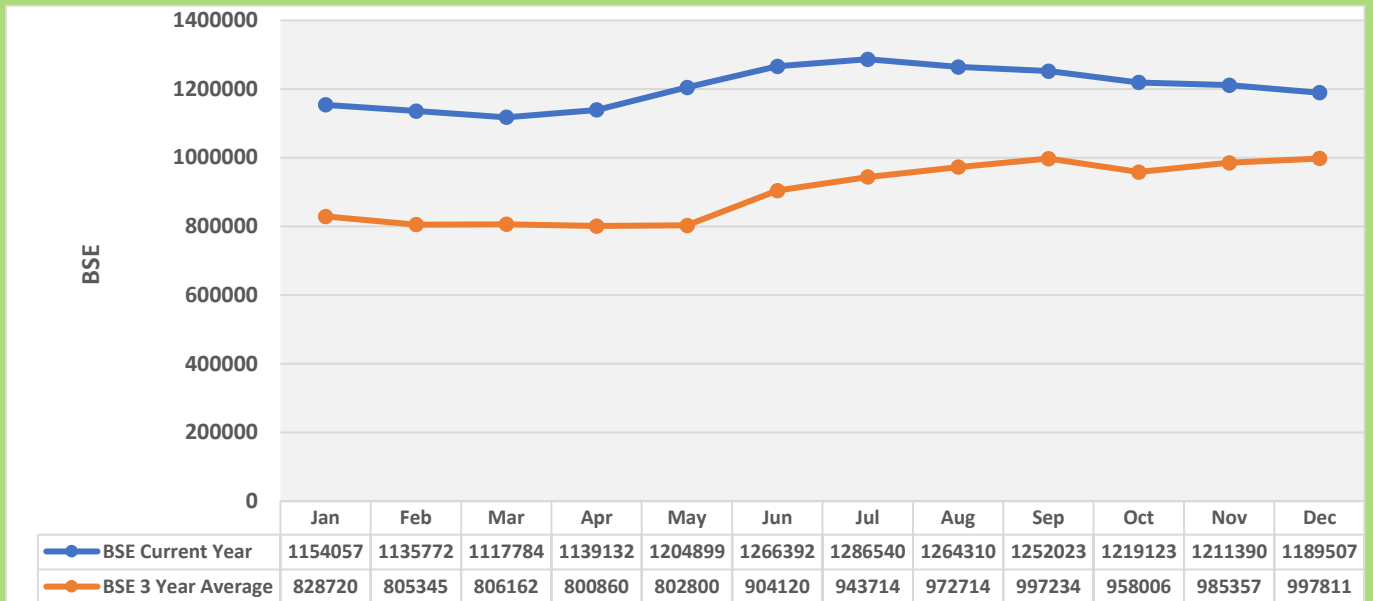

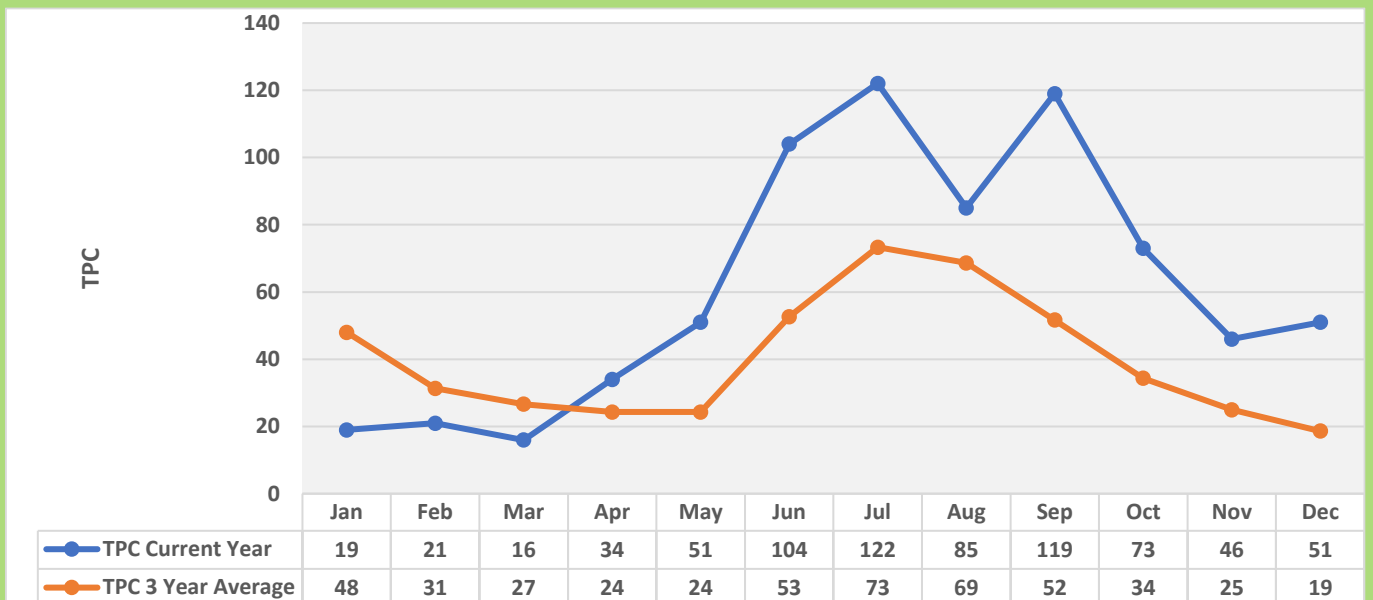

**GRAPH 1: MONTH WISE TREND OF BSE IN KARNATAKA**



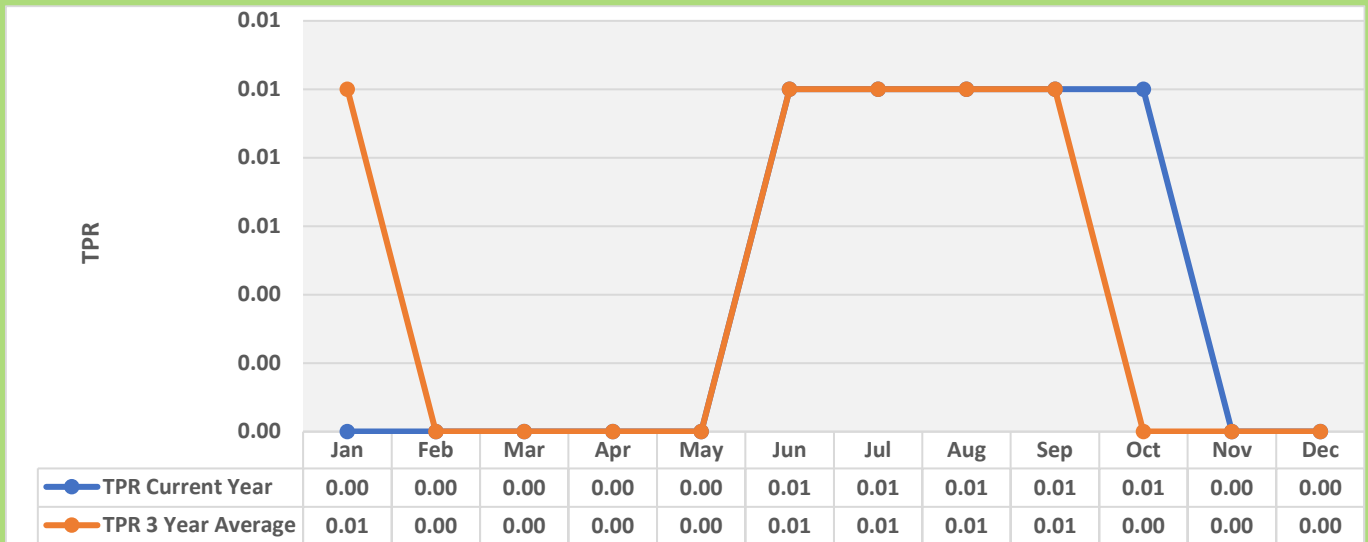

**GRAPH 2: MONTH WISE TREND OF TPC IN KARNATAKA**



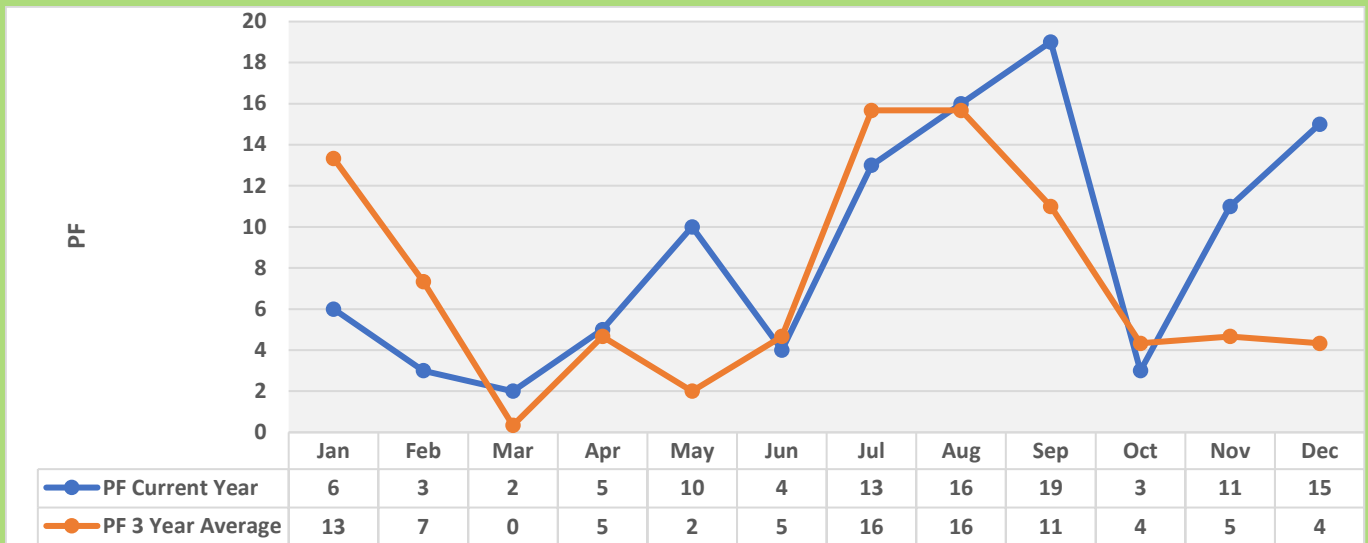

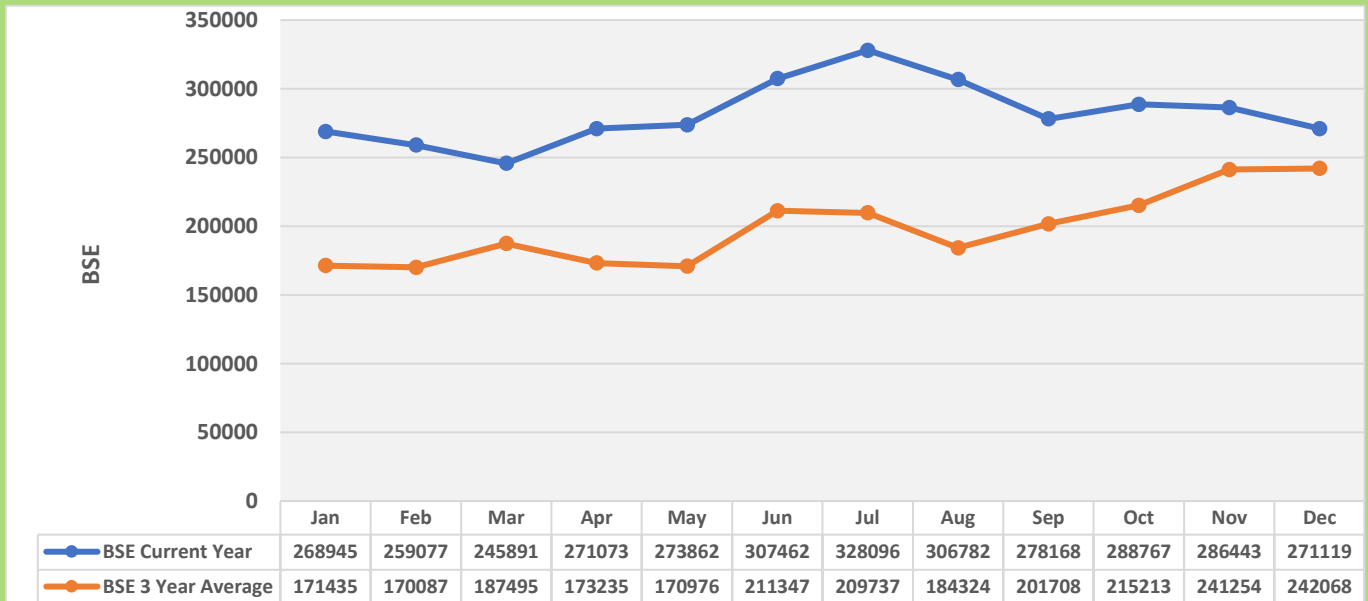

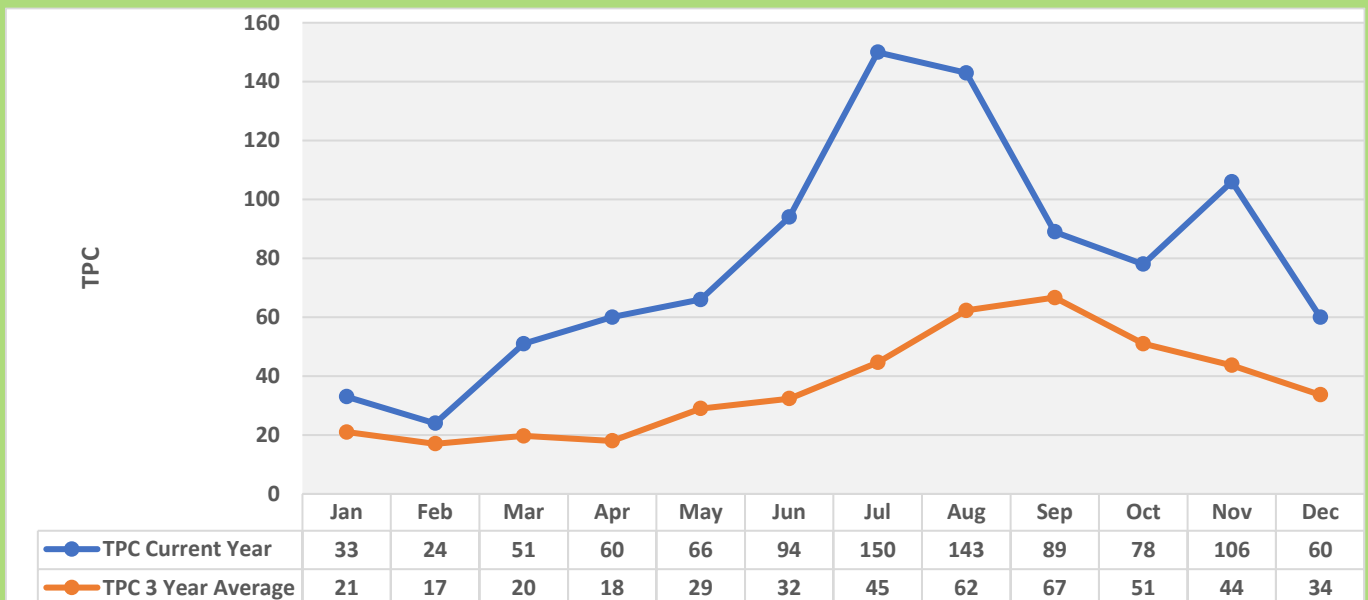

**GRAPH 1: MONTH WISE TREND OF BSE IN KERALA**



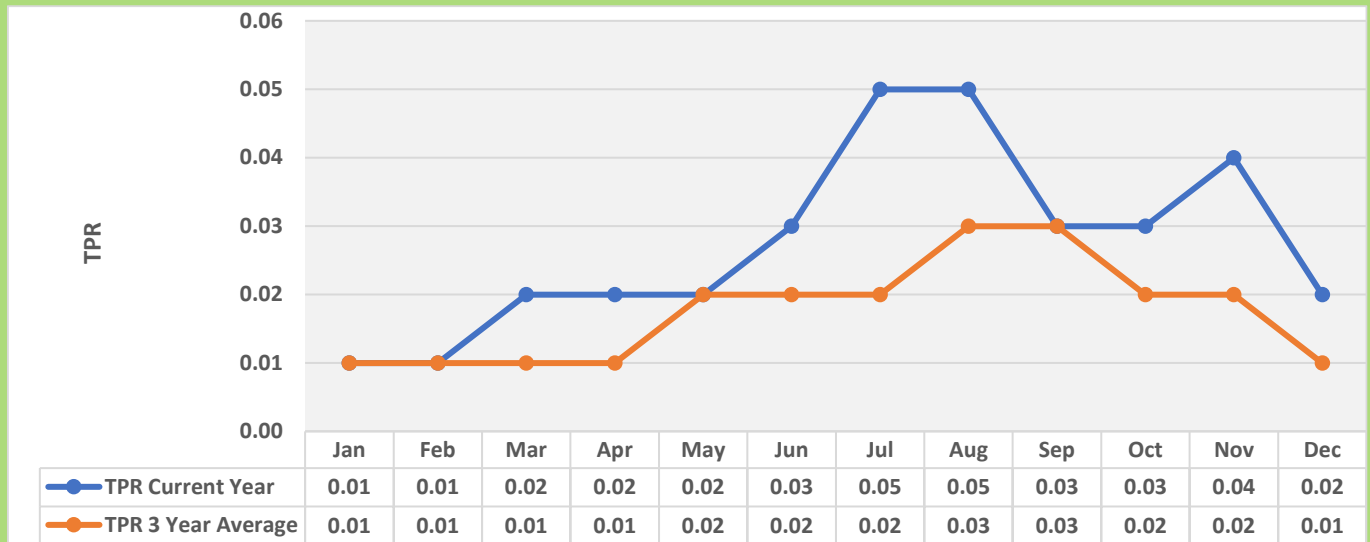

**GRAPH 2: MONTH WISE TREND OF TPC IN KERALA**



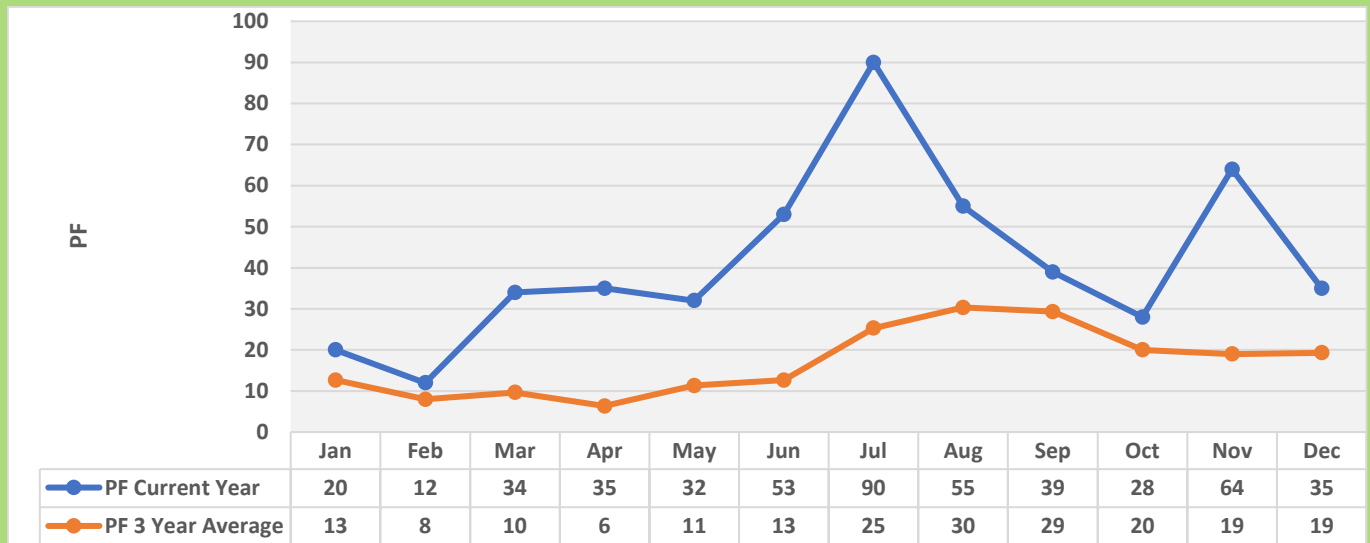

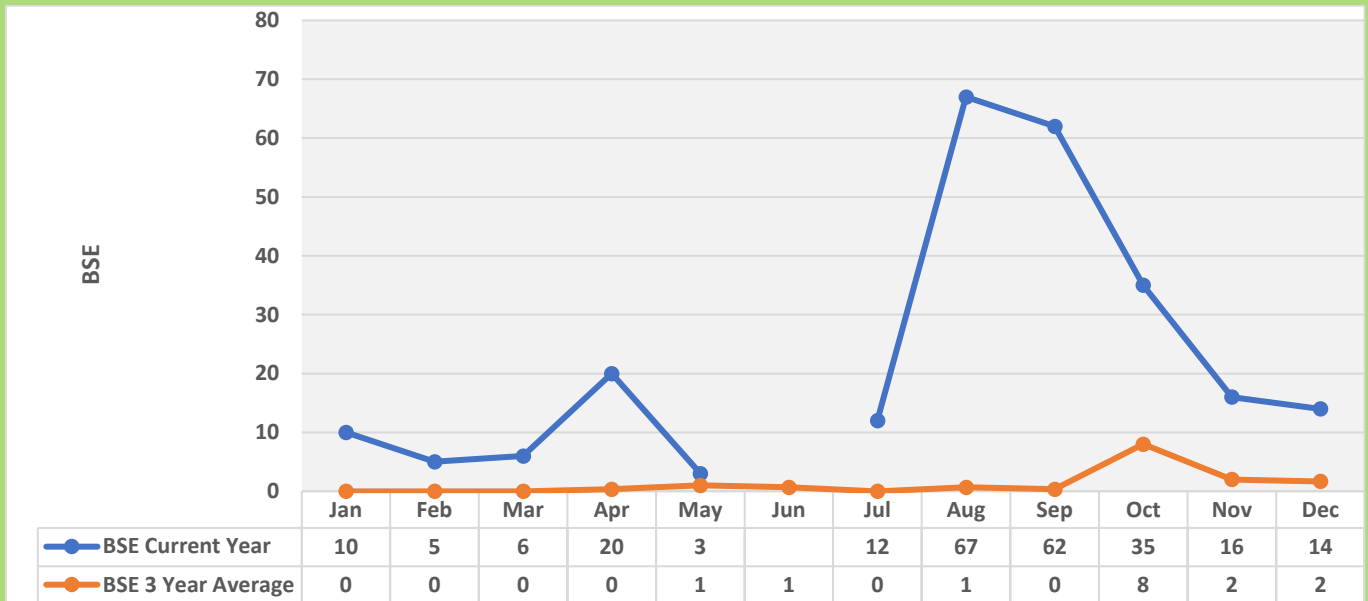

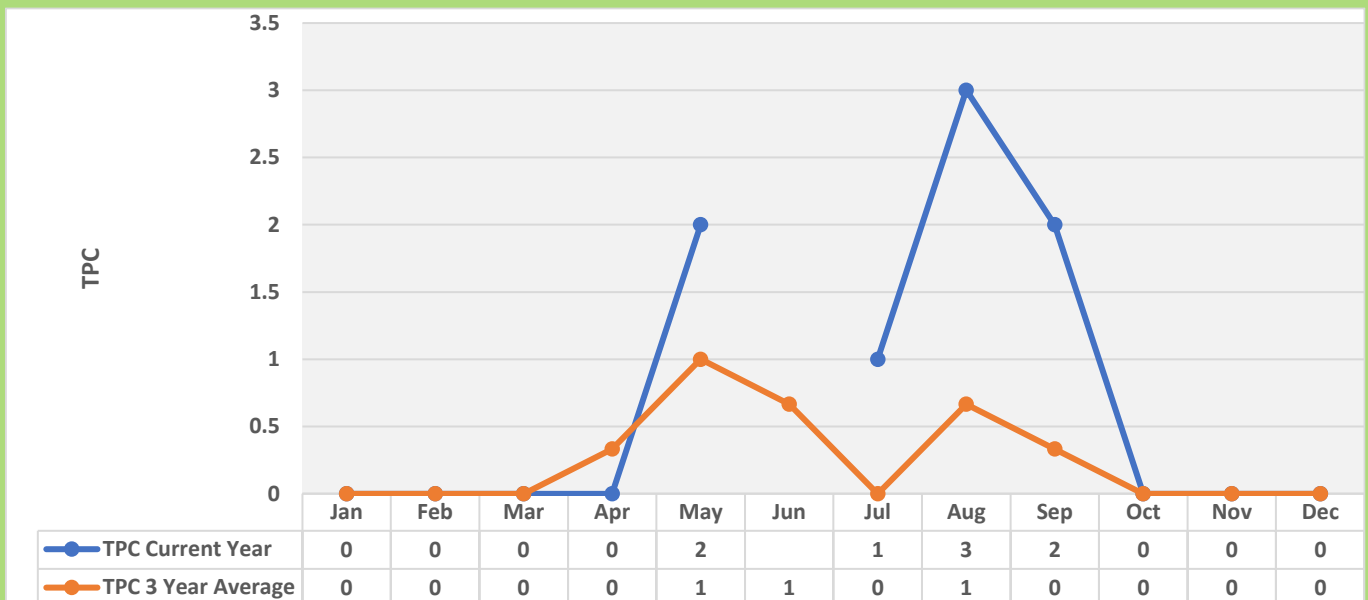

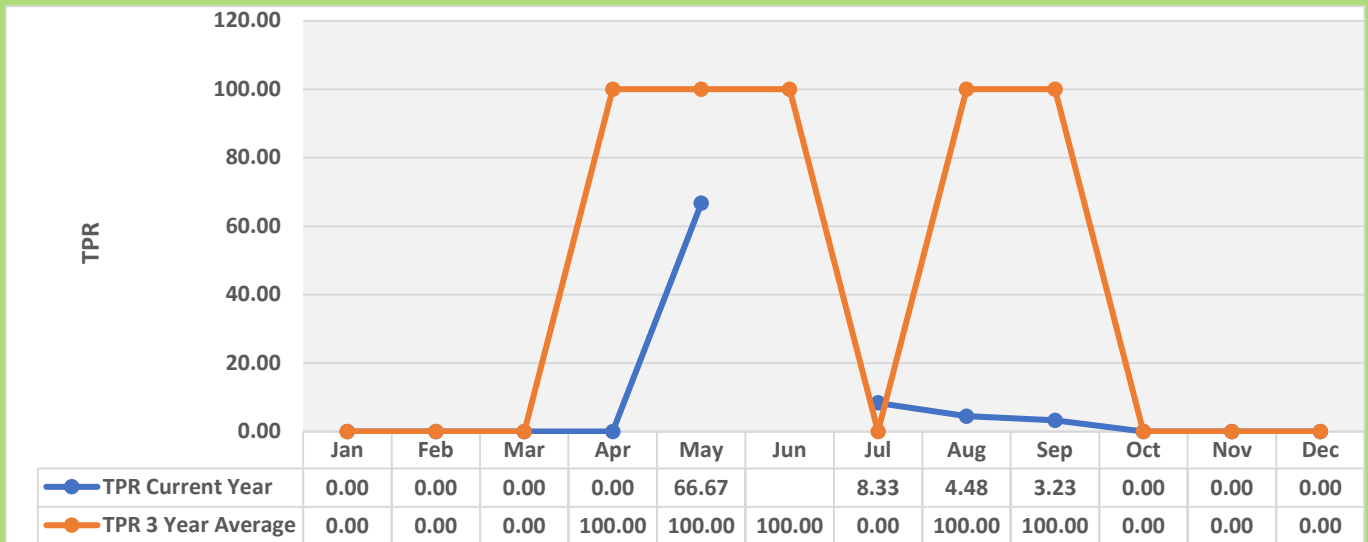

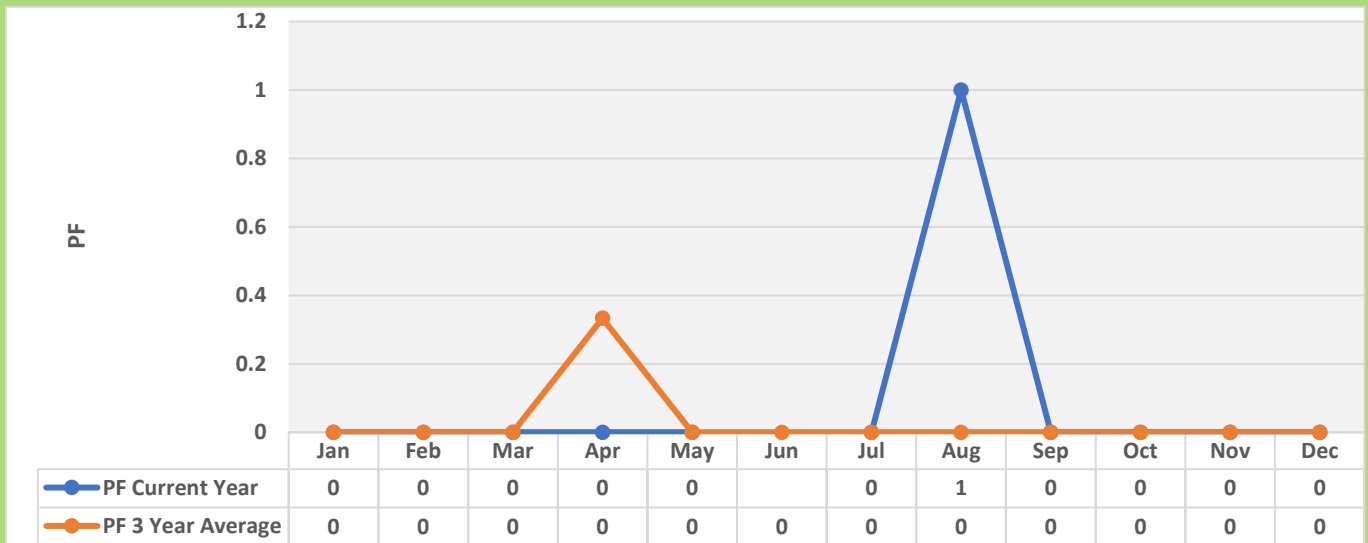


**GRAPH 3: MONTH WISE TREND OF TPR IN LADAKH**

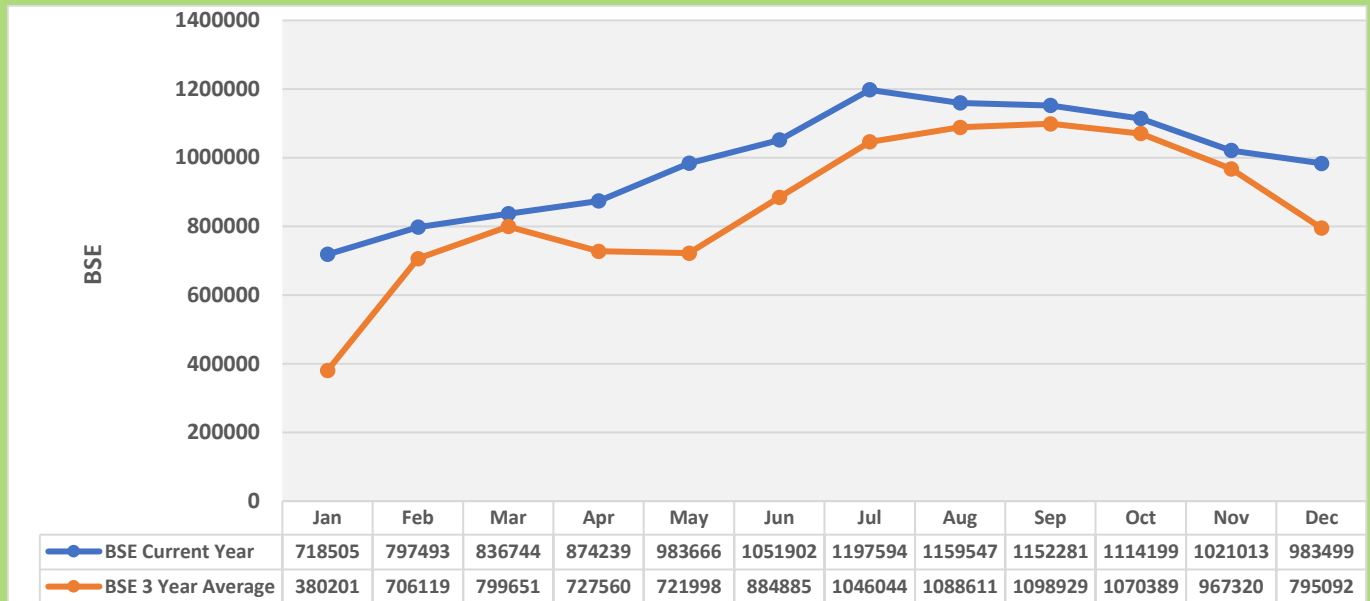
**GRAPH 4: MONTH WISE TREND OF PF IN LADAKH**

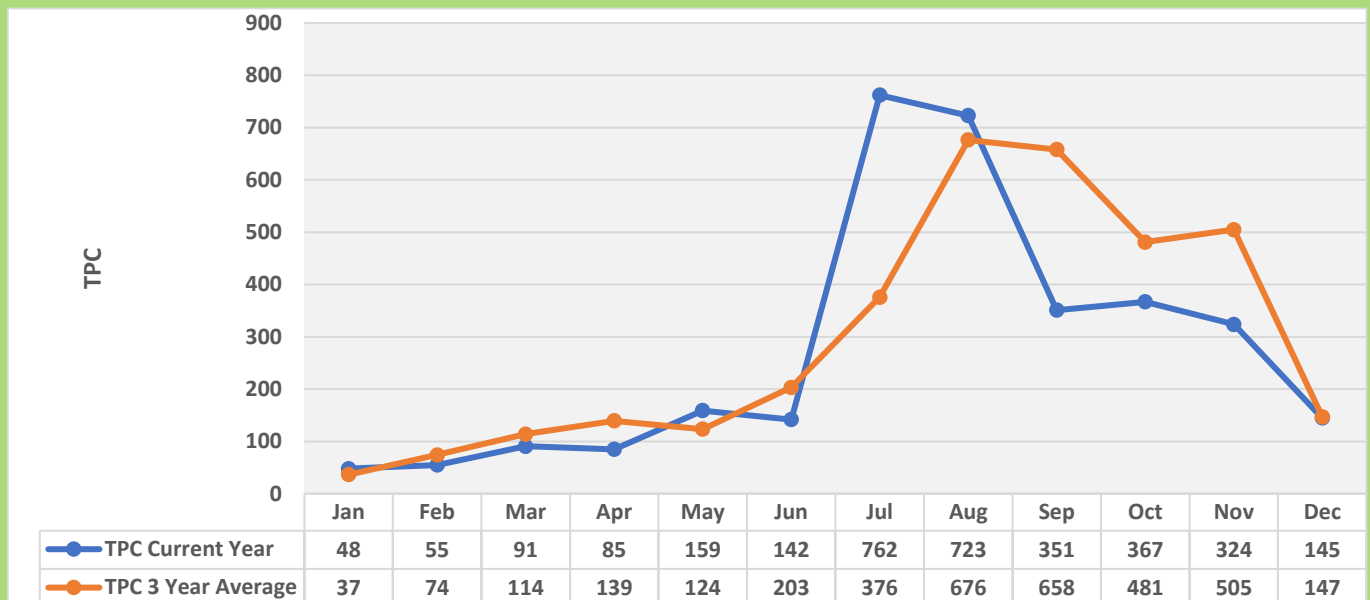

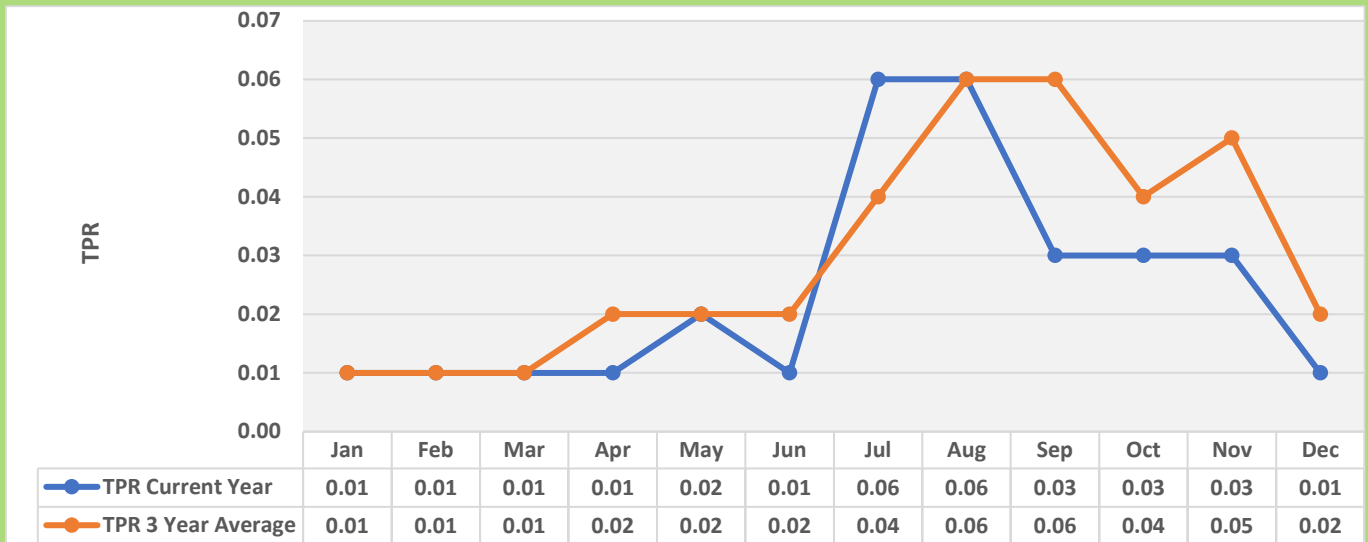

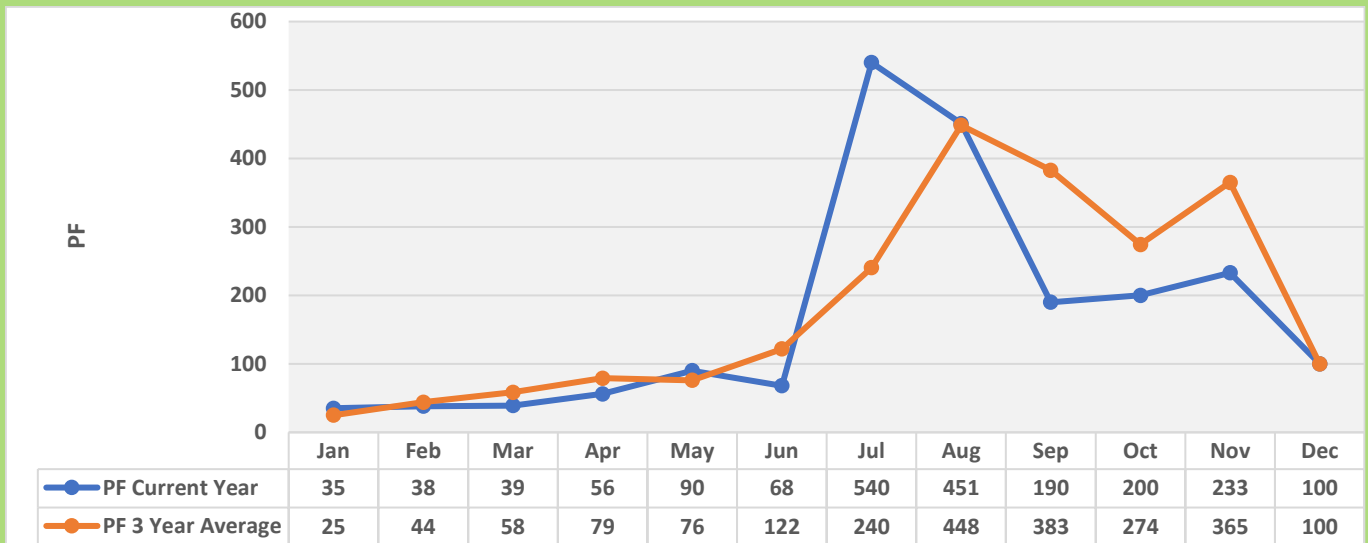

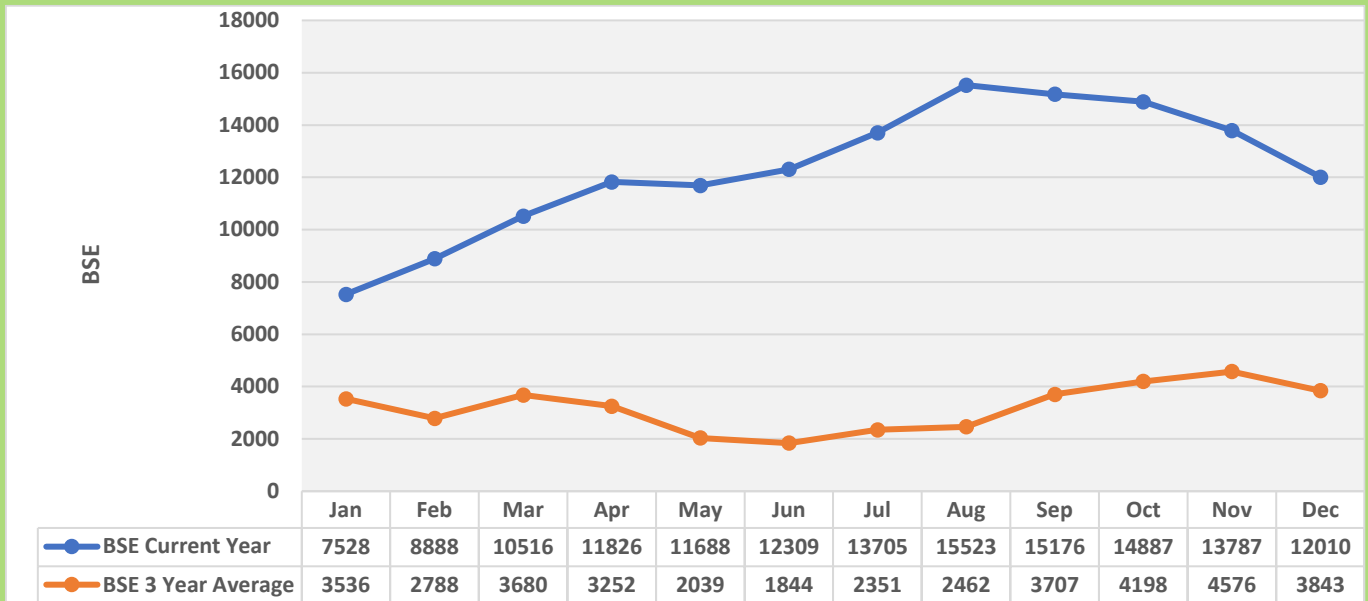

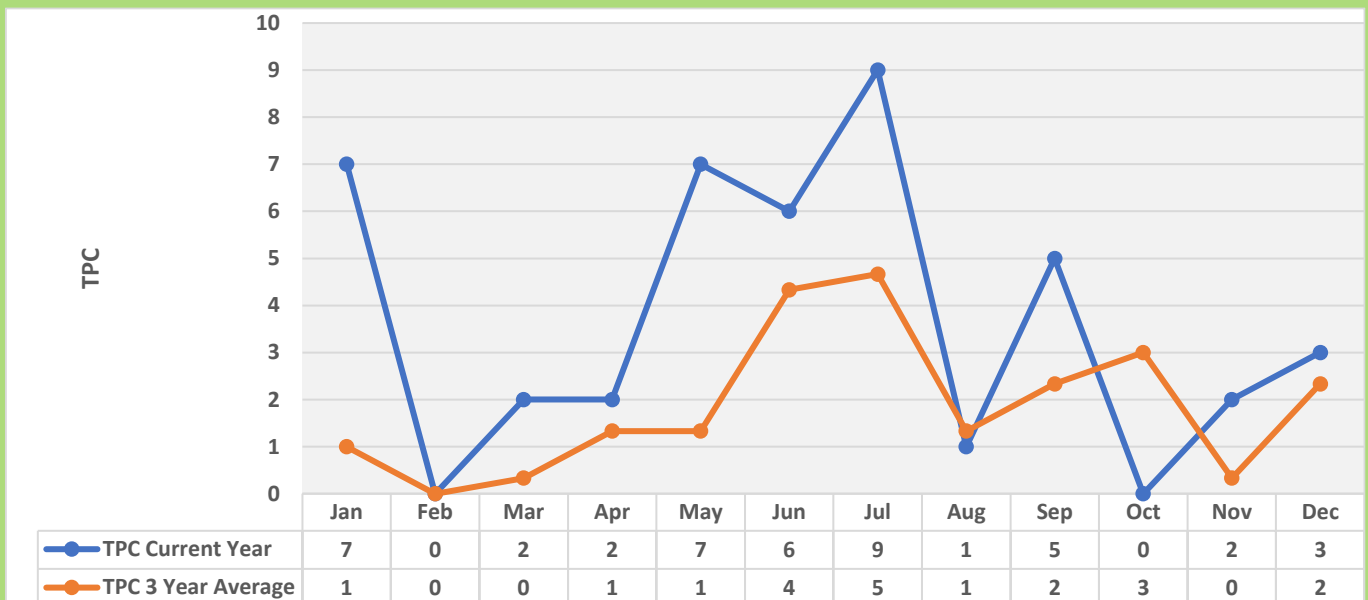

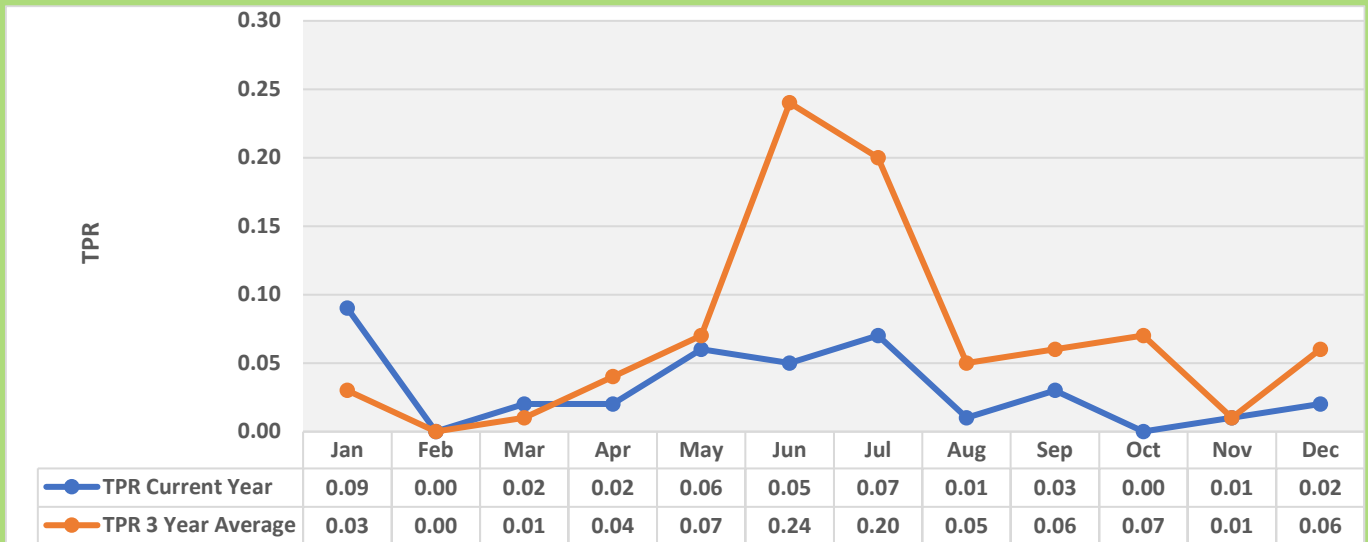

**GRAPH 2: MONTH WISE TREND OF TPC IN MANIPUR**



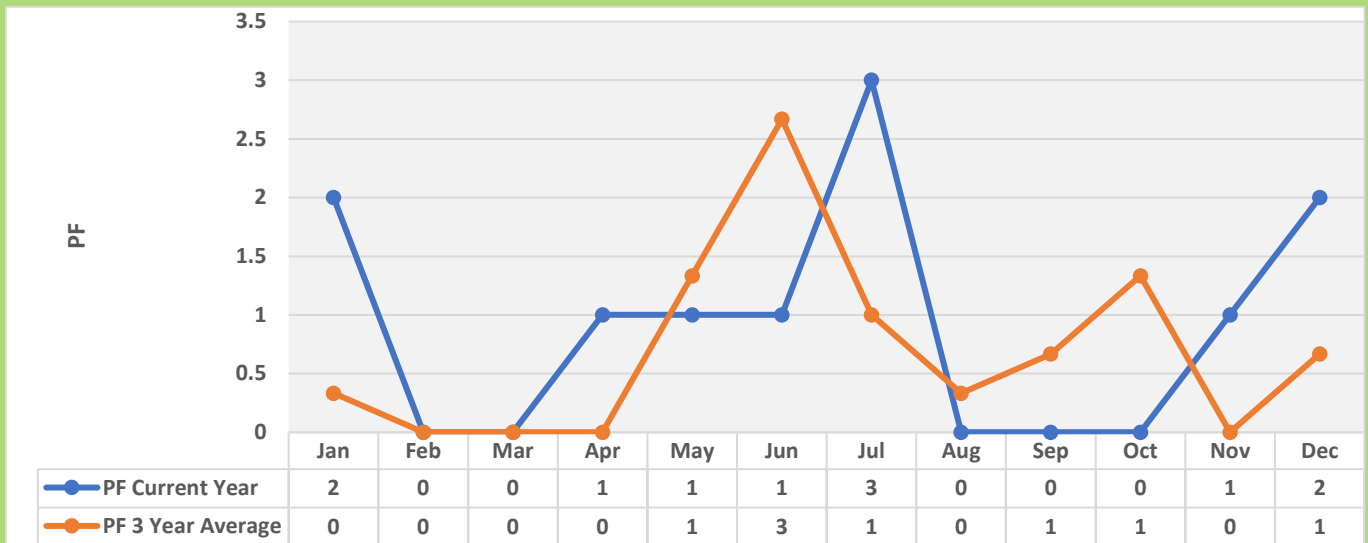

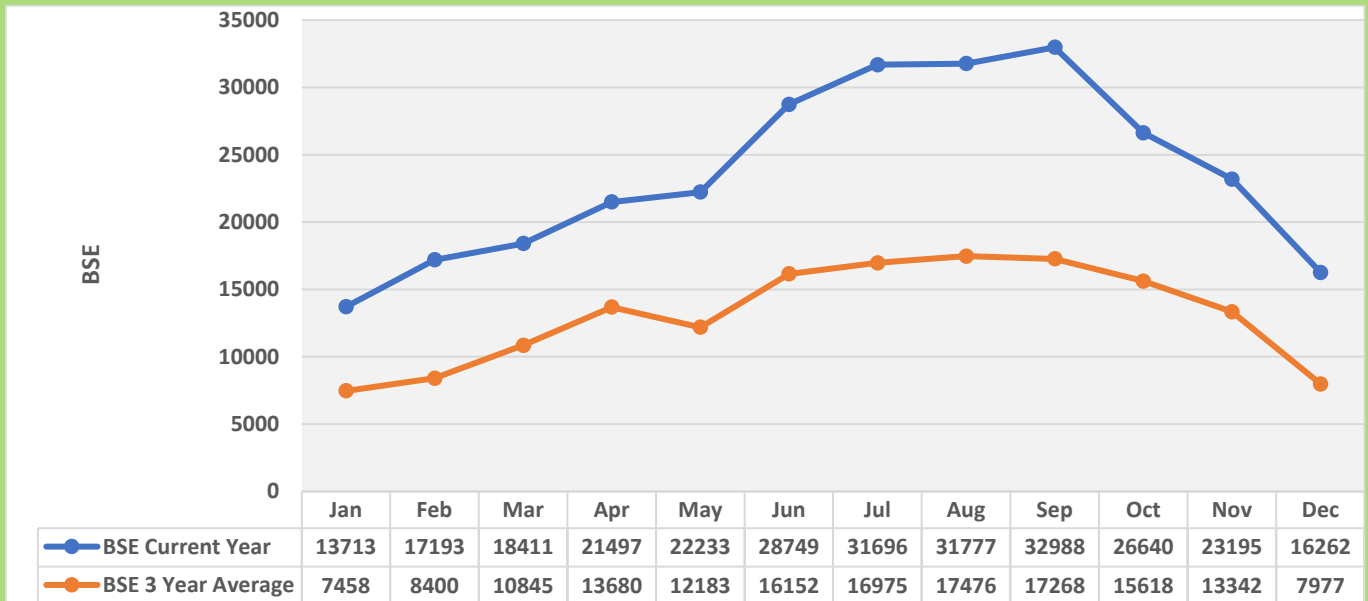
**GRAPH 4: MONTH WISE TREND OF PF IN MANIPUR**

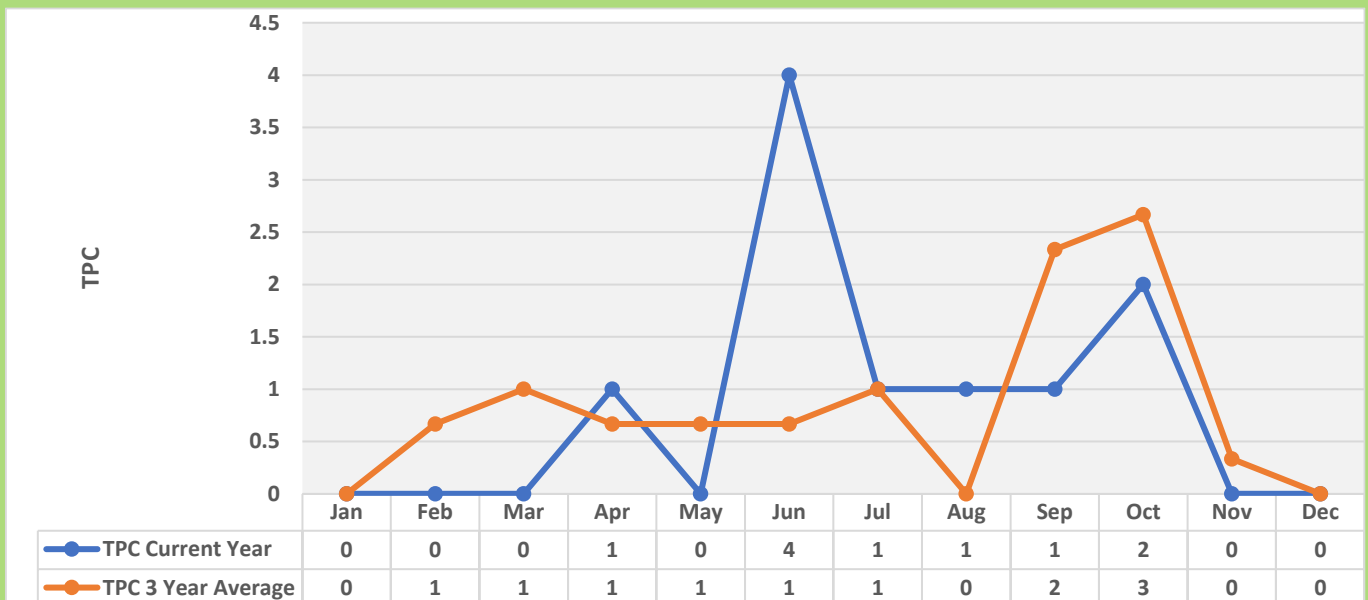

**GRAPH 1: MONTH WISE TREND OF BSE IN NAGALAND**



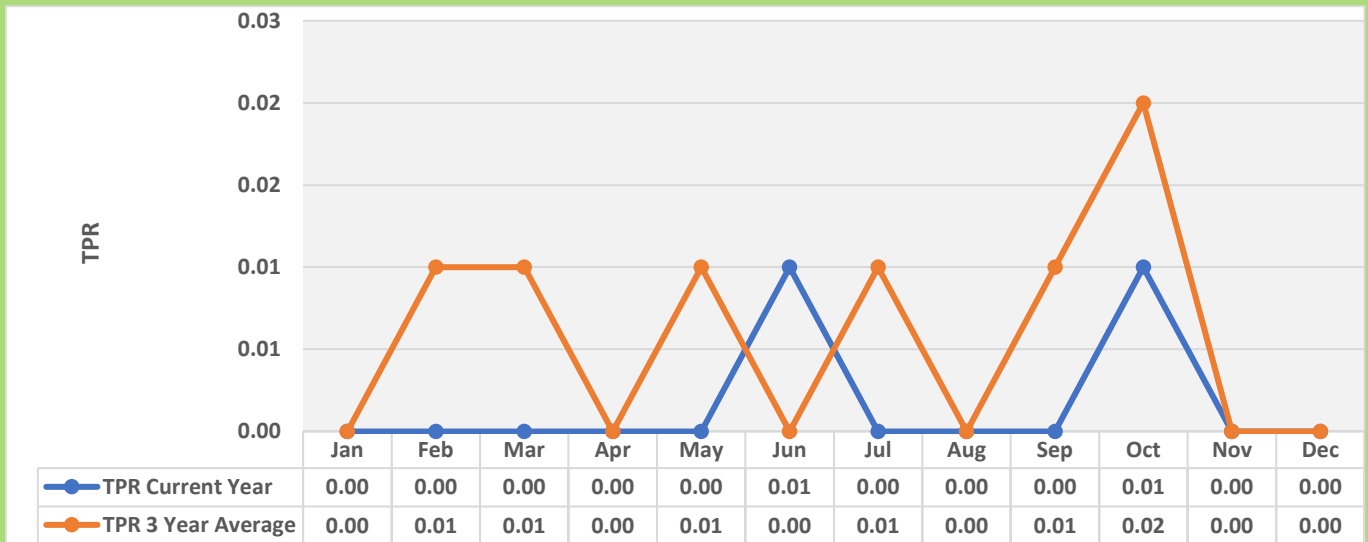

**GRAPH 2: MONTH WISE TREND OF TPC IN NAGALAND**



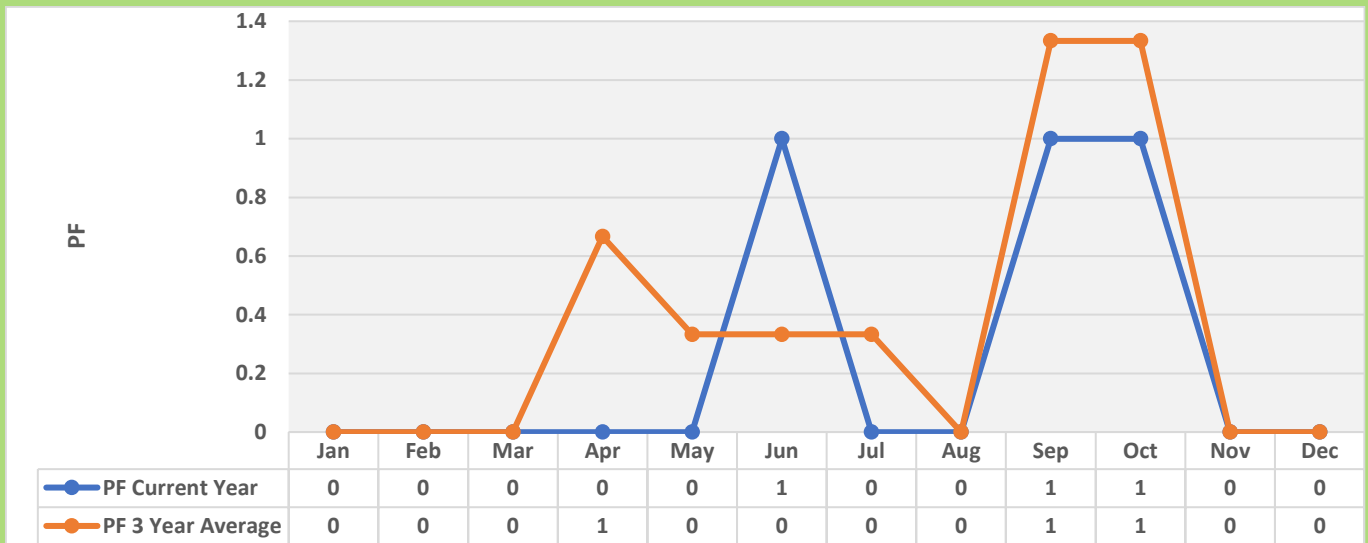

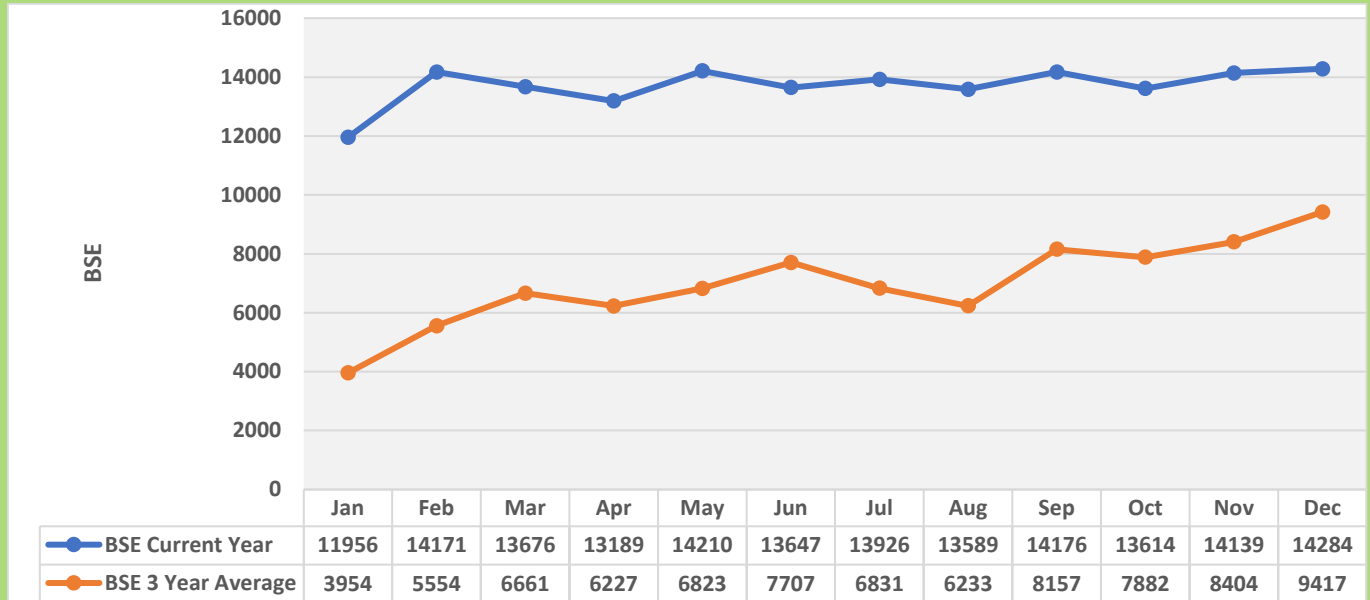

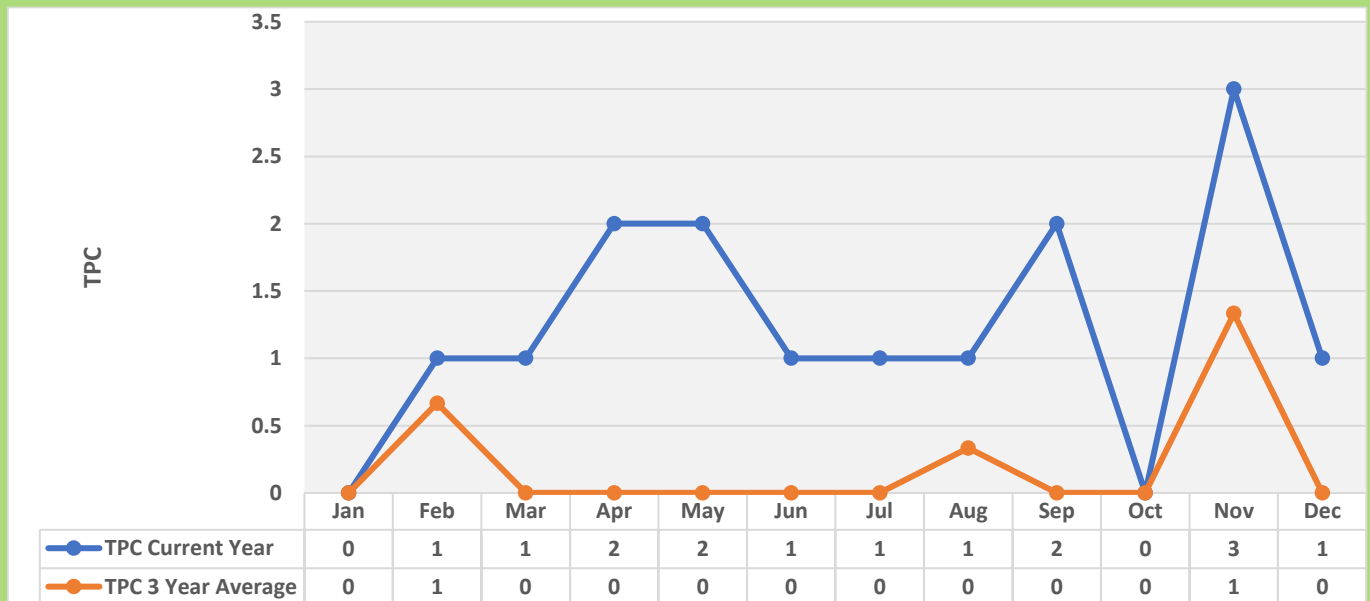

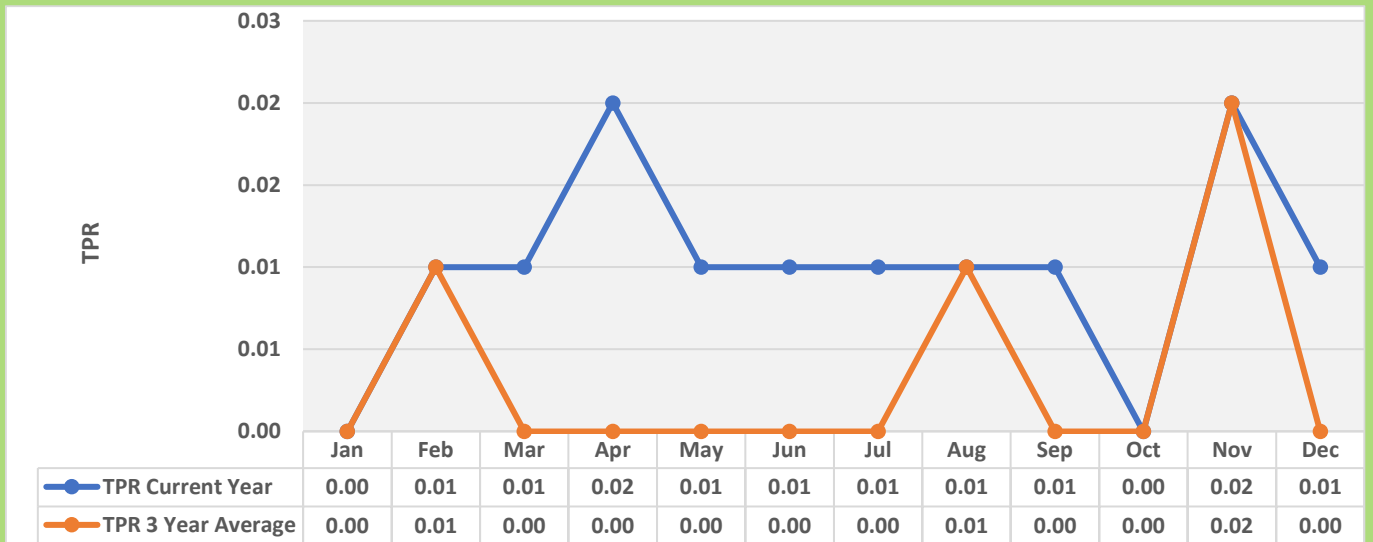
**GRAPH 2: MONTH WISE TREND OF TPC IN PUDUCHERRY**

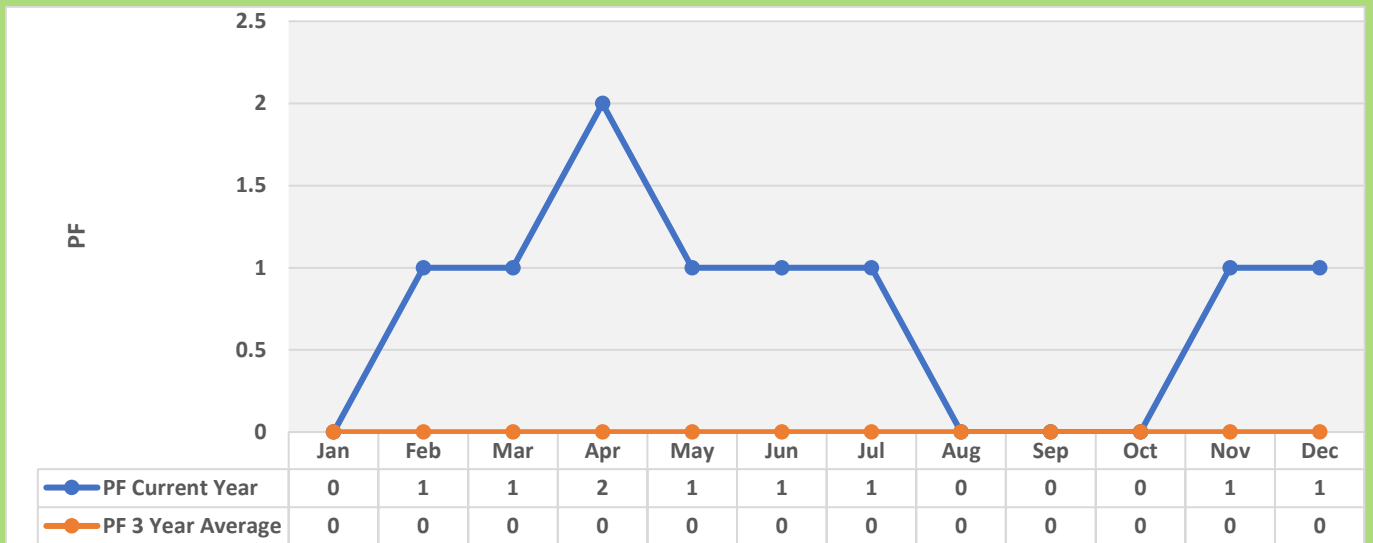


**GRAPH 3: MONTH WISE TREND OF TPR IN PUDUCHERRY**

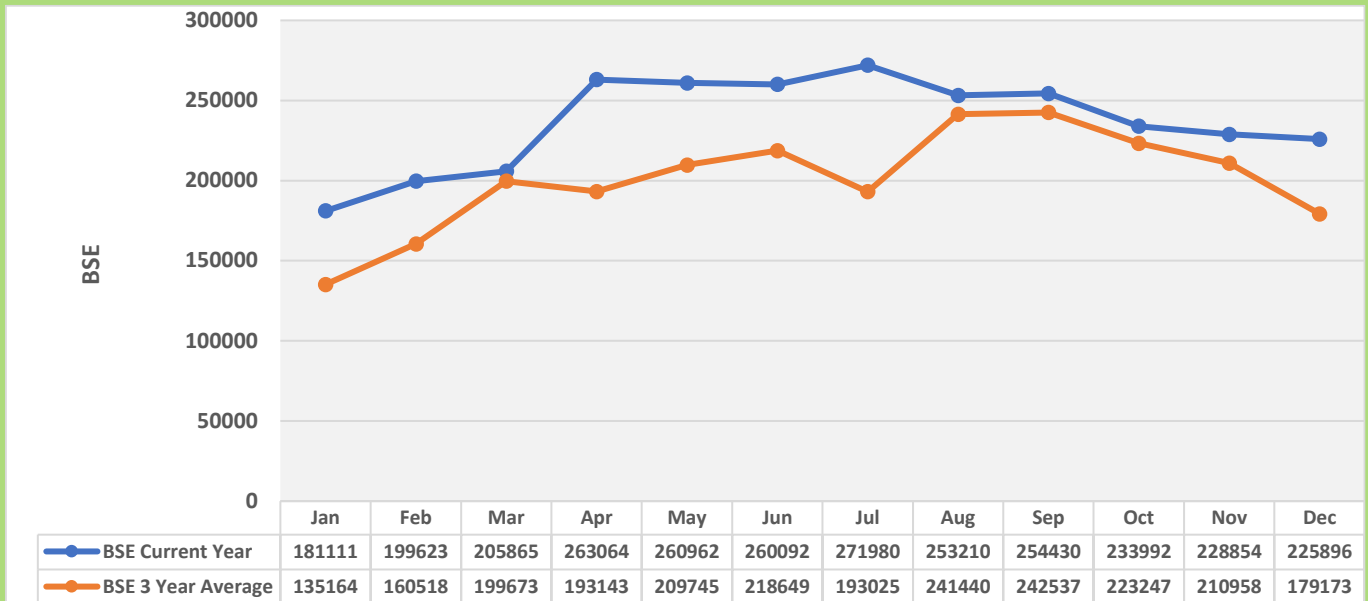
**GRAPH 4: MONTH WISE TREND OF PF IN PUDUCHERRY**

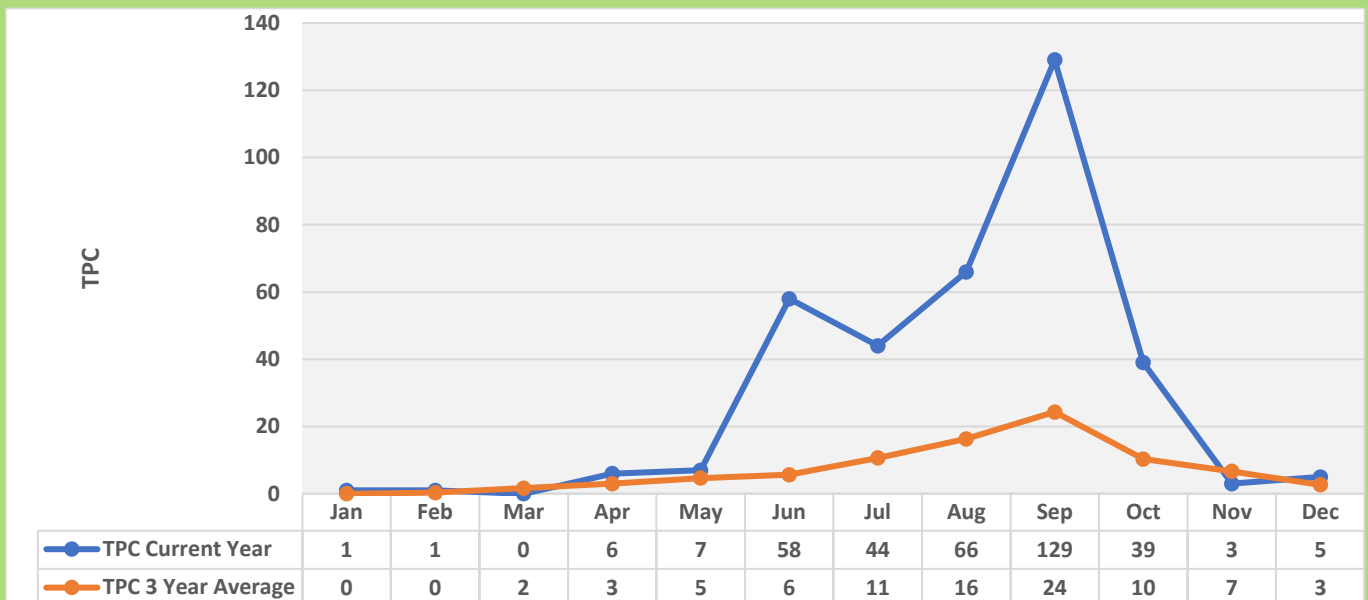

**GRAPH 1: MONTH WISE TREND OF BSE IN PUNJAB**



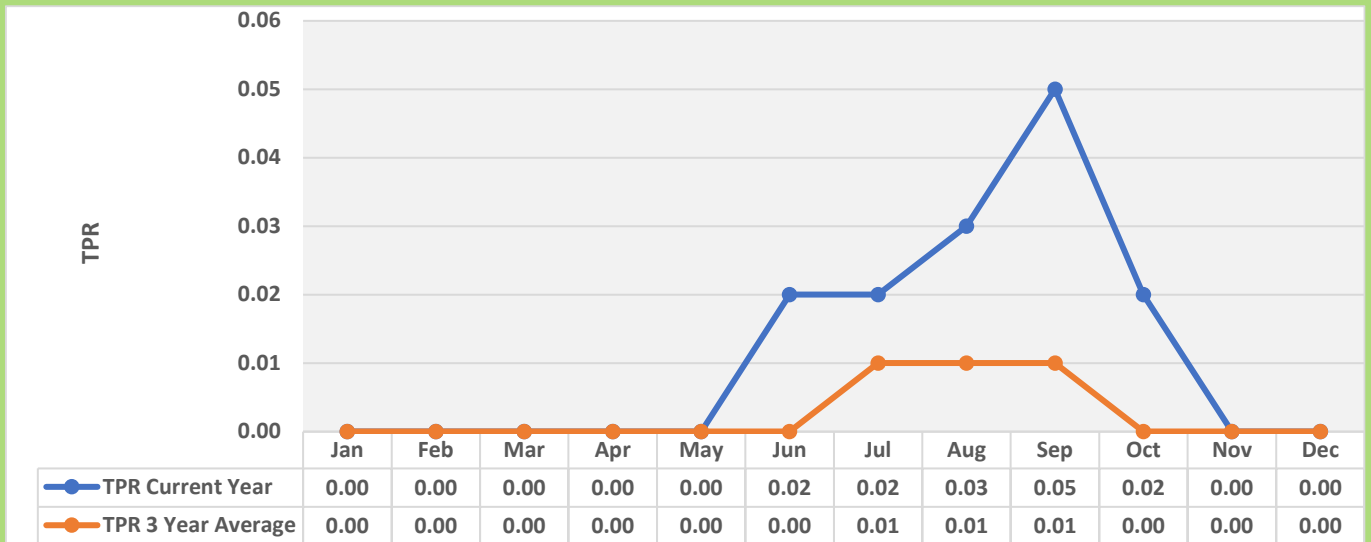

**GRAPH 2: MONTH WISE TREND OF TPC IN PUNJAB**



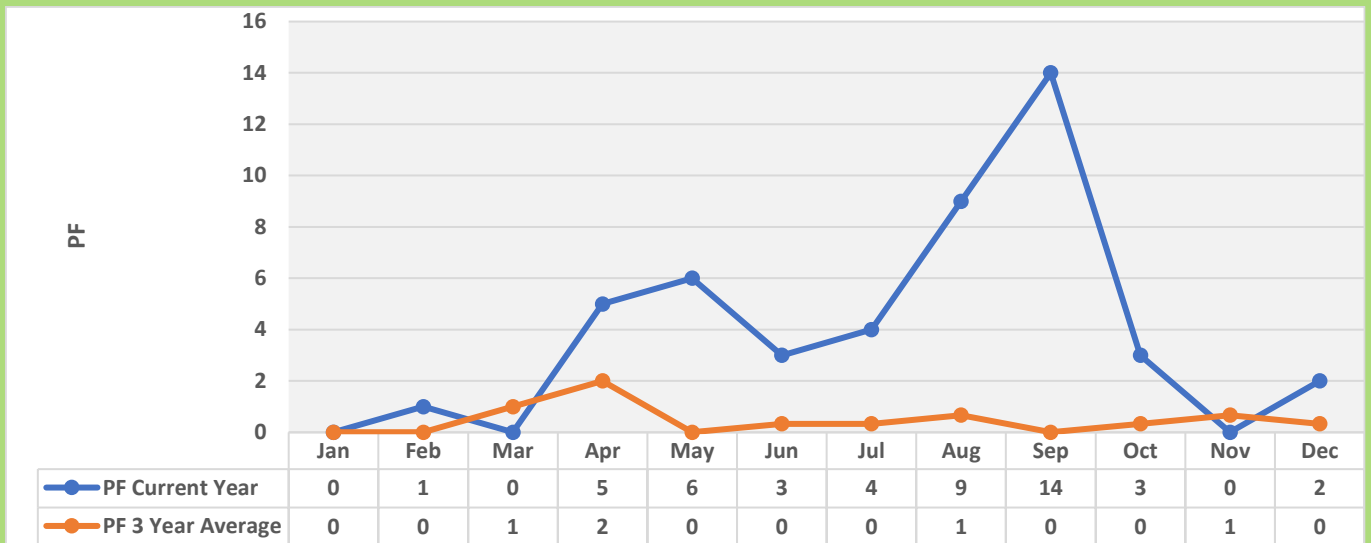

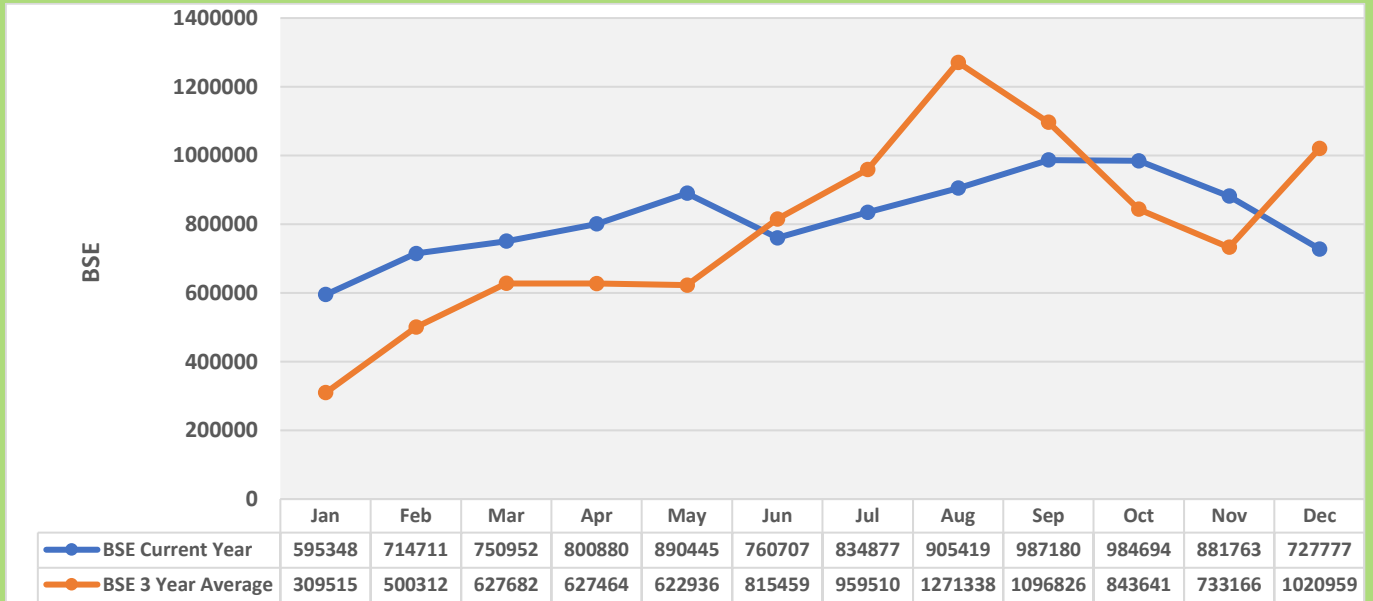
**GRAPH 4: MONTH WISE TREND OF PF IN PUNJAB**

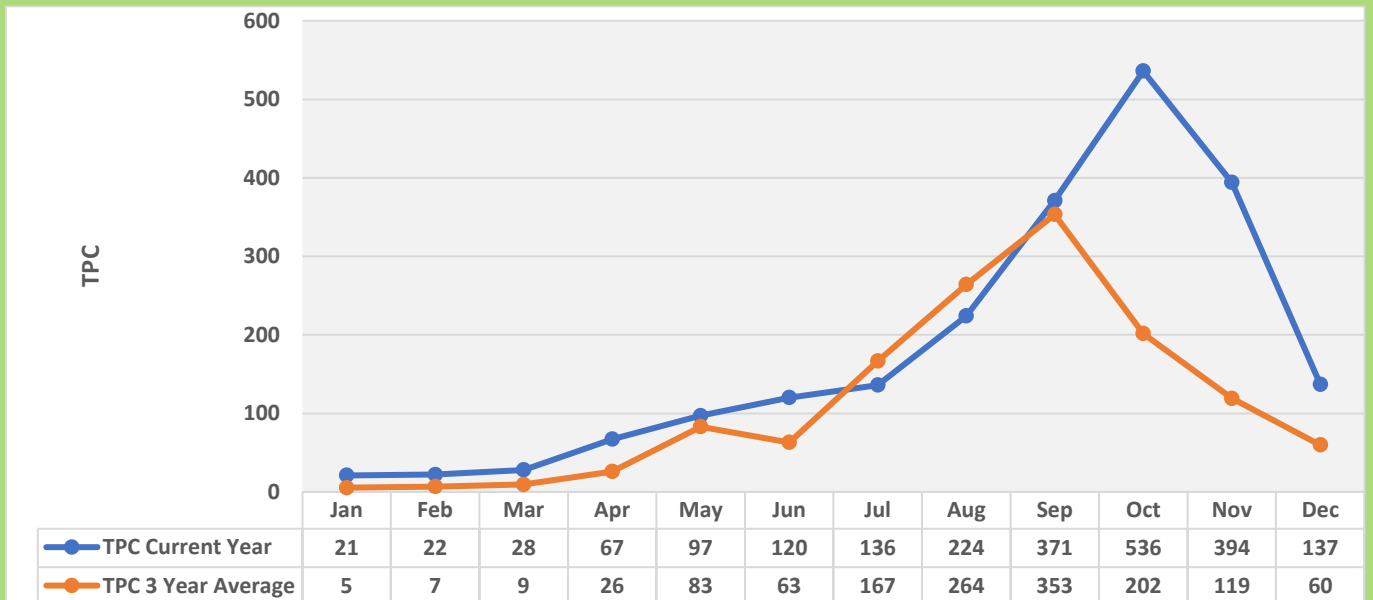

**GRAPH 1: MONTH WISE TREND OF BSE IN RAJASTHAN**



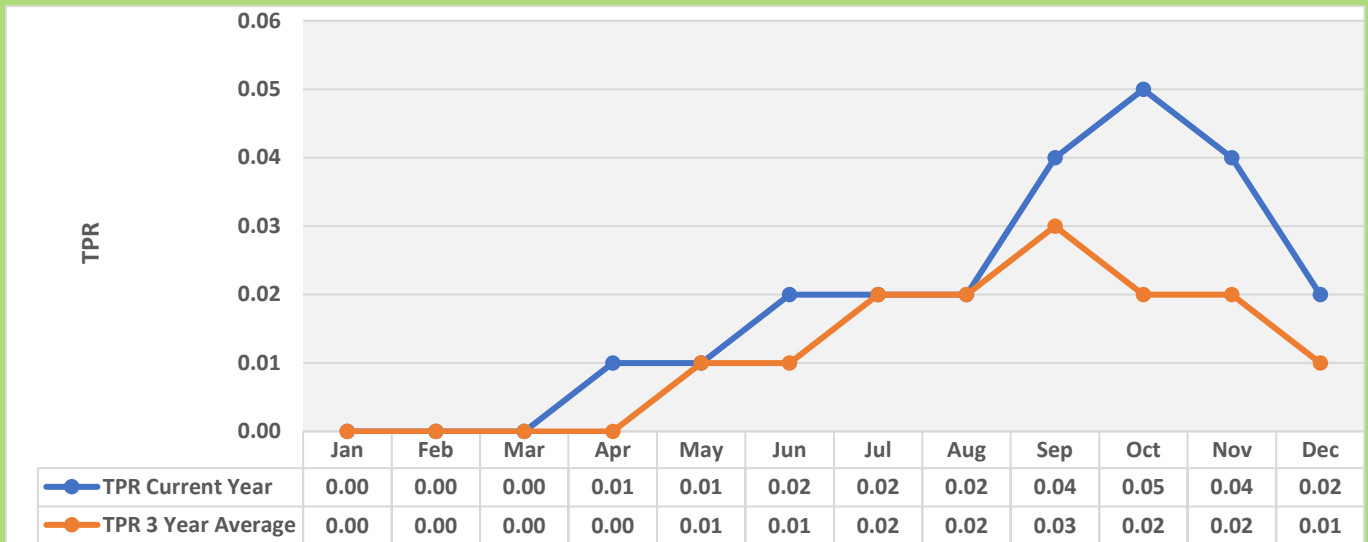

**GRAPH 2: MONTH WISE TREND OF TPC IN RAJASTHAN**



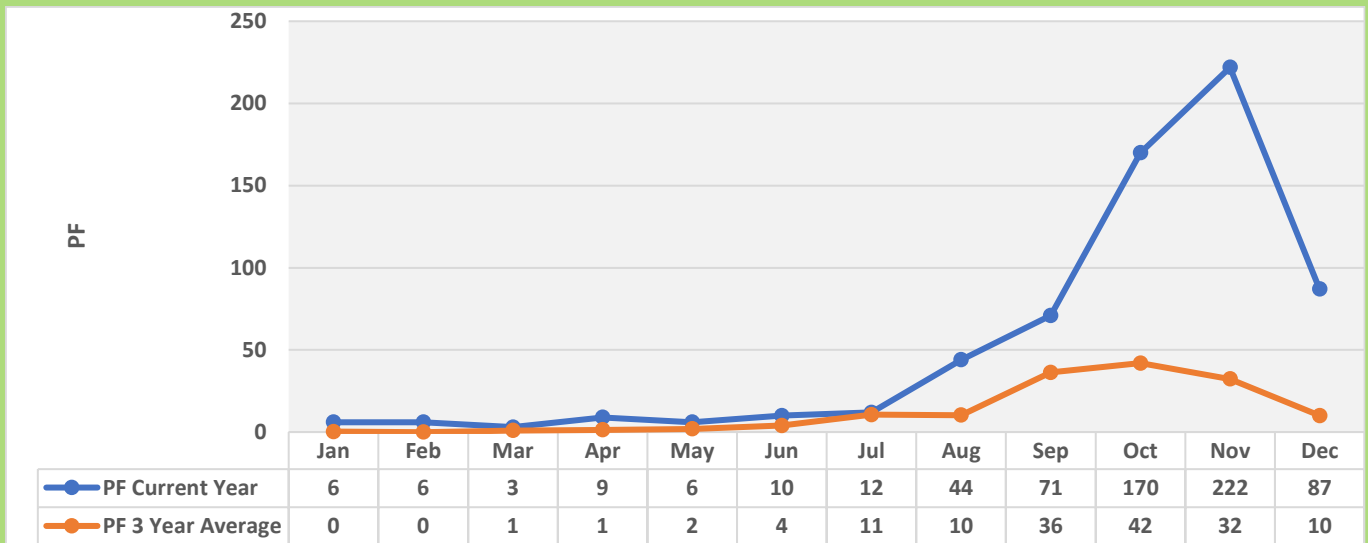

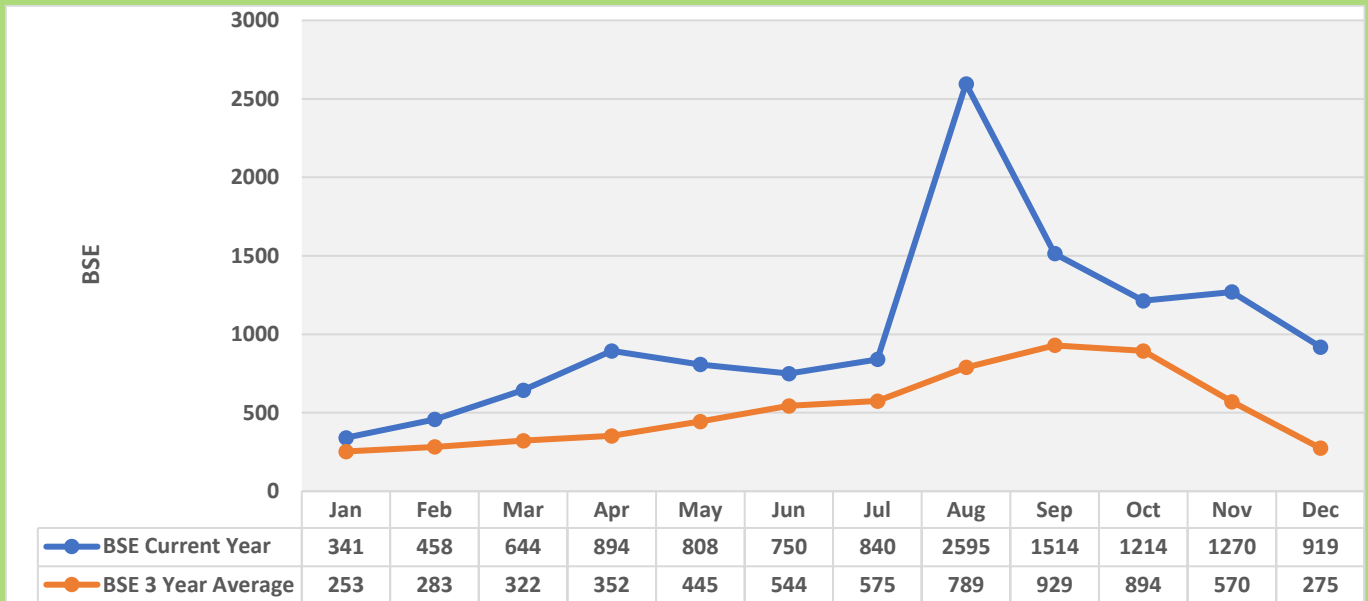
**GRAPH 4: MONTH WISE TREND OF PF IN RAJASTHAN**

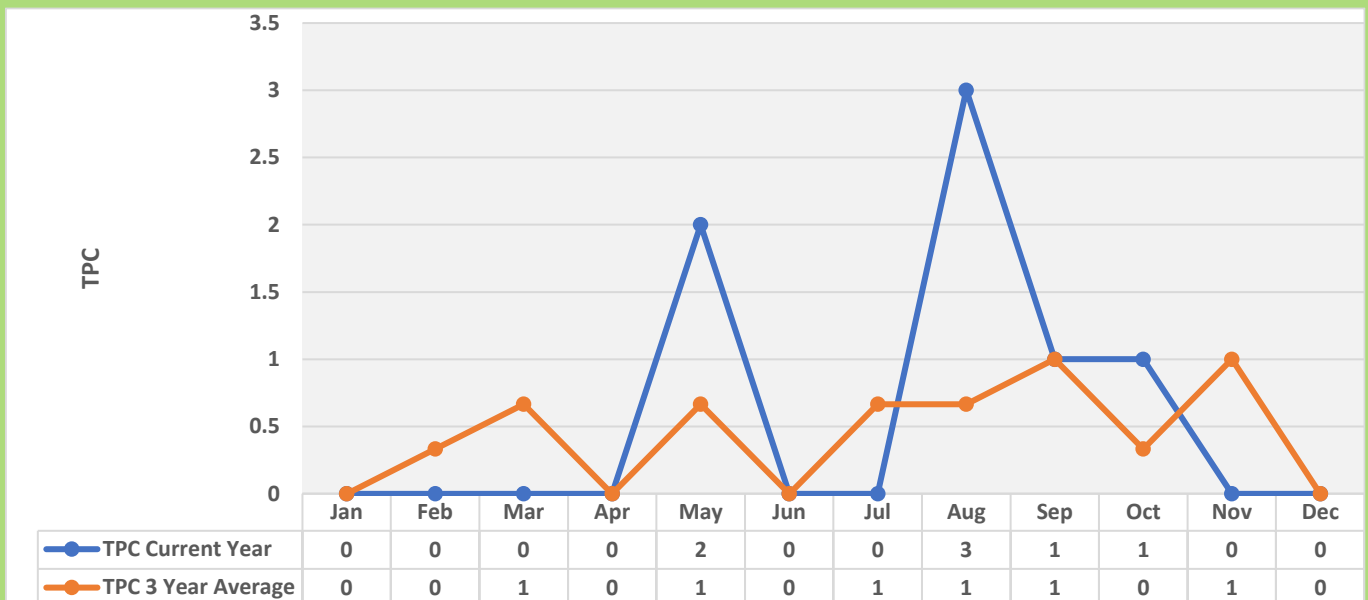

**GRAPH 1: MONTH WISE TREND OF BSE IN SIKKIM**



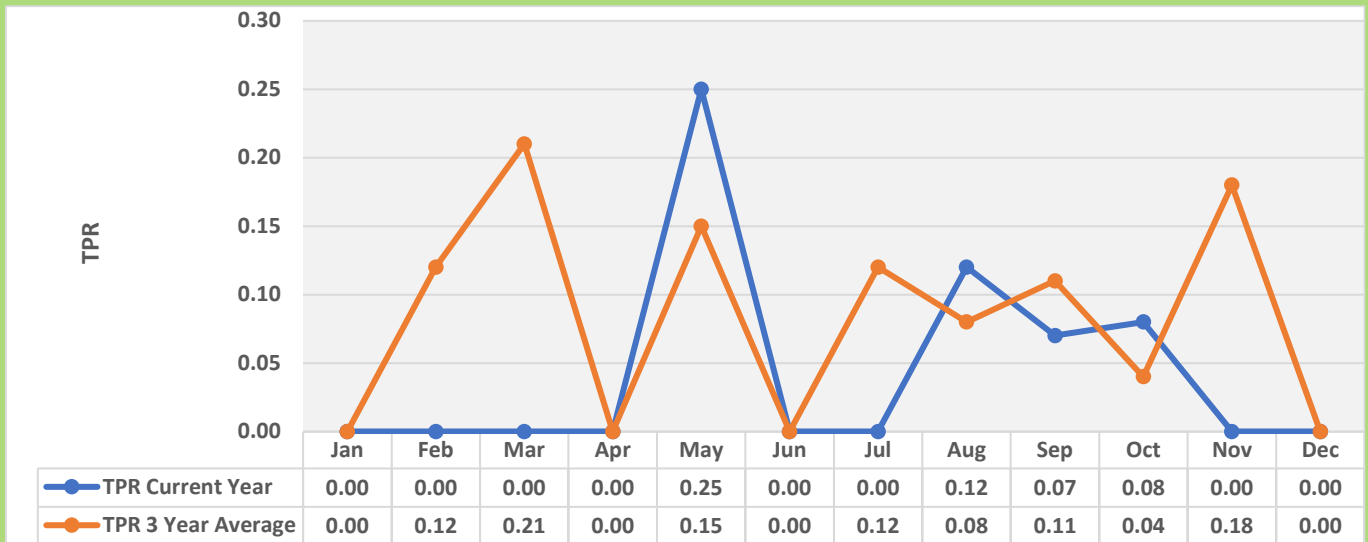

**GRAPH 2: MONTH WISE TREND OF TPC IN SIKKIM**



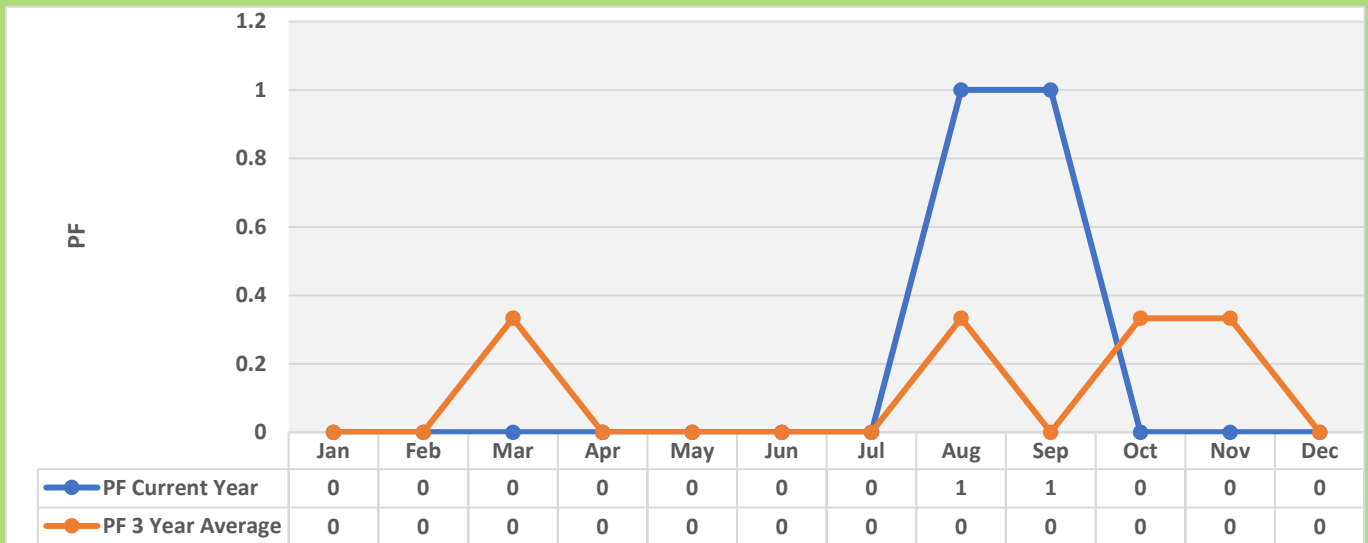

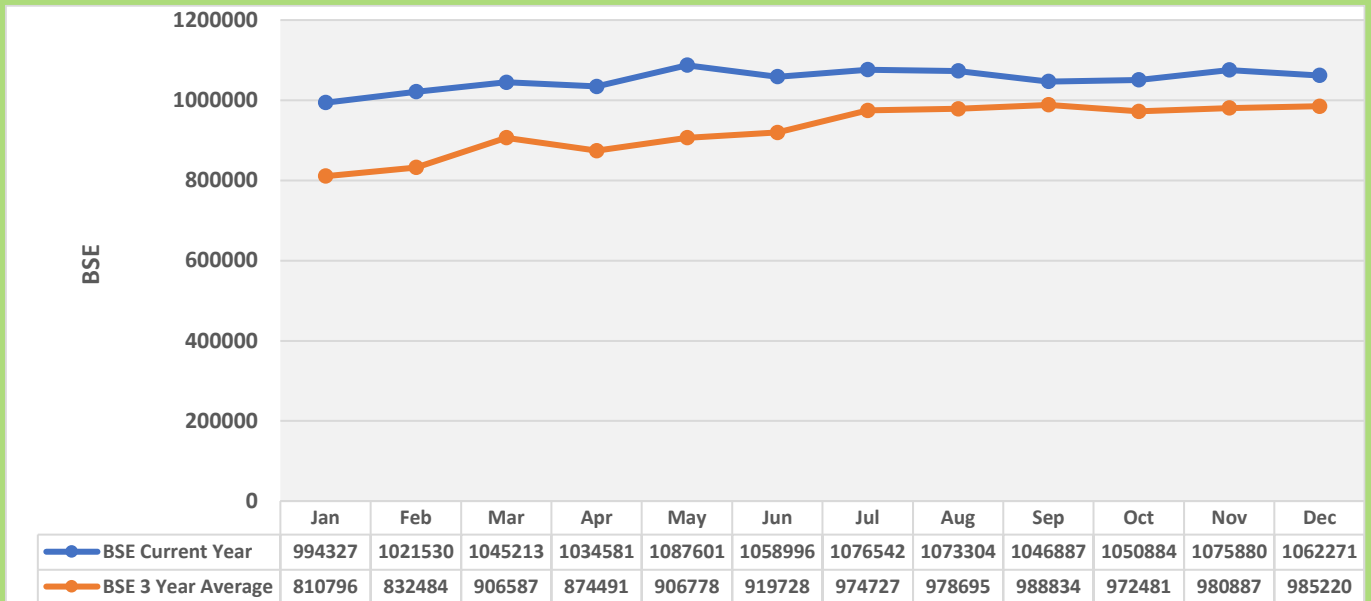
**GRAPH 4: MONTH WISE TREND OF PF IN SIKKIM**

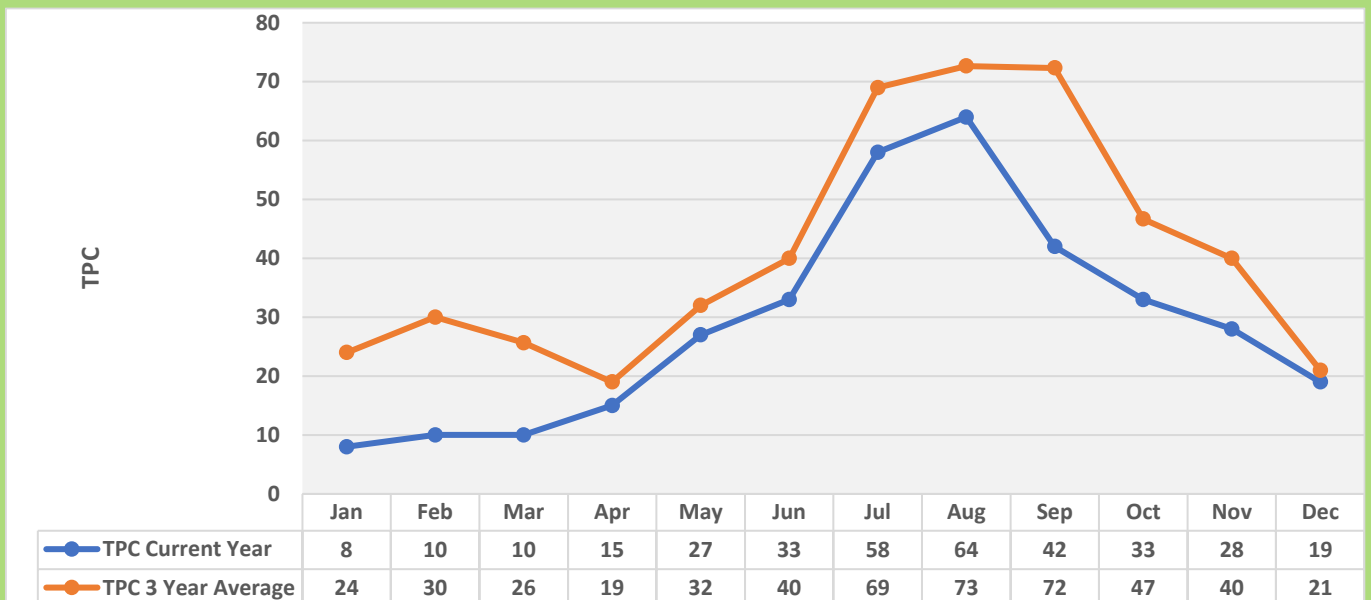

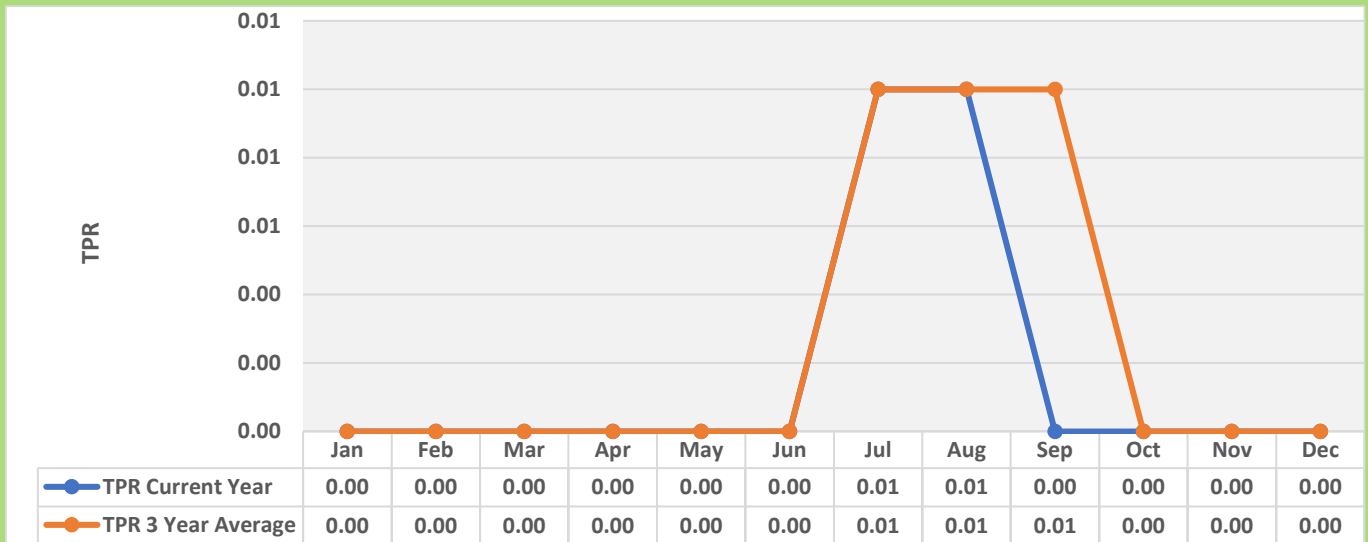
**GRAPH 2: MONTH WISE TREND OF TPC IN TAMIL NADU**

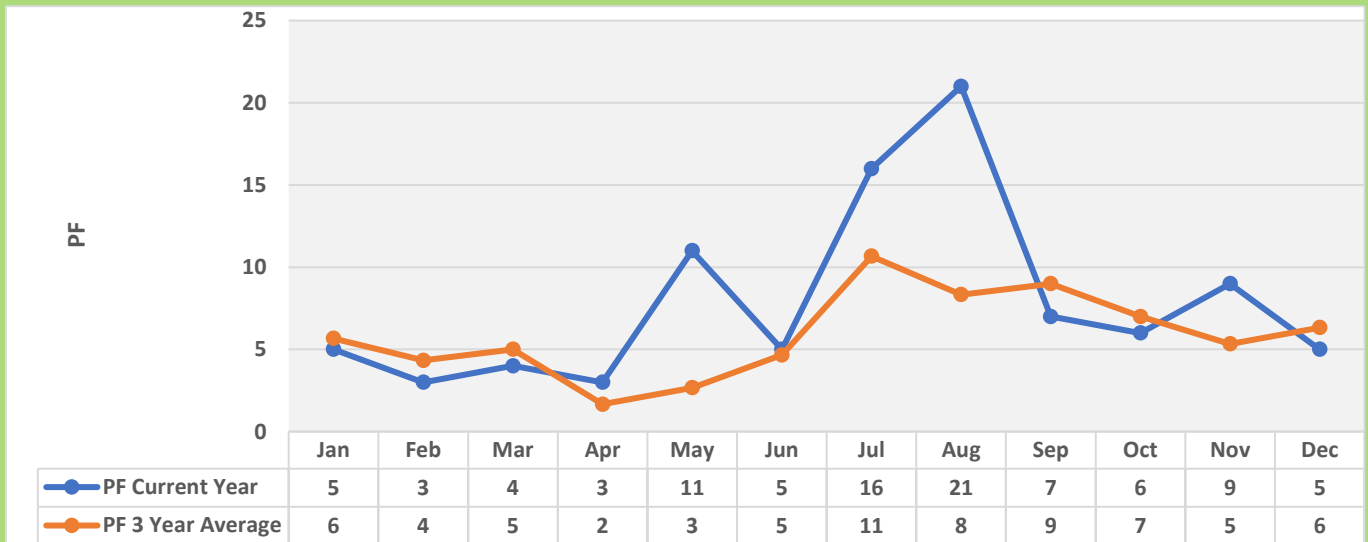


**GRAPH 3: MONTH WISE TREND OF TPR IN TAMIL NADU**

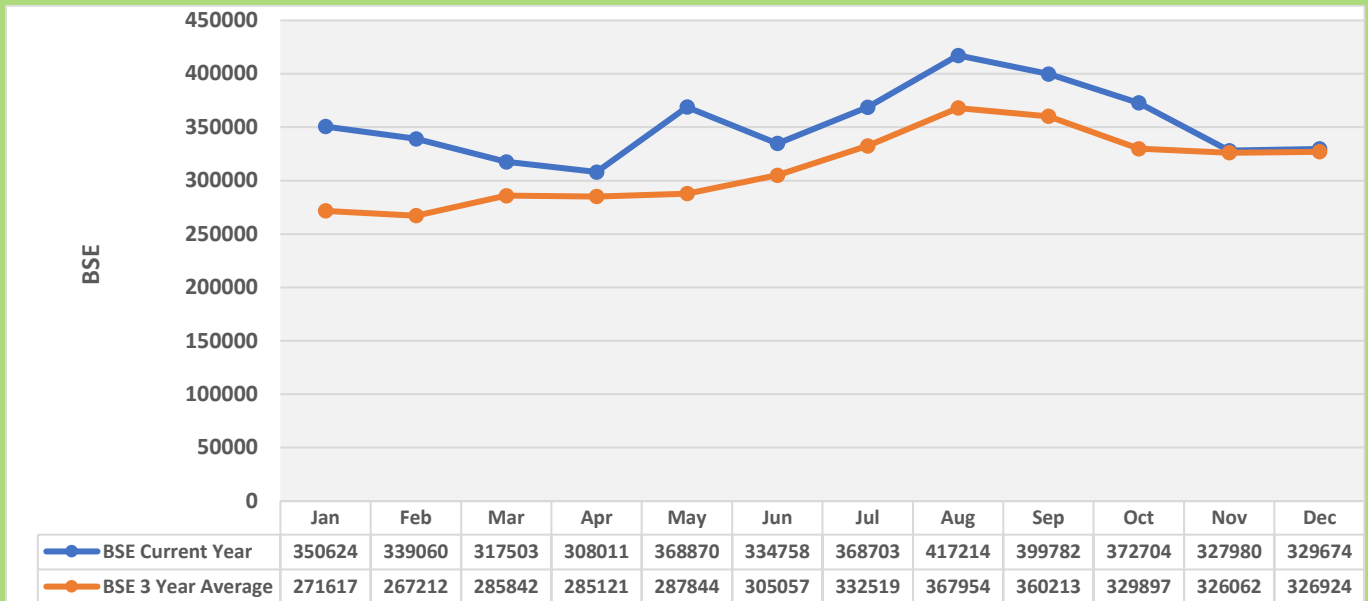
**GRAPH 4: MONTH WISE TREND OF PF IN TAMIL NADU**

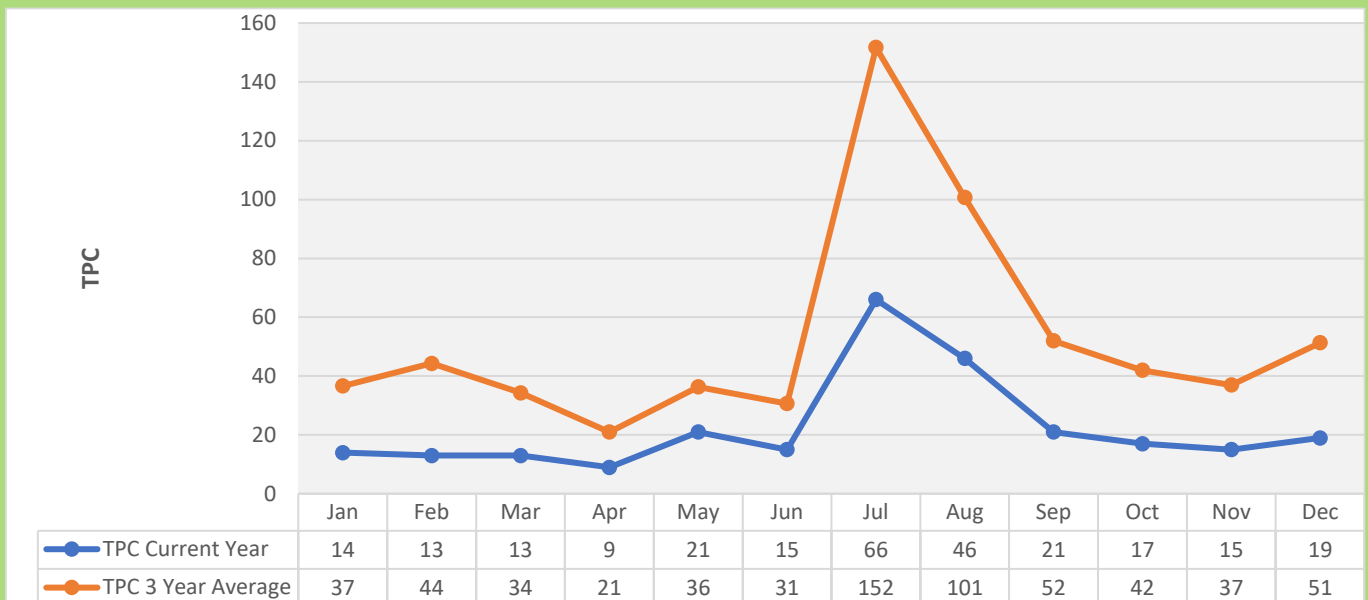

**GRAPH 1: MONTH WISE TREND OF BSE IN TELANGANA**



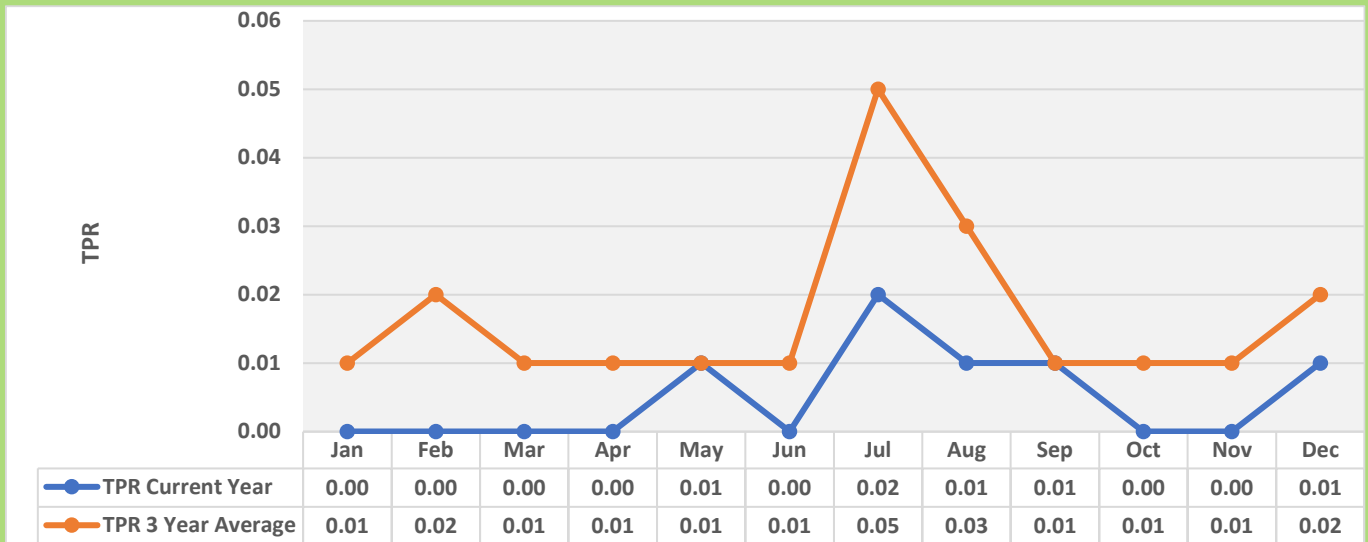

**GRAPH 2: MONTH WISE TREND OF TPC IN TELANGANA**



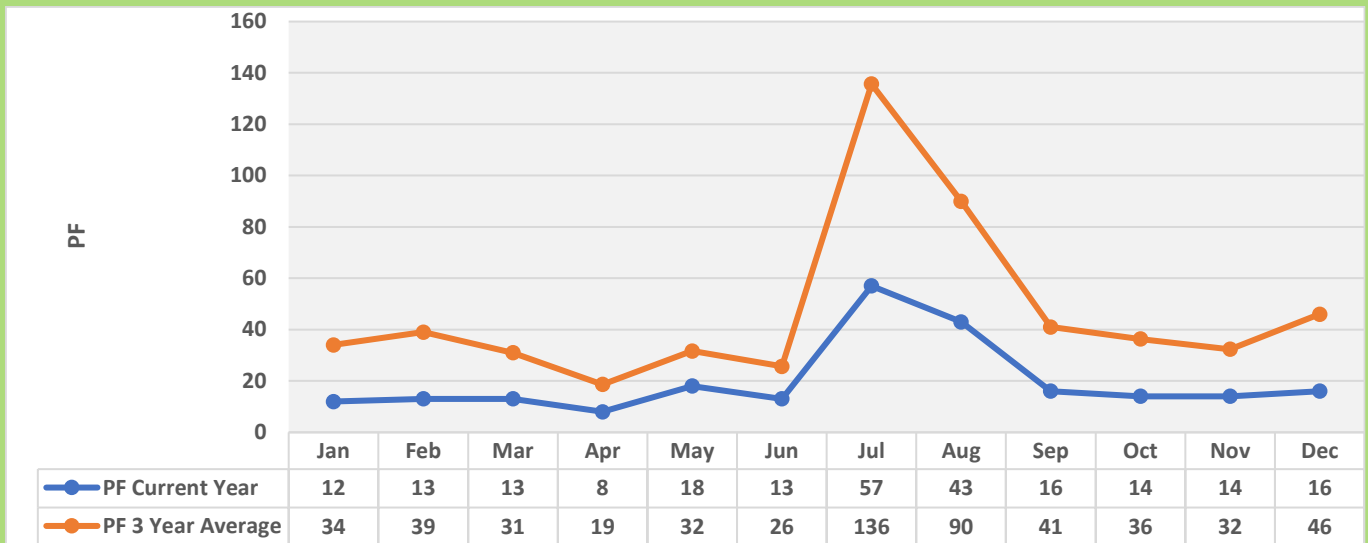

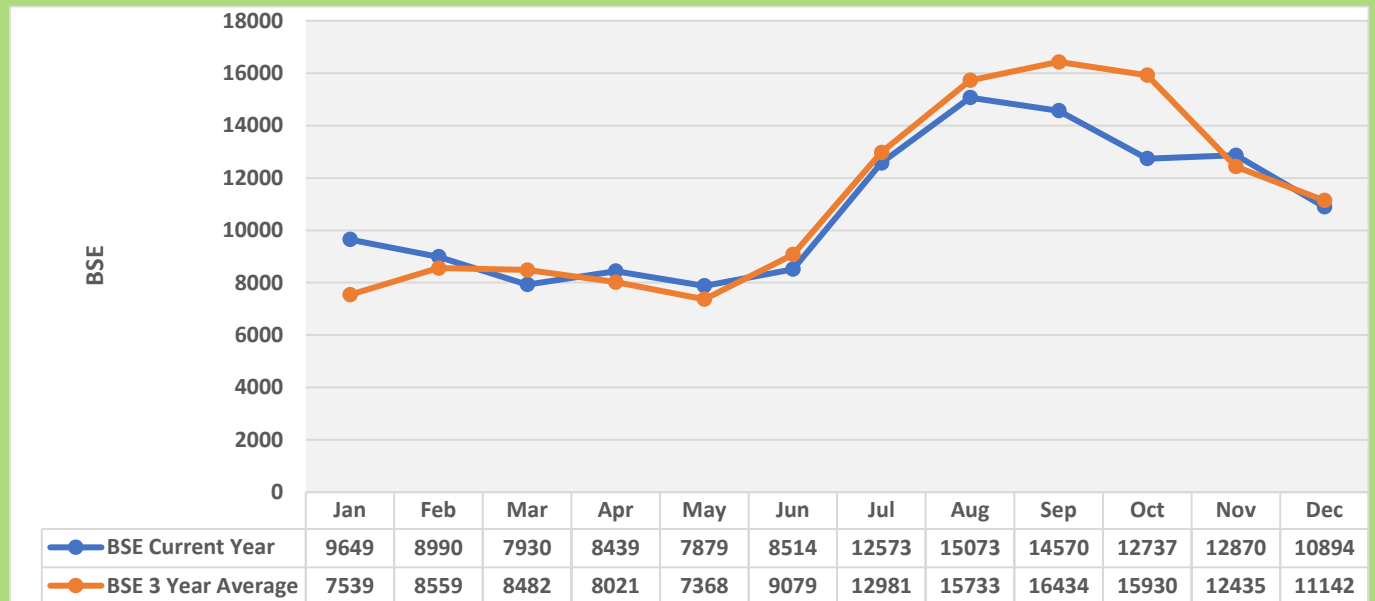
**GRAPH 4: MONTH WISE TREND OF PF IN TELANGANA**

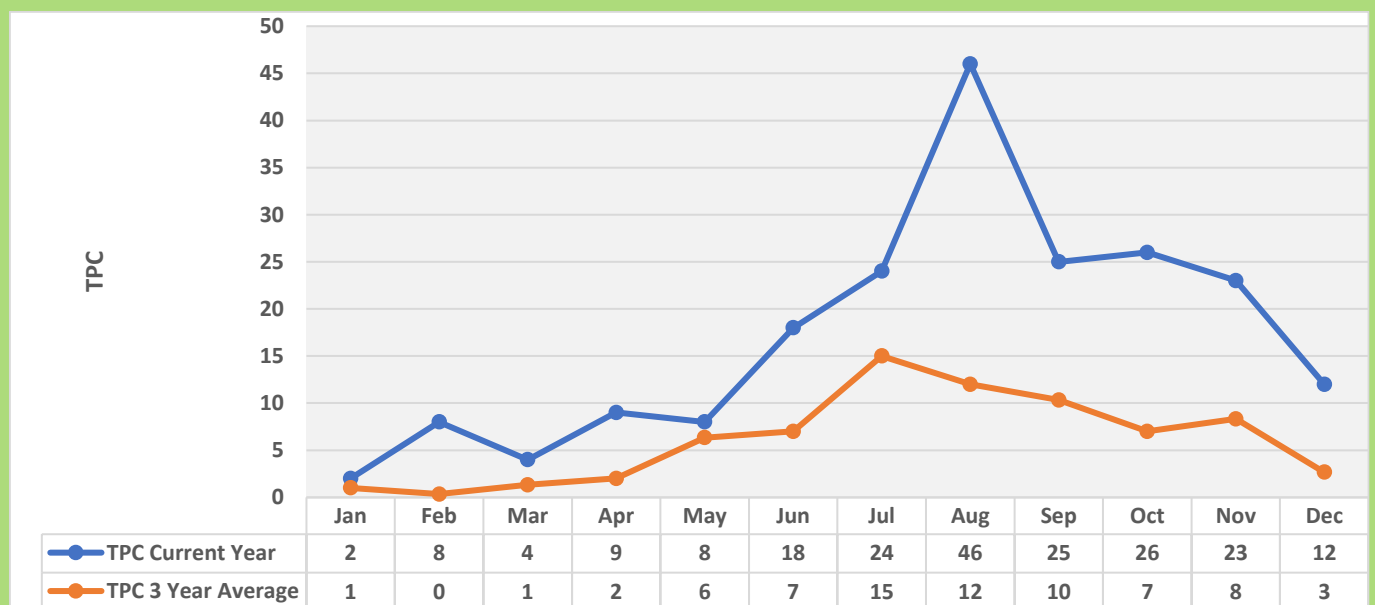

**GRAPH 1: MONTH WISE TREND OF BSE IN THE DADRA AND NAGAR HAVELI AND DAMAN AND DIU**



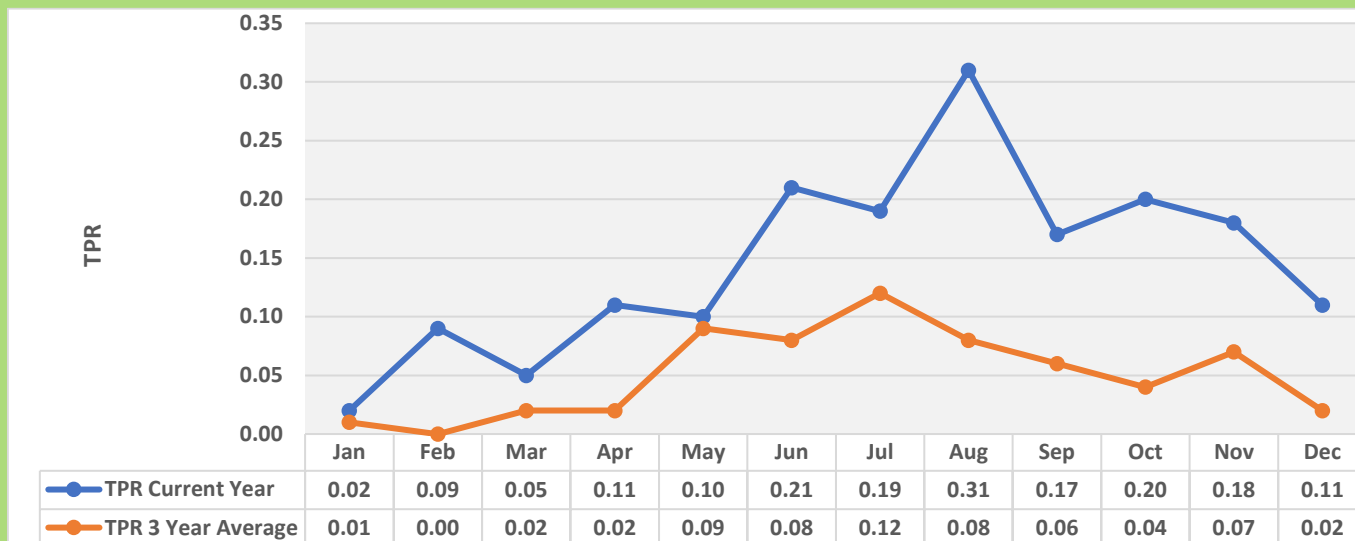

**GRAPH 2: MONTH WISE TREND OF TPC IN THE DADRA AND NAGAR HAVELI AND DAMAN AND DIU**



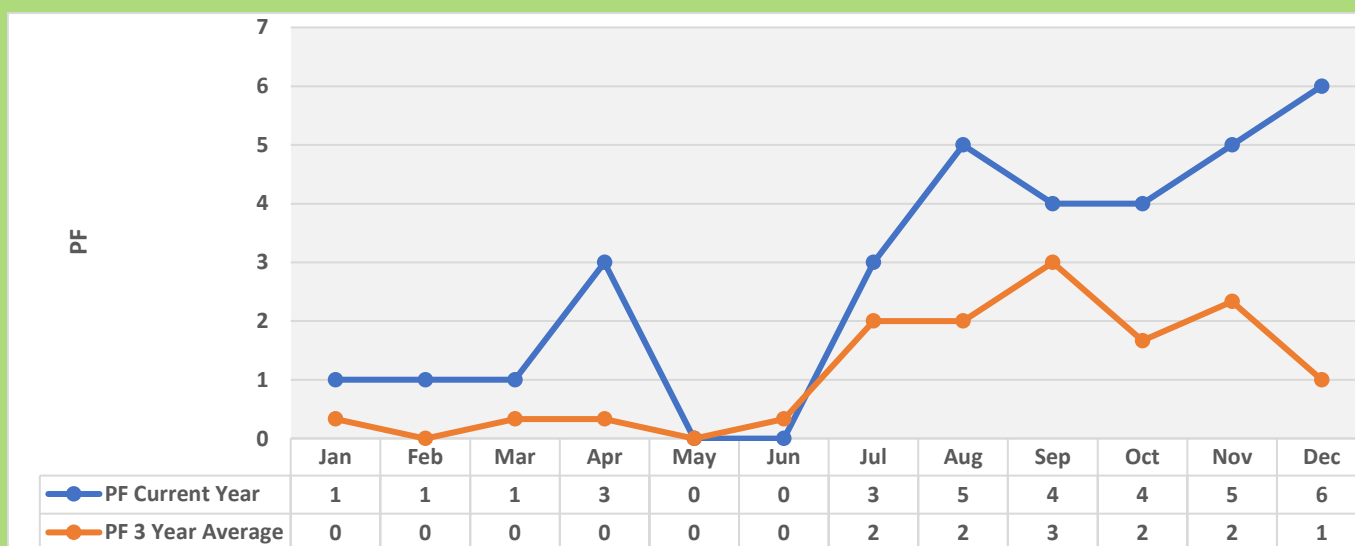

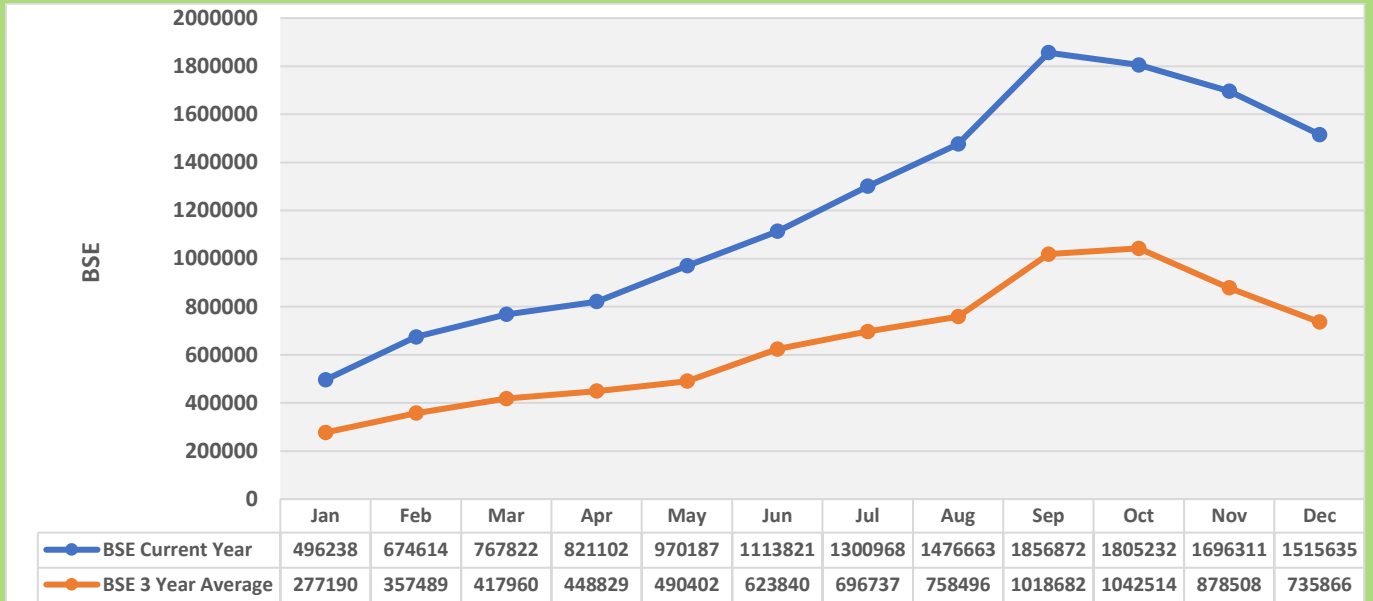
**GRAPH 4: MONTH WISE TREND OF PF IN THE DADRA AND NAGAR HAVELI AND DAMAN AND DIU**

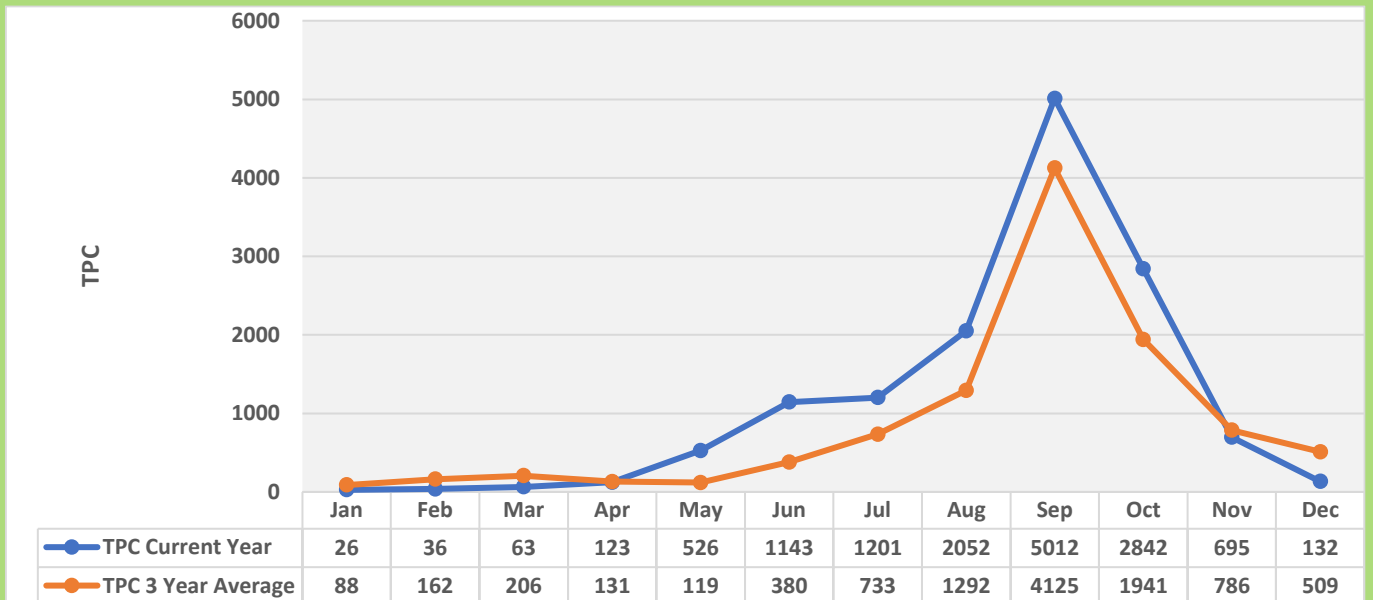

**GRAPH 1: MONTH WISE TREND OF BSE IN UTTAR PRADESH**



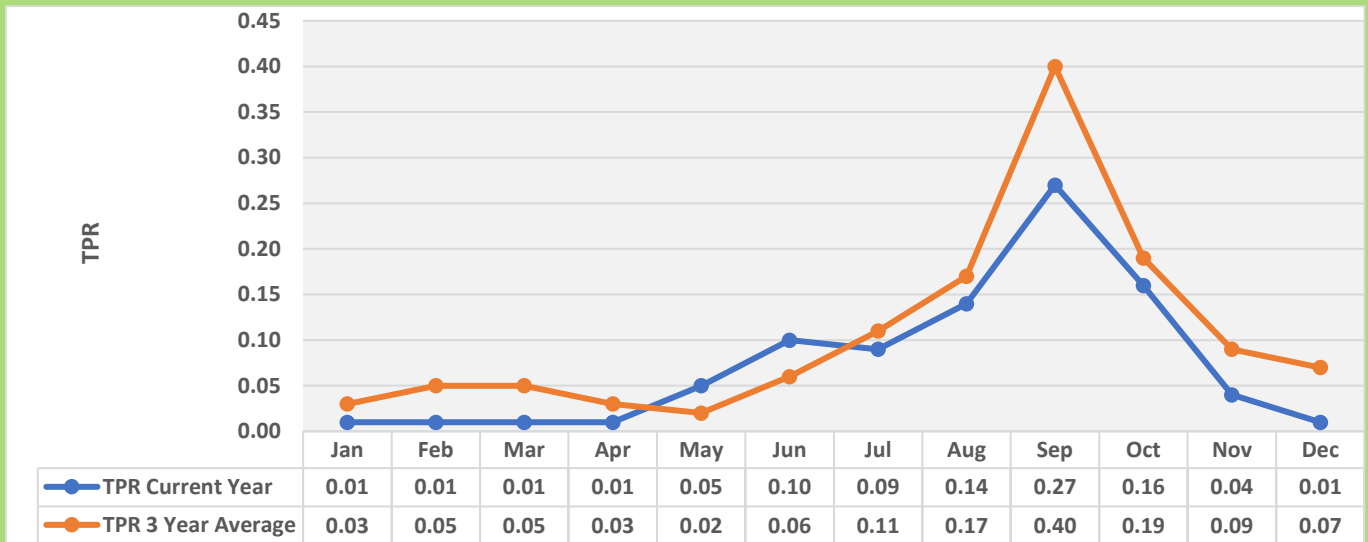

**GRAPH 2: MONTH WISE TREND OF TPC IN UTTAR PRADESH**



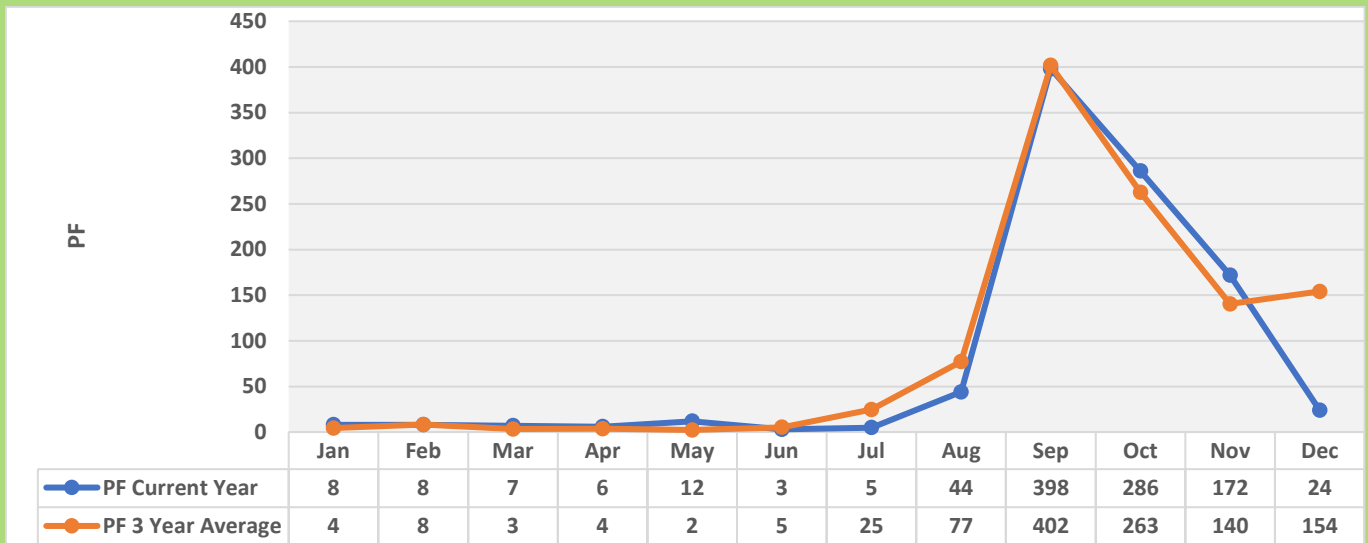

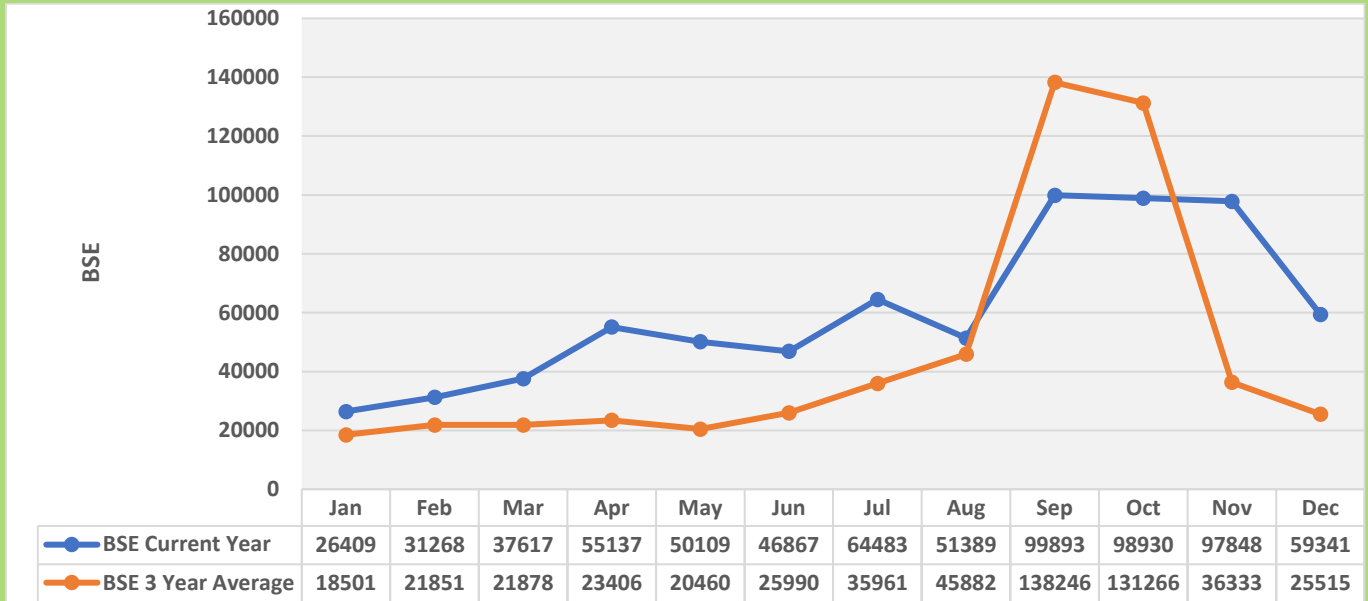
**GRAPH 4: MONTH WISE TREND OF PF IN UTTAR PRADESH**

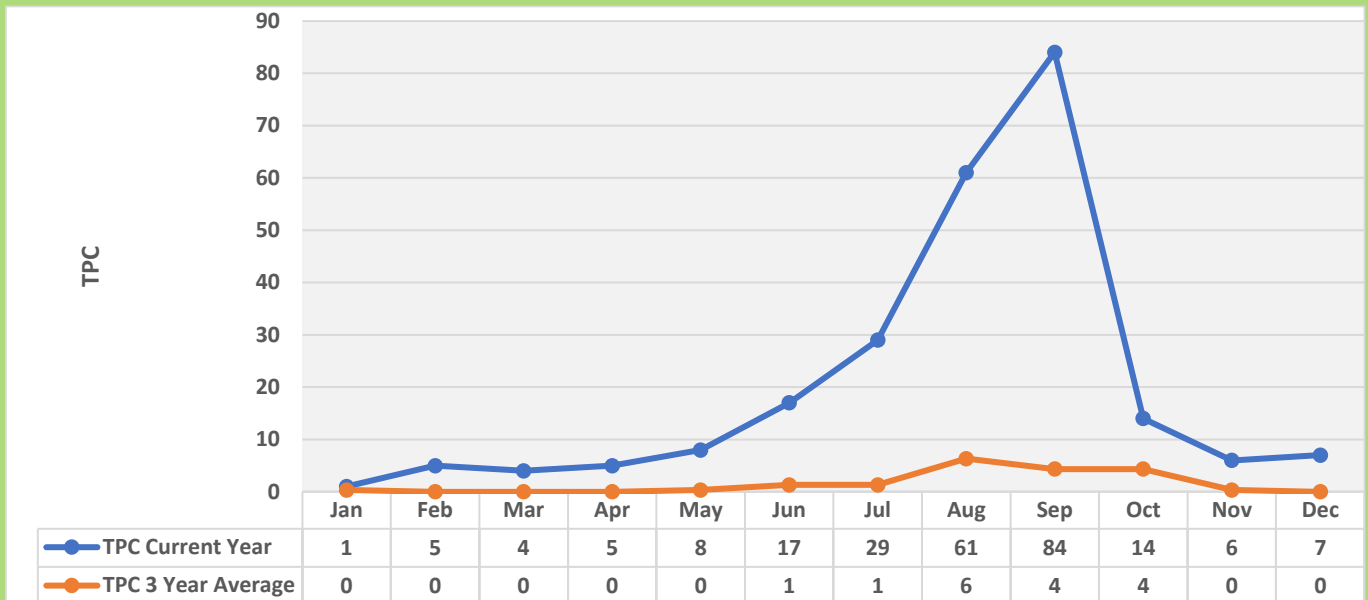

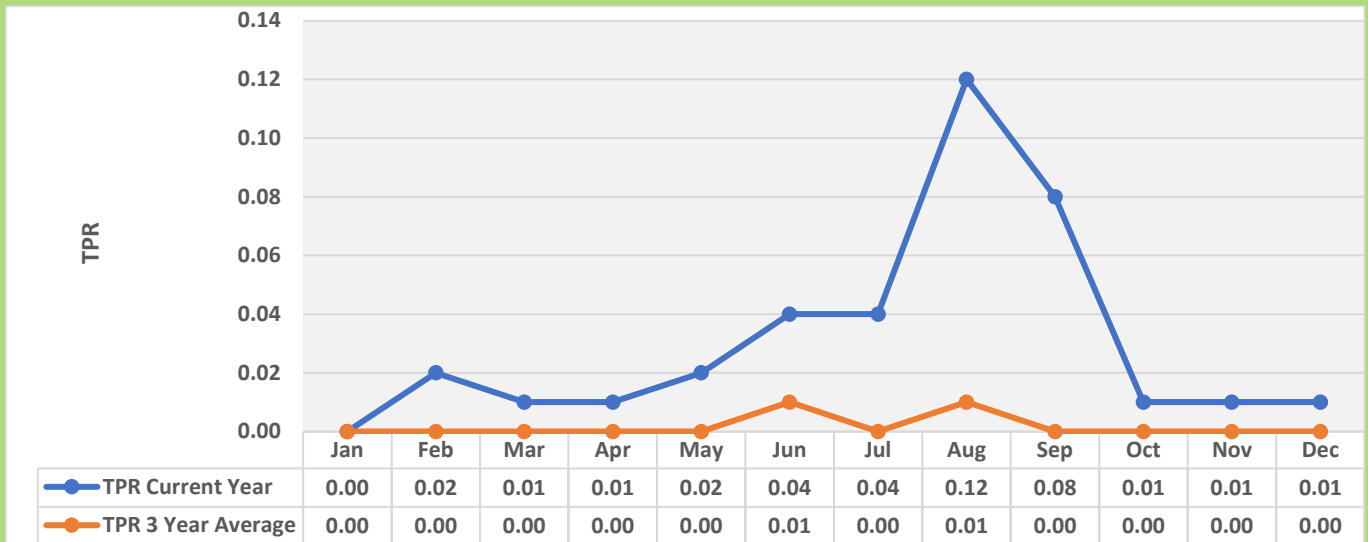
**GRAPH 2: MONTH WISE TREND OF TPC IN UTTARAKHAND**

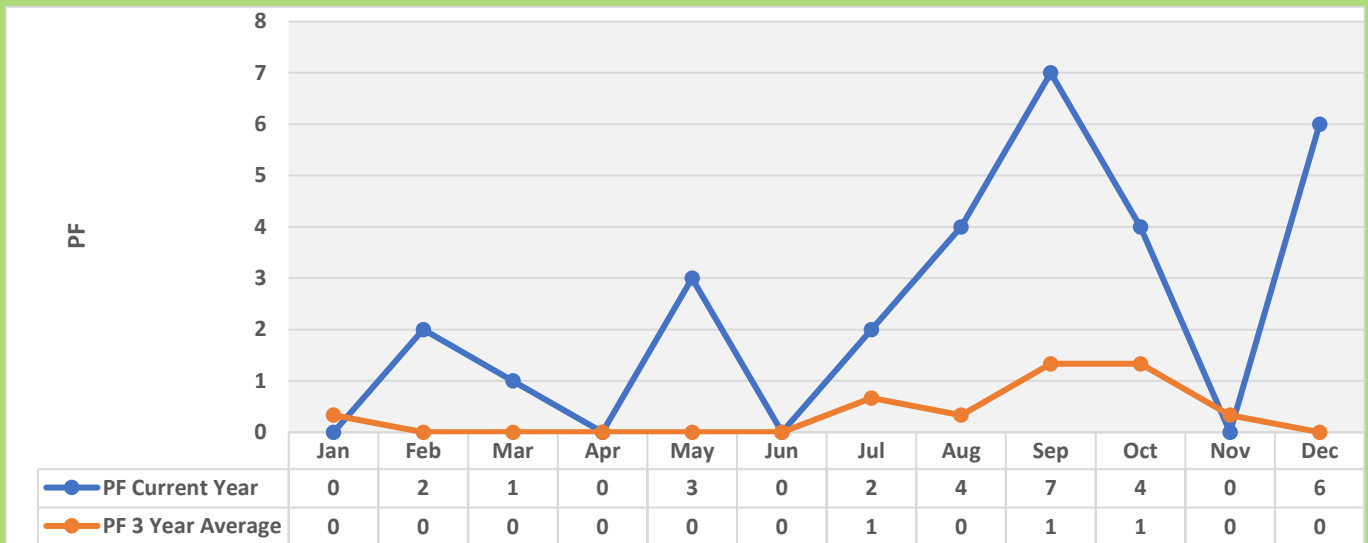


**GRAPH 3: MONTH WISE TREND OF TPR IN UTTARAKHAND**
