




GRAPH 2: MONTH WISE TREND OF TPC IN CATEGORY I STATES/UTS



Action points for all Category I States/UTs:

- States/UTs need to perform data analysis at sub district level to identify hotspots and implement focal strategies.
- States/UTs need to focus on surveillance of migratory workers.
- States /UTs need to conduct private sector mapping and ensure 100% reporting.
- States/UTs need to conduct regular meetings of district and state task force for Malaria Elimination.
- States/UTs need preparedness and response of outbreak.
- States/UTs need to ensure that all malaria cases are investigated by the competent authority.
- Vector control measures by identifying potential vector breeding sites, environmental management, biological control and focus based adult vector intervention.

GRAPH 1: MONTH WISE TREND OF BSE IN ANDAMAN AND NICOBAR ISLANDS






GRAPH 4: MONTH WISE TREND OF PF IN ANDAMAN AND NICOBAR ISLANDS

GRAPH 1: MONTH WISE TREND OF BSE IN ARUNACHAL PRADESH





GRAPH 2: MONTH WISE TREND OF TPC IN ASSAM




GRAPH 4: MONTH WISE TREND OF PF IN ASSAM



GRAPH 1: MONTH WISE TREND OF BSE IN BIHAR










GRAPH 4: MONTH WISE TREND OF PF IN DELHI











GRAPH 4: MONTH WISE TREND OF PF IN HIMACHAL PRADESH








GRAPH 4: MONTH WISE TREND OF PF IN JAMMU AND KASHMIR

GRAPH 1: MONTH WISE TREND OF BSE IN KARNATAKA






GRAPH 4: MONTH WISE TREND OF PF IN KARNATAKA

GRAPH 1: MONTH WISE TREND OF BSE IN KERALA








GRAPH 4: MONTH WISE TREND OF PF IN LADAKH



GRAPH 1: MONTH WISE TREND OF BSE IN MADHYA PRADESH






GRAPH 4: MONTH WISE TREND OF PF IN MADHYA PRADESH


GRAPH 4: MONTH WISE TREND OF PF IN MANIPUR



GRAPH 1: MONTH WISE TREND OF BSE IN NAGALAND





GRAPH 2: MONTH WISE TREND OF TPC IN NAGALAND






GRAPH 4: MONTH WISE TREND OF PF IN NAGALAND



GRAPH 1: MONTH WISE TREND OF BSE IN PUDUCHERRY





GRAPH 2: MONTH WISE TREND OF TPC IN PUDUCHERRY






GRAPH 4: MONTH WISE TREND OF PF IN PUDUCHERRY

GRAPH 1: MONTH WISE TREND OF BSE IN PUNJAB







GRAPH 1: MONTH WISE TREND OF BSE IN RAJASTHAN





GRAPH 2: MONTH WISE TREND OF TPC IN SIKKIM







GRAPH 1: MONTH WISE TREND OF BSE IN TAMIL NADU






GRAPH 4: MONTH WISE TREND OF PF IN TAMIL NADU




GRAPH 4: MONTH WISE TREND OF PF IN TELANGANA

GRAPH 1: MONTH WISE TREND OF BSE IN THE DADRA AND NAGAR HAVELI AND DAMAN AND DIU











GRAPH 4: MONTH WISE TREND OF PF IN UTTAR PRADESH




