Dear Sir / Madam,

As you are aware that Long Lasting Insecticidal Nets (LLINs) are distributed to all sub-centers with Annual Parasite Incidence (API) >1. Long Lasting insecticidal nets (LLINs) are budgeted considering the three-year replenishment cycle of LLINs in high endemic sub-centers.

In order to streamline the procurement and to improve the availability of LLINs for prevention and control of vector-borne diseases, the Ministry of Health and Family Welfare, Govt. of India, has decided to decentralize the procurement of LLINs. Technical specifications of these items are available on the NCVBDC website. States/UTs are requested to procure the technically approved quantity at State/UT/District level. States/UTs are further requested to:

1. Assess the requirement carefully, procure the LLINs as per NCVBDC guideline.
2. Ensure that stock entries are made regularly in the DVDMS portal so that near real time stock position is available for taking corrective action to manage shortage and surplus, if any.
3. Keep the complete record of distribution to District and sub-center level and share the same with NCVBDC.

I would like to inform you that fund for procurement of above-mentioned items shall be provisioned in the approved PIP under National Health Mission.
