

## Call for Expression of Interest

### Register for Nomination- India CCM-Academic/Educational Institutions, Private Sector Organizations and Professional Associations for term 2026-2028

Date of Issue: 19<sup>th</sup> February 2026

Last date of submission: 13<sup>th</sup> March 2026 (till 5:30pm)

**Background:** The India Country Coordinating Mechanism (I-CCM) was established by the Ministry of Health and Family Welfare with the goal of strengthening measures to fight HIV/AIDS, TB and malaria in the country under GFATM. It operates on a voluntary basis and represents a multi-stakeholder partnership of governmental, nongovernmental, CSOs, communities, private sector, academia and development partners. The role of the India CCM is to ensure the proper coordination of the funds within the national response, provide national oversight and ownership of grant implementation. One of the core responsibilities of the India-CCM is to ensure compliance with the Global Fund eligibility requirements and minimum standards. **Objective:** The objective of this Expression of Interest (EoI) is to ensure equitable representation from Academia representing their constituencies to be part of the India CCM, for the three year term 2026 -2029 for the following seats **ONLY**:

**Process:** India-CCM members representing academic/ research/ educational institutions, professional associations and private organization shall be nominated by their organizations. The selection process needs to be conducted in a transparent manner and documented in detail, by the organization. Members need to meet the eligibility criteria as detailed in this document.

The final selection of candidates needs to be endorsed by the institution and the organization. The entire process of identifying the nominee should be documented in detail by the institution and the organization and submitted along with application.

Once selected all representatives/organizations will be required to be an active member of India CCM for a term of 3 years and participate in at least four meetings in a year.

Each institution and organization may also nominate an alternative member to represent their institution/ organization during the absence of the primary member. The alternate member may also be selected on the basis of the eligibility criteria as the primary member.

**Eligibility Criteria:**

1. The organization or institute nominating members/alternates should not be a Principal or Sub Recipient (PR/SR) of Global Fund grants and the nominee should not be working for any PR/SR with active grant in India.
2. Individuals/organizations should have demonstrated experience of working in any one or on all the three areas of TB/HIV/Malaria in India for at least 5 years.
3. Organization be registered with Darpan portal of Niti Aayog and must submit a copy of their registration certificate, wherever applicable
4. Individuals selected be willing to sign a Conflict of Interest Declaration of India-CCM, Code of Ethical Conduct and the Prevention of Sexual Exploitation, Harassment and Abuse (PSEAH) document.

**Note:**

1. In case, the above essential eligibility criteria are not met, the application will be summarily rejected and not be examined further.
2. The final selection will be in accordance to recommendation of the Election Committee of ICCM and approval of Chairperson, India CCM
3. Whom to recommend as Member and Alternate will be decided by the Election Committee of ICCM
4. There will be no interview and the selection shall be based on the documents submitted in support of the eligibility and suitability.
5. In case the committee finds more than two candidates (one for member and one for alternate member) against any constituency, a panel shall be created out of the remaining suitable candidates for ICCM term 2026-2028. This roster/panel would be deployed if any member or alternate against that constituency were to drop off without completing the term subject to the availability and willingness of the candidate.
